Chairman Bruce Cull called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. Central Time. A roll call was taken and a quorum was determined.

Cull opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23. No conflicts of interest were disclosed and no waivers were requested.

Cull asked for a motion to approve the May 12, 2022 Commission meeting minutes.

A motion was made by Roby and seconded by Nelson to approve the May 12, 2022 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Commissioner Mike Vehle joined the meeting at 9:01 a.m.

Secretary Joel Jundt presented to the Commission the Secretary's Report. It included the following items:

- Acknowledgment of the retirement of Joe Feller, Program Manager for the Office of Materials & Surfacing, effective June 2022. The Secretary thanked Mr. Feller for 37 years of service to the Department of Transportation (the "Department"). Jundt also shared that Feller will remain employed for a few additional months as a mentor to Tanner Fitzke, the newly hired Program Manager for the Office of Materials and Surfacing.
- Discussion of changes to the federal *Buy America* requirements for construction materials and manufacturing products based changes that were posted on the federal register published by USDOT under the heading of temporary waivers for construction materials.
- Discussion of the Department's work with AGC and contractors regarding increased fuel prices. The Secretary informed the Commission about the standard fuel escalation clause in construction contracts.
- The Department is continuing to work on the compensation guidelines for members of the Commission who participate in events outside of Commission meetings.

Craig Smith, Director of Operations, presented the following Construction Change Orders (CCOs) for the Commission's information.

CCOs approved in April contain an increase of \$674,486.15. Over the past 12 months, the overall contract increase is 0.46%.

<u>Explanation of Change on CCO No. 1:</u> This decrease is the result the Department adjusting the payment of salvage materials due to a Contractor proposed alternative salvaging operation. The alternate operation involves the Contractor processing and blending the recycled asphalt mix and granular base material on site. The alternate operation will save the Contractor the costs of trucking and will also reduce the amount of dust produced by hauling.

The excess waste material resulted from the embankment material shrinkage factor being less than estimated in the plans.
