Chairman Mike Vehle called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m.

Vehle opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) chapter 3 - 23.

No conflicts of interest were disclosed, and no waivers were requested.

\*\*\*\*\*\*

Vehle asked for a motion to approve the January 30, 2020, Commission meeting minutes.

A MOTION WAS MADE by Roby and seconded by Zander to approve the January 30, 2020, Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Vehle asked for a motion to approve the February 13, 2020, Commission meeting minutes.

A MOTION WAS MADE by Rosenboom and seconded by Karim to approve the February 13, 2020, Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Secretary Darin Bergquist presented the Secretary's Report. Bergquist provided a legislative update to the Commission. The Department of Transportation (the "Department") is still working on SB21 and HB1238. Bergquist provided background on HB1200 which has now been tabled by the Legislature. HB1200 set to establish dates for the mowing of ditches on the state trunk highway system. The Department will be proposing some updates and changes to the administrative rules to address the concerns HB1200 tried to address.

Bergquist provided information about interstate resiliency. During the flooding that occurred in the summer of 2019, Governor Noem directed the Department to consider how to prevent flooding and subsequent closure of the Interstate system in the future. The Department has identified 15 sites on the interstate system that were impacted by flooding. The Department has identified 8 of those 15 sites where the Department can perform shorter term interim measures to improve flood resiliency at those sites. The other 7 sites will require longer term more expensive projects to improve flood resiliency at those sites.

Bergquist shared that the Department was awarded additional federal money to repair bridges across the state. The federal money for bridge repair is awarded to those states that rank high in terms of the number of bridges in need of repair due to being in poor condition. The Department will come back to the Commission with a recommendation on how to distribute these funds once they are received.

Craig Smith, Director of the Division of Operations, presented the following Construction Change Orders (CCO) to the Commission and responded to questions from the Commission.

Construction change orders completed in January contain an increase of approximately \$708,587.

Over the past 12 months, the overall contract increase is 2.98%.

The access allowed in the plans utilized a local road and required equipment to pass under a trussle bridge. This oversight did not allow for the size of equipment necessary for the work. The additional structural concrete was due to a change in conditions discovered during construction regarding the subsurface elevation of the bedrock.

Explanation of Change on CCO No. 15: This increase is the result of the Department adjusting the contract quantities of base course and excavation to match the quantities used during construction. The increase of base course was the result of correcting an error on a prior CCO which removed a large quantity of base course from the contract. The increase in excavation resulted from additional traffic diversions at cross pipe and box culvert installation locations. The diversions were added to increase safety to the traveling public and construction personnel.

Tammy Williams, Program Manager for the Office of Administration, presented a Lyman County loan request for Commission consideration. The request is to enter into an amendment to the County's previously approved loan agreement, which was executed on October 2, 2019, to increase the loan amount authorized under the agreement.

\*\*\*\*\*\*

Tobin Morris, representative of Lyman County, addressed questions from the Commission. Morris shared how the amendment meets the four factors required under the state's administrative rules governing these loans: (1) the availability of other funding for the proposed project; (2) the likelihood the proposed project will foster and support economic development; (3) whether a highway emergency exists; and (4) the ability of the local government to repay the loan on terms satisfactory to the Commission. Morris also explained how the funds would be processed.

Commissioner Don Roby shared his concerns with the process for administering loans and would like the Commission to discuss changes that may need to be made to the loan process for any future loans.

A MOTION WAS MADE by Cull and seconded by Fouberg to approve the additional funds requested under the terms of the loan agreement previously approved by the Commission in August of 2019 and authorize the Department to enter into an amendment to the loan agreement with Lyman County to increase the loan amount to an amount not to exceed \$3,123,166.00. All present voted aye by voice vote. The motion carried.

Doug Kinniburgh, Engineering Supervisor of the Office of Local Government, presented 2020 Bridge Improvement Grant (BIG) applications for Commission consideration.
