Description: One mandible originally labeled and cataloged as "11516" by W.H. Over, as discovered at the University of Wisconsin-Madison in June 2025 (see Burial Report 2025-20). Available information indicates that this individual was recovered in the 1920s by W.H. Over, that the remainder of the same individual was reburied at site 39ST15 in 1986, and that the mandible was likely transferred to the University of Wisconsin-Madison sometime prior to 1978 (no loan or transfer paperwork has been located).

Reason: Native American Graves Protection and Repatriation Act (NAGPRA). Public Law 101-601- November 16, 1990. Section 7, Repatriation. The ARC and the U.S. Army Corps of Engineers, Omaha District, jointly submitted the applicable Notice of Inventory Completion for its forthcoming *Federal Register* publication (tracking number N6475). The ARC will generate an Outgoing Transfer form to document the repatriation process following the 30-day comment period provided in the *Federal Register* publication; ARC and USACE representatives will coordinate responsibility for the transfer of the deaccessioned ancestral remains directly to the culturally affiliated tribal representatives.

Determined not to be associated with a modern forensic case in consultation with law enforcement; NAGPRA inventory conducted at the ARC determined consistent with ancestral Native American.
