Chairman Roby called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Roby passed the gavel to Vice-chairman Austin Simons to run the meeting since Simons was in the room and Chairman Roby was on the phone.

Simons opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

Karla Engle, Office of Legal Counsel, reported on a potential conflict of interest Commissioner Ron Rosenboom shared with her immediately prior to the meeting. Engle explained that Commissioner Rosenboom has a potential conflict of interest regarding the request to modify the Lemmon State Infrastructure Bank (SIB) loan. Engle further explained that Commissioner Rosenboom's employer, West River Foundation, is engaged in negotiations with the City of Lemmon for a possible sale of land owned by the foundation. Commissioner Rosenboom will recuse himself from the discussion and vote concerning the SIB loan request.

A MOTION WAS MADE by Nelson and seconded by Karim that the matters disclosed are fair, reasonable, and not contrary to public interest. All present voted aye by roll call vote except Rosenboom who abstained. The motion carried.

No other members of the Commission disclosed a conflict or requested a waiver.

Simons asked for a motion to approve the October 9, 2025 Commission meeting minutes.

A MOTION WAS MADE by Vehle and seconded by Vallery to approve the October 9, 2025 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

\*\*\*

Karla Engle, Office of Legal Counsel, announced a public hearing on the Commission's consideration of proposed amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:26 – Edmunds County speed zone rule and ARSD 70:01:02:52 – Moody County speed zone rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rules.

Engle proceeded to discuss the purpose and effect of the proposed amendments to ARSD 70:01:02:26 – Edmunds County speed zone rule. The Secretary of Transportation received a petition from a resident of Ipswich, Michael Hammrich, requesting the current 45 miles per hour (mph) speed limit on U.S. Highway 12 be extended westward through the intersection with 357<sup>th</sup> Avenue. After performing an engineering analysis, the South Dakota Department of Transportation (the "Department") agreed with the change and proposes the rule amendment. The rule change would extend the current 45 mph speed zone an additional distance of approximately 0.35 mile through the intersection of U.S. highway 12 and 357<sup>th</sup> Avenue. Engle discussed speed study results and the recommendation of the speed limit setting tool to reduce the speed limit to 55 mph. But the surrounding road context, which includes a residential development on the north side of US Highway 12, a golf course on the south side of the highway, and an accompanying uptick in pedestrian activity, weigh in favor of a speed limit reduction to 45 mph. The Highway Patrol and Edmunds County Sheriff concur with the extension of the 45 mph speed limit.

The Department also proposes to change distance measurements to the nearest one-tenth of a mile and replace legal descriptions with references or markers that will be easier to administer in the field and easier for the public to understand.

Engle stated the department received many written comments on the proposed speed limit reduction in Edmunds County, all in favor of the proposed rule change. Those comments were submitted by Emily Marcotte, Carol Lacher, Joe and Lacey Galbraith, Dan and Kelsey Knust, Cody Knutson, Cory Hammrich, Eric

and Angela Sieh, Christopher Gillick, Brandon Malsam, Nathan Oban, Lacey Weig, and Rachel Crissman, all of whom are residents of the housing development, Golf View Acres, that abuts the proposed new 45 mph speed zone. Their support for the speed zone change focused on safety, noting the residential character of the area, the presence of children and pedestrians, the difficulty of judging gaps in traffic at higher speeds (especially for inexperienced drivers leaving or entering the development), the heavy truck traffic on Highway 12 mixed with passenger and other vehicle types, the nearby golf course which draws motor vehicle movements, bicyclists and pedestrians, near-miss situations, and agricultural development. The written comments are reinforced by the department's own observations of the more urban residential character of the area and increased pedestrian activity.

Engle reported the purpose of the Edmunds County rule change is to enhance safety, facilitate accurate speed zone signing, and promote understanding of speed limit locations.

Engle then discussed the amendments to ARSD 70:01:02:52 — Moody County speed zone rule. The Department is proposing to change the speed limit on State Trunk Highway 34 in and around the Interstate 29 interchange in Moody County. Currently, there is a 55 mph speed limit for vehicles traveling on Highway 34 through the interchange. The Department proposes to replace the 55 mph speed limit with a 45 mph speed limit, while also shifting the reduced speed limit slightly westward to better accommodate two truck stops on the west side of the interchange. The proposal came about because of public comments received at a reconstruction project public meeting. The reconstruction project will narrow the driving lanes and install a median at the turn lanes into the truck stops. Engle discussed the results of the Department's speed study and reported that the narrower driving lanes and additional turn lanes are likely to cause drivers to naturally reduce their speeds. In addition to the speed limit change, the Department is also revising measurements to the nearest one-tenth of a mile in this rule.

Engle reported the purpose of the Moody County rule changes is to enhance safety, facilitate accurate speed zone signing, and promote understanding of speed limit locations.

Engle stated the Department received no written comments on the proposed rule changes in Moody County. Engle also stated that Legislative Research Council's changes to both proposed rules had been incorporated into the rules.

Simons asked for public testimony in favor of or opposed to the proposed rule amendments. Michael Hammrich, a resident of Ipswich, testified in person in favor of the speed limit reduction on U.S. Highway 12 west of Ipswich in Edmunds County. He discussed his experience as a first responder coming upon accident scenes and his belief that a speed reduction would enhance safety in this location. The Commission asked Mr. Hammrich several questions about the reasoning behind the proposed Highway 12 speed limit change. No other members of the public testified in favor of or opposed to the proposed rule amendments.

A MOTION WAS MADE by Karim and seconded by Vehle to approve the proposed amendments to ARSD 70:01:02:26 – Edmunds County speed zone rule. All present voted aye by roll call vote the motion carried.

Simons asked for public testimony in favor of or opposed to the proposed rule amendments for Moody County. No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Roby and seconded by Jensen to approve the proposed amendments to ARSD 70:01:02:52 - Moody County speed zone rules. All present voted age by roll call vote the motion carried.

RESOLUTION #2025 – 10.1 was adopted.

Engle requested the Commission set a hearing date of November 25, 2025 to consider amendments to ARSD 70:01:02:44 - Lincoln County speed zone rule.

A MOTION WAS MADE by Rosenboom and seconded by Karim to set the administrative hearing date of November 25, 2025, for consideration of amendments to ARSD 70:01:02:44 - Lincoln County speed zone rule. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2025 – 10.2 was adopted.

Simons opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Simons gave kudos to Secretary Joel Jundt for his 40 years of service to the Department.

Secretary Jundt presented the following items to the Commission in his Secretary's Report:

- Federal: Although the federal government shutdown is now entering its fourth week, thus far the Department has been minimally impacted. Primary reason is that FHWA employees are considered "essential", meaning they are not furloughed and serve by performing critical functions such as executing state reimbursements requests. For other federal agencies, such as those considered resources agencies, federal government employees are currently furloughed. So, depending upon how long the shutdown lasts, we could see slippage of our projects from a bid letting standpoint as the federal government is not able to perform reviews and other necessary functions.
- FHWA: Federal Highway Administration (FHWA) has sent out correspondence regarding State DOT's funding obligation, in essence informing us that although there is no limitation currently in place, once Congress passes a Continuing Resolution (CR), obligation limitation will be enacted based on the duration of the CR set in legislation. For example, if a CR was approved for the time period of September 30, 2025 through November 30, 2025, we would receive funding obligation for 0.167 of the yearly total limitation, based on 2025 funding amounts.
- State: Proposed agency bills have been submitted to the Governor for his concurrence. We will know whether we have approval to file these bills with Legislative Research Council (LRC) sometime in November.

Jundt then presented for Commission approval the proposed 2026 Commission meeting dates.

A MOTION WAS MADE by Nelson and seconded by Karim to approve the 2026 Commission meeting dates as proposed. All present voted aye by roll call vote. The motion carried.

\*\*\*

Commissioner Ron Rosenboom recused himself from the discussion of the City of Lemmon SIB loan request and sat in the gallery at 9:35 a.m. CT.

Jundt presented for Commission consideration a request from the City of Lemmon to increase its current SIB loan from \$1.5 million to \$3 million payable over 10 years, rather than the standard 7 year period set out in the Commission's guidance.

Chad Abel, Finance Officer for the City of Lemmon, and Craig Mizera, HDR, discussed the request and the reasoning behind it. They explained the single bid received for the project as originally planned and how that bid exceeded the engineer's estimate by thirty-three percent. They discussed their investigation into how to invite additional competition and lower bids, and their decision to pursue a larger project as a means of enhancing competition and improving bids.

The Commission discussed the request, including the rationale behind its loan guidance and how the City might prove its ability to service a larger debt. The Commission posed questions to the City representatives and Department staff regarding loan history, SIB fund availability, and security for loans.

A MOTION WAS MADE by Nelson and seconded by Vehle to amend the City's current loan agreement to provide a \$3 million loan, amortized over 7 years, with interest at the rate of 2.5%.

After further discussion, A MOTION WAS MADE by Vallery to table the current motion and request additional financial information from the City of Lemmon.

Vallery and other Commission members discussed the type of financial information that might satisfy the Commission, including tax revenue and expense information, potential contributions from Perkins County, assets, audited financial statements, and overall ability to service the debt.

Simons called for a second to the pending motion to table and Frick seconded the motion. Commissioners Frick, Jensen, Karim, Roby, Vallery, Vehle, and Simons voted aye and Commissioner Nelson voted nay by roll call vote. Commissioner Rosenboom abstained. The motion carried.

Commissioner Rosenboom returned to the meeting at 10:44 a.m.

Jundt then presented for Commission consideration a request transfer jurisdiction of a portion of US385 to Wind Cave National Park. The Department and Wind Cave have been jointly working on this transfer for over 10 years. The primary purpose for transferring the highway section is for safety, both for the traveling public and the buffalo within the park boundary.

Below are the reasons for the request:

- There is currently a cattle guide near the current park boundary to keep wildlife in the park.
- The cattle guide is in an area that has limited sight distance due to two horizontal curves on either side.
- The buffalo frequently congregate at the cattle guard.
- Because of the limited sight distance along the highway (just coming off a horizontal curve at both ends), there is a real potential that a crash could take place, endangering both the buffalo and the occupants of the vehicle.
- The proposed solution is to move the park boundary 0.41 mile southeast, closer to the actual park boundary and at a much better location (tangent section).

With the transfer, the Department will transfer a 0.41 mile section of US385 to the National Park Service by quit claim deed. Legislation will need to be introduced to remove the segment from the State Trunk Highway System. The Department will relocate the cattle guard from approximately MRM 42.72 to approximately MRM 42.32 (approximately 0.4 mile south of its current location), repair the road where the cattle guard was removed, and install dark sky friendly lighting along US385 near the relocated cattle guard in accordance with federal highway standards. Finally, the Department will widen US385 on the south side of the new cattle guard to allow snowplow drivers a safe location to turn around, thus limiting road salt entering the park.

The National Park Service will take over ownership, repair and maintenance responsibilities of the 0.41 miles of roadway and will support legislation to remove the transfer segment from the State Trunk Highway System. Lastly, the National Park Service will provide all necessary electricity, maintenance and replacements, in kind, of all parts, poles, and apparatus of the lighting system installed by the Department, to ensure the continuing operation of said system.

A MOTION WAS MADE by Rosenboom and seconded by Vehle to authorize the Secretary or his designee to execute all documents necessary to transfer to the United States of America the South Dakota Department of Transportation's ownership interests in, jurisdiction over, and operational and maintenance responsibilities for a segment of U.S. Highway 385 from its intersection with the existing Wind Cave National Park boundary to a point approximately 0.41 miles from this intersection. All present voted aye by roll call vote. The motion carried.

The Commission took a short recess from 10:51 a.m. to 10:59 a.m.

Craig Smith, Division Director of Operation, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in September contain an increase of \$1,142,054.48. Over the past 12 months, the total change to the original contract amounts is an increase of 1.70%.
