Chair Zander called the meeting of the Transportation Commission (the "Commission") to order at 9:01 a.m. Roll call was taken, and a quorum was determined.

Zander opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

No conflicts of interest were disclosed, and no waivers were requested

Zander asked for a motion to approve the minutes of the January 31, 2019, Commission meeting.

A MOTION WAS MADE by Roby and seconded by Fouberg to approve the January 31, 2019, meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle, Office of Legal Counsel, requested the Commission set an administrative hearing date for March 28, 2019, to consider amendments to ARSD Article 70:12 County Highway and Bridge Improvement Plan and ARSD Chapter 70:13:01 Local Bridge Improvement Grant Requirements.

A MOTION WAS MADE by White and seconded by Fouberg to set the hearing date as March 28, 2019. All present voted aye by roll call vote. The motion carried.

#### RESOLUTIONS # 2019-2.1 was adopted.

Secretary Bergquist outlined the history of the election of Chair and Vice Chair and the timing of when the newly elected Chair and Vice Chair would take over meetings. The question posed to the Commission is when the election of Chair and Vice Chair should take place and when should the newly elected Chair and Vice Chair assume their duties. The Commission decided to leave the current process as is, with election taking place in February of each year for a 12-month term.

Secretary Bergquist provided an update on the Legislative Session. All bills the Department of Transportation (the "Department") had been working on have been passed or defeated so the Department's involvement in the Legislative session is complete unless new issues arise.

Greg Fuller, Director of Operations, introduced Tony Ondricek as the new State Construction and Maintenance Engineer for the Department. Fuller presented the following information regarding Construction Change Orders to the Commission:

Construction change orders approved in January contain a decrease of approximately \$590,771.

Over the past 12 months, the overall contract increase is 2.19%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

Original Contract Amount: \$ 540,615.70 Change on CCO No. 1: \$ (102,674.85) Net Change to Date: \$ (102,674.85)

<u>Explanation of Change on CCO No. 1:</u> This decrease is the result of the Department adjusting the contract quantities of pavement marking paint to match the quantities used to complete the work.

# II. Project: NH 0014(00)353, Brookings & Kingsbury County, PCN 03VM

Location: US 14 in Volga, DeSmet, Arlington, and Lake Preston

Contractor: BX Civil & Construction, Inc. Type of Work: ADA Curb Ramp Upgrades

Original Contract Amount: \$ 453,819.30 Change on CCO No. 2: \$ 55,343.70 Net Change to Date: \$ 47,181.99

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of the Department paying for extra work performed by the Contractor to relocate the intersection with Brewster Street in DeSmet about 11.5 feet south of its current location.

# III. Project: IM 0293(109)85, Minnehaha County, PCN 05EG

Location: I-29 from Exit 86 (Crooks) to Exit 109 (SD34)

Contractor: Central Specialties Inc.

Type of Work: Asphalt Concrete Surfacing and Edge Drains

Original Contract Amount: \$ 22,565,024.88 Change on CCO No. 2: \$ 62,443.16 Net Change to Date: \$ 119,093.60

Explanation of Change on CCO No. 2: This increase is the result of the Department paying the Contractor for extra work performed to widen the existing shoulder to accommodate temporary guardrail during construction near MRM 85.48. This CCO also included an increase in quantity for high tension cable guardrail at numerous locations throughout the project. The approved shop drawings contained slight increases from what was shown on the estimate and the plans.

#### IV. Project: NH 0018(179)402, Hutchinson County, PCN 036L

Location: US 18 from US 81 to SD 19 Contractor: Bowes Construction, Inc.

Type of Work: Grading, Structures, Interim Surfacing, and Permanent Signing

Original Contract Amount: \$ 17,483,650.16 Change on CCO No. 4: \$ (379,409.03) Net Change to Date: \$ (367,638.74)

Explanation of Change on CCO No. 4: This decrease is the result of the Department eliminating cold central plant recycled asphalt from the project. The Department intended to place a trial section of cold central plant recycled asphalt on the project but, due to weather conditions, an insufficient length of grade was completed prior to the seasonal limitations of cold central plant recycled asphalt and the work was eliminated from the contract.

Location: US 281 from SD 258 to 243 Street

Contractor: Asphalt Surface Technologies Corporation

Type of Work: Microsurfacing

Original Contract Amount: \$ 870,297.15 Change on CCO No. 1: \$ 65,235.74 Net Change to Date: \$ 65,235.74

Explanation of Change on CCO No. 1: This increase is the result of the Department paying for extra work performed by the Contractor to apply a fog seal on the shoulders of US 281. The Department determined the need for the fog seal to keep the shoulders from deteriorating beyond repair.

There are no CCOs amounting to a change of \$50,000 to report this period.

<u>Explanation of Change on CCO No. 3:</u> This increase is the result of the Department adjusting the contract quantities of base course and asphalt concrete composite. Additional base course material was used to stabilize the subgrade under a cattle pass. Additional asphalt concrete composite was used to pave the turn lane.
