(MRC RRA) (joined the meeting at 11:20 a.m.)

Chairman Harlan Quenzer called the meeting of the South Dakota State Railroad Board (the "Board") to order at 11:04 a.m.

Chairman Quenzer opened the floor to Board members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

The Board acknowledged receipt of Burket's written annual disclosure of potential conflict of interest, which will be filed with the required state agencies. A copy of the written annual disclosure form is attached to and incorporated into these minutes as **Exhibit A**.

Chairman Quenzer opened the floor for public input.

Alex Huff presented a page from a Dakota Southern report to correct a statement he made regarding the Dakota Southern Railway Company ("DSRC") derailment. Huff requested the record reflect that the cost of the derailment was \$2,500,000.00 and not \$1,000,000.00 as he had previously reported. The page is attached as **Exhibit B**.

Jack Dokken, Program Manager for the Office of Air, Rail, and Transit, provided the Board with an update on the State Railroad Trust Fund balance.

Member Jerry Cope joined the meeting at 11:12 a.m.

Jack Parliament, a representative of D&I Railroad Co. ("D&I"), presented a proposal to the Board for the potential submission of a CRISI grant. The grant funds would be used to replace approximately 11.7 miles of 100 lb. jointed rail with approximately 7 miles of new 115 lb. continuously welded rail and 4.7 miles of 80-foot lengths of 115 lb. jointed rail. This project would also include the construction of a meet and pass siding in the Fairview, South Dakota area. The funding package would consist of CRISI grant funds in the amount of \$4,050,000.00; a loan from the Railroad Trust Fund in the amount of \$3,050,000.00; and a grant from the State Railroad Trust Fund in the amount of \$1,000,000.00. The Department of Transportation (the "Department") would be tasked with developing the grant application, with support from the Sioux Valley Regional Railroad Authority ("SVRRA"). The Department and SVRRA would share equally in the cost of the grant writing services.

Jerry Vest, a representative of Rapid City, Pierre & Eastern Railroad ("RCP&E"), presented a proposal to the Board for the potential submission of a CRISI grant. The grant funds would be used to modernize and upgrade the capacity of the RCP&E main line west of Fort Pierre between Mileposts 488.3 (Fort Pierre) and 520.6 (Capa, South Dakota). The project would replace 25.6 miles of old, obsolete, and defect-prone 90 lb. and 100-35 lb. main line rail with new modern 115 lb. continuous welded rail; upgrade seventeen (17) separate bridges to be able to handle modern 286,000 lb. freight cars; and rebuild the "JC siding" at MP 505, replacing 72 lb. rail with new 115 lb. continuous welded rail. The funding package would consist of CRISI grant funds in the amount of \$10 million; RCP&E match in the amount of \$10,000,000.00; and a supplemental grant from the State Railroad Trust Fund in the amount of \$2,500,000.00. The CRISI grant application would be prepared by RCP&E management and a consulting firm. RCP&E would pay for the consultant.

Heath Haden, a representative of Dakota Southern Railway Company ("DSRC"), presented a grant request to the Board for the potential submission of a CRISI grant or other type of grant. The project would consist of placing approximately 50,000 to 60,000 tons of ballast (40,000 West River and 20,000 East River), double tamp the entire line, and place 2,000-3,000 ties. The funding package would consist of CRISI grant funds in the amount of \$1,250,000.00 and DSRC would use an in-kind match for the remainder of the \$2,300,000.00 cost of the project. Haden was unsure who would be responsible for the application and associated cost of any grant writing services.

Dokken presented a letter the Department received from Ken Cotton, an attorney representing the MRC Regional Railroad Authority ("MRC RRA") in response to the potential submission of a CRISI grant application. The project would consist of expanding the MRC rail line west to Murdo, South Dakota. Although a proposed estimated project cost was not indicated in the letter, MRC RRA indicated that the cost of the project would necessitate a large grant with a corresponding large "match" being put up by the MRC RRA, or other entities. The MRC RRA would need assistance from the Department to complete the grant application.

With no other business to come before the Board, the meeting was adjourned at 12:57 p.m.
