#### SOUTH DAKOTA BOARD OF PHARMACY March 30, 2023 1:00 pm CDT Public Board Meeting

Meeting was called to order at 1:02 pm CDT. Mission statement was read, roll was called, and a quorum confirmed. A call for public comment pursuant to SDCL 1-25-1 was made; there was no public comment. A motion to approve the consent agenda was ratified (Somsen / Kraemer / carried).

Operations Report - Executive Director, Kari Shanard-Koenders

- Dan Somsen's replacement has not been determined by the Governor.
- Staff has completed scanning all license documentation.
- Due to funding issues, two PDMP projects (NarxCare and Statewide Gateway) that were funded by a BJA grant and available to
  PDMP users have been discontinued. BJA did not approve the budget submitted with our most recent grant proposal and has
  designated our vendor Bamboo as a subrecipient. We are at an impasse with BJA and will focus on the basics of PDMP going
  forward.
- March 29, 2023, the FDA approved Naloxone for over-the-counter use. Concern what the price will be and when available.
- Public Health Emergency is ending on May 11, 2023.
- PREP ACT Liability protections will remain in effect through October 1, 2024, potentially only if there is a government contract involved.
- Plan to begin rule writing efforts to retain technicians' ability to immunize and expand pharmacists immunizing options.
- DSCSA rules (becoming compliant with digital data sharing), is effective November 27, 2023.
- NABP has established a database to help individuals and regulators with contacts to assist in determining drug legitimacy.

#### **Inspector Reports**

Carol Smith

- Rescheduled nine inspections due to weather.
- Found C-II and CIII-V invoices that were not segregated when filed. Invoices were separate for current month but then filed all together in a manila envelope. Invoices need to be filed separately.
- Found outdated product on the shelf.
- Found "return to stock" medications that were over one year old on the shelf.
- Found an expired SD controlled substance registration; entity's DEA registration was in date.

#### Lee Cordell

- Staffing in pharmacies appears slightly better than in pharmacies visited last quarter.
- Compounding book not updated; one case with no compounding master formula for reference.
- Found multiple temperature log issues (not up to date) or temperature excursions not recorded properly.
- Wholesaler moved and failed to inform the board.
- Identified several pharmacies with cleanliness issues like food in area used for drawing up immunizations and hazardous drugs.
- Found many stock bottles with names still on bottle.

#### Tyler Laetsch

- Fielded many questions regarding telemedicine, script legitimacy, hospital compounding and concern.
- Accompanied DEA investigators on a SD inspection / compliance check
- Future focus rule changes regarding technician immunizations and PREP Act changes.
- Questions regarding Canadian pharmacies filling prescriptions and sending scripts to South Dakota; not considered legal in South Dakota.
- Hy-Vee opened a Central Fill Distribution Center in Sioux Falls. A first of a kind in the State.
- Questions/discussions about drug brokers in the U.S. an online site tied to multiple wholesalers; allows independent
  pharmacies to search for the best drug price.
- USP <797> Glove boxes are no longer good on their own; need to be in a clean room suite to get the full beyond use date.
- Tyler was chosen as the SDSU Preceptor of the Year; award presented at graduation hooding ceremony.

#### PDMP Report - Director Melissa DeNoon

- In 2021, SD PDMP was awarded a three year BJA Grant pending budget approval. Funds were never received as BJA disqualified the PDMP platform vendor Bamboo Health as a contractor. Many other states experienced the same vendor issue. Due to lack of funding, both the gateway integration and Narxcare programs ceased January 2023. Many entities/facilities have opted to pay fees themselves to maintain programs; however, integration cost may prohibit smaller entities and independent pharmacies from participating. The board is working with Bamboo Health to reconcile amounts owed for services.
- Continue to work on compliance, correcting errors on PDMP data that has not posted due to errors.
- Reviewed PDMP stats, top 10 controlled substances list, take-back program (see handout).

#### SD Pharmacists Association Activity & Financial Reports - Amanda Bacon, Executive Director

- HB 1135 (regulating PBMs) was signed into law by the governor and becomes effective July 1<sup>st</sup>, 2023. The bill prohibits direct or indirect retroactive claims adjustments, prohibits onerous fees, prohibits PDMs from reimbursing its own pharmacies more, strengthens gag protection, and addressed MAC list regulation. In addition, the bill strengthens audits and reporting requirements for PBMs.
- Eric Grocott, a past SDPhA president, was appointed to the 14-member medical marijuana oversight committee by the executive board of the LRC. The committee will review and advise on medical marijuana in South Dakota.
- SDPhA spring district meetings as schedule through April.
- Annual SDPhA meeting is set for September 15-16, 2023, at the Lodge in Deadwood, SD.

#### **Other Reports**

SDSU College of Pharmacy – Dan Hansen, Pharm.D., Dean and Professor

- SDSU College of Pharmacy and Allied Health Professionals received affirmation of their Accreditation of the Pharmacy program through ACPE; College received a full eight years of accreditation (through June 2031).
- 2022 NAPLEX results SDSU 94.4% first time pass rate, 79% national first time pass rate; places SDSU at #1 in District 5 and #5 in the nation. Pass rates may have been impacted/affected by COVID.
- 24 students matched for PGY1 residency in the first round; second round match is underway.
- Discussion of pharmacy curriculum offerings around informatics / computer science / AI. Not a lot of student interest in that area.

SD Society of Health System Pharmacists (SDSHP) - Alyssa Bryant, Pharm.D., SDSHP President

- SDSHP Annual Conference will be held March 31<sup>st</sup> April 1<sup>st</sup>, 2023, in person.
- 2024 Annual Conference is scheduled for April 5-6, 2024, in Sioux Falls.
- In planning stages of the upcoming Resident Conference scheduled for June 14, 2023, at Arrowwood Resort in Oacoma, SD
- Launched a new SDSHP Fellowship Program
- Board member transitions

SD Association of Pharmacy Technicians (ADAPT) – John Thorns, CPhT (no report)

SD Health Professionals Assistance Program (HPAP) - Amanda McKnelly, MS, LAC

- SD HPAP was established in 1996. Enrollment in the program can be voluntary or mandated. Voluntary users are not known to the board while mandatory users are known to the board.
- Currently, seven pharmacists are enrolled in HPAP with one successful discharge and two non-successful discharges.
- All pharmacists enrolled in the program are employed.
- HPAP program fees for mandated users are paid by the SD Pharmacist Association. Amanda McKnelly requested a funding decrease from \$20,000 to \$15,000 due to decreased participant numbers.
- A pharmacist on buprenorphine, if they meet HPAP criteria, would be admitted into the program so they could potentially return to practice.

#### Old Business

Renewal of Hy-Vee Variance for Technician Administered Vaccines - James Mennen, BS Pharm, MS, MBA

- James Mennen appeared to request a one-year extension of the current variance allowing technicians to administer all types of immunizations in the pharmacy setting.
- Technician immunization numbers:
- 22 technicians trained to administer vaccine and CPR certified at 10 Hy-Vee sites in SD
- From March 2022 February 2023, Hy-Vee pharmacies gave a total of 53,775 immunizations with technician giving 17,702 immunizations.
- Three patients refused a technician administered immunization
- No adverse events were recorded.
- Additional benefits allowed for increased testing, increase in COVID-19 vaccines given, increase in flu shots and Shingrix vaccines.
- Motion to approve one year extension of current variance with continued reporting (Somsen / Kraemer / unanimous).

Workplace Satisfaction Survey SDSU - Emily Van Klompenburg, PharmD, BCACP

- Survey was sent via ListServe with reminder communications sent at weeks two and four.
- Survey collected data from 242 participants in South Dakota; most respondents came from the Sioux Falls SDPhA district (125) and Black Hills SDPhA district (50); 71.85% worked in a hospital or community settings followed by 8.28% in ambulatory care.
- The top three reasons why participants chose their current field of work scope/nature of the work, professional interest, and location.
- Survey measured respondents' satisfaction with career, current position, and setting; motivation for change of practice setting, and unsafe work environment issues workflow interruptions, inadequate staffing, non-clinical duties.

2021 BJA Harold Rogers Grant and Bamboo update - Melissa, Kari

• Topic discussed during the Operations Report and PDMP report.

USP <795>, USP <797>, published 11/1/2022, enforceable 11/1/2023 - Tyler

- USP <795> documented training and change to best used date.
- USP <797> smaller hospitals to address glove boxes, immediate-use, or remodel.
- USP <800> almost all South Dakota pharmacies are compliant.

Donated Prescription Drug and Medical Supply Redispensing Program update - Tyler

- Rules passed and in effect for program November 27,2022.
- Optum and RVO are working to develop a BIN and PCN number for claims processing for zero pay.
- RVO will pay for Optum set-up fees; board is currently working on an agreement with entity.
- Vendor, Serum, began development of a database but had to step away from the project. Google Docs will be the go forward database for the project and administered by the Board of Pharmacy.
- Work continues on finalizing forms.

#### **New Business**

Hy-Vee Central Fill Variance for Final Verification – Judith Zachariasen, PharmD.

- Today, Board members toured the new Hy-Vee Central Fill Pharmacy that utilizes Parata Express Robots (PE), a fully automated system, for labeling, counting, and capping of prescriptions. System is extremely accurate.
- Hy-Vee has requested a variance to SD Rule 20:51:29:20 to allow pharmacist verification to occur at the point of individual canister replenishment instead of adjudication of every prescription at fulfillment.
- A pharmacist verifies the drug filled in all replenished/refilled canisters, canister(s) is loaded in the Parata Express Robot, and the first script dispensed out of each canister verified/adjudicated.
- A similar system is used at the Hy-Vee Des Moines Central Fill Distribution Center with a 99.8% accuracy rate.
- Forced verification is utilized for all manual fills and anything filled by a technician. Two images of each prescription are taken and archived for historical purposes/access. Return to stock items are placed on the shelf in front of return to stock bottles, labeling allows item to be scanned back into PE.
- Motion to grant a variance to 20:51:29:20 to allow Hy-Vee Fulfillment Distribution Center to verify the first prescription filled out of a canister only, to provide the board with quarterly error reports, and to revisit variance in one year. (Hansen / Somsen / carried).

Rules to make PREP Act authorization permanent for SD - Kari, Tyler

- Preliminary discussion authorizing the board to develop rules to make PREP Act permanent in South Dakota.
- Motion to direct the board to work on (1) rules to make PREP Act accommodations permanent, (2) legislation to move the
  administration of the controlled substance registration from the Department of Health to the Board of Pharmacy, (3) adopting
  all USP <795>, <797>, <800> and <825> rules (Hansen / Rising / carried).

There was no Executive Session per SDCL1-25-2(4) to discuss contract/attorney consultation

# Legislative Session and Policy Initiatives

# 98<sup>th</sup> Legislative Session

The main run of the 2022 Legislative Session has nearly drawn to a close, as of the date of this report we are in the final week of the main run of the Legislative Session, which concludes March 10. The final legislative day is, "Veto Day," March 27. That's the legislative day reserved at the end of each session calendar for the consideration of gubernatorial vetoes.

We are extremely grateful to once again have retained the skillful services of long-time SDPhA lobbyist and general legal counsel Robert Riter, as well as Lindsey Riter-Rapp, who is in her 4<sup>th</sup> year as lobbyist for SDPhA. This year we also again employed the services of Craig Matson and Roger Tellinghuisen specifically regarding our Pharmacy Benefit Manager (PBM) initiatives.

# HB 1135

Things were quite active for the SDPhA Commercial and Legislative Branch well before the session started. In fact, round two of work on legislation to regulate PBMs began shortly after the gavel fell on the 97th (2022) Session. Nearly immediately after SB 163 failed on a tie vote, several Senators expressed to us, and some of our opponents, that they had a desire to see this work come to fruition for the good of all. We took those words to heart, and your SDPhA board soon went to work. SB 163 was very comprehensive legislation, so the board's first task was to identify the "must have" provisions from that bill. The following were the pieces we felt had the most immediate impact should the bill become law. We're happy to say that after many months and countless hours of negotiations with stakeholders (including Wellmark and PhRMA, among others), all the SDPhA priorities remained in the bill:

- **Prohibit direct or indirect retroactive claim adjustments** unless it's the result of a technical billing error, audit, fraudulent or duplicate claim. (Section 13)
- Prohibit the numerous onerous fees PBMs charge pharmacies. (Section 14)
- MAC list regulation to help ensure pharmacies are paid fairly and transparently. (Sections 15-16)
- **Prohibit a PBM from reimbursing its own pharmacies more** than it does other resident South Dakota pharmacies (Section 17)
- Strengthens gag clause prohibition (Section 10)

**In addition**, the bill strengthens audit (Section 4, 7) and reporting (Section 18) requirements for PBMs (including identifying all instances of spread spicing) and establishes the conditions under which the Division of Insurance may suspend, revoke, or deny a PBM's license (Section 19).

HB 1135 came unanimously out of the House Commerce and Energy Committee, Feb. 8, passed the House of Representatives 62-5 Feb. 12, passed unanimously out of the Senate Health and Human Services Committee, and passed the full Senate with a vote of 34-0. At present, HB 1135 has been signed by the Speaker of the House and the President of the Senate, and has gone to the Governor. Wellmark, Hy-Vee, Avera and the South Dakota Retailers spoke as proponents of the bill.

We want to express our immense gratitude to **Rep. Mike Weisgram**, the Prime Sponsor of HB 1135, and **Sen. Mike Diedrich**, the prime sponsor on the Senate side. These two gentlemen have put in a lot of work to help us pass this bill. In addition, thank you to **Eric Grocott, Hugh Mack, Lindsey Osterkamp**, and **Kristen Carter** for their invaluable testimony, as well as to all of you who wrote, called, emailed, and showed up to make sure the voice of pharmacy was heard. Thank you to SCAPP student liaisons **Kaylee Ayers** and **Annabelle Simpson**, who rallied our student pharmacists, and thanks to some fortuitous timing – ensured we packed the first committee hearing with a sea of beautiful white coats. Last but certainly not least, we would not be where we were it not for **Craig Matson**, our lead lobbyist on this issue. He put countless hours into this bill in the "off season" with Amanda Bacon and the SDPhA board, as well as the other principal stakeholders. His partner **Roger Tellinghuisen** was also an integral part of the passage of HB 1135.

## Other Key Bills

The passage of HB 1135 required the bulk of our time and attention. As such, while we monitored a long list of other bills this Legislative Session, the board is extremely strategic regarding the bills in which they choose to actively engage. Lindsey Riter-Rapp and Robert Riter continue to do a remarkable job of working with us to watch out for the profession.

<u>SB 122</u> - SDPhA testified in opposition this legislation titled "address the potential abuse of opiate and opioid drugs." We echoed the concerns of many others with regard to the legislation, but also highlighted section three of the bill as particularly problematic for pharmacy. The Senate Health and Human Services Committee unanimously sent SB 122 to the 41<sup>st</sup> legislative day.

Several other key pieces of legislation on which SDPhA kept a close watch: Immunization measures, COVID immunization measures, mental health issues, practice act measures, employment contracts issues, Medicaid coverage, drug paraphernalia measures, controlled substance scheduling, several bills related to medical marijuana, You can see the full scope of the bills we followed this session <u>online with the SDPhA's new bill tracker</u>.

# Medical Marijuana and IM 26 Oversight Committee

One of the medical marijuana bills referenced above (SB1) came out of the Medical Marijuana Oversight committee. Initiated Measure 26 required the creation of an oversight committee, and South Dakota pharmacists have a seat at the table. Eric Grocott, a past president of SDPhA, was appointed to the 14-member oversight committee by the executive board of the Legislative Research Council. The committee's role is to review and advise on medical marijuana in South Dakota. The group most recently met in Pierre Oct. 25. Discussion included legislative drafts, one of which the group voted to move forward to the Executive Board for further consideration as referenced above.

# Lobbying Funds Update | Commercial and Legislative Branch

All of this legislative work leads us here – to the very important role the Commercial and Legislative Fund plays in our ability to move forward with PBM reform, and other legislative priorities. The legislative work of recent years shed some light on something that may have seemed a bit mysterious to many – the SDPhA Commercial and Legislative (C&L) Branch. The C&L branch is the lobbying arm of the association.

#### Some very important things about this fund:

- The funds for our lobbying branch must be maintained separate from the general fund
- It relies nearly exclusively on your contributions
- For many years now, expenses have vastly outpaced contributions

Lobbying is an extremely expensive, but necessary function. We've been represented by the same firm for decades, and the executive director preforms many of the lobbying duties. That's all kept our rate very low – our lobbying expenses **had** typically totaled only about \$12,000 per year. This amount is **far below** the going rate of most lobbyists. In fact, the going rate for one session with many would empty our entire C&L Fund.

As referenced earlier, we had additional lobbyists working with us for the 2022 and 2023 session. **So, while all this was needed to move our PBM initiates forward, it also means expenses have increased dramatically.** This legislative work cannot continue without your strong financial support. If we want to ensure the profession has a seat at the table, we have to pay for the chair. **We need your help.** \$25, \$250, 2,500 – whatever you can contribute will help ensure the profession continues to have representation at the Capitol. Because without your contributions – it simply won't.

#### Legislative Days

They say timing is everything and that couldn't possibly be more true than for the 2023 Legislative Days event at the Capitol. The event Feb. 7-8 coincided with the House Commerce Committee Hearing for HB 1135, and we filled the committee room with pharmacy students eager to see the process, and take a stand (literally – it was standing room only) for their profession.

Tuesday evening provided a townhall style opportunity for pharmacists, pharmacy technicians and pharmacy students to learn about our work thus far in the legislative session. Lindsey Riter-Rapp, SDPhA lobbyist, and Amanda Bacon, SDPhA Executive Director, discussed the various bills and legislation SDPhA was working on your behalf. The group also heard from Kari Shanard- Koenders, Executive Director, Board of Pharmacy. Wednesday morning prior to the committee hearing, we provided wellness screenings at the Capitol, courtesy of the roughly 30 SDSU student pharmacists who attended.

Legislative Days is a fantastic opportunity to show a much broader range of the great work pharmacists do each day. It's also a unique chance for students to hone their skills by providing screenings, while also having the option to sit-in on various committees, and venture onto the House and Senate floors to meet their lawmakers. There's nothing like learning the legislative process first-hand! Practicing pharmacists, we strongly encourage you to join us next year – your involvement further showcases, for students and lawmakers alike, the importance of having a strong presence at the table during legislative session.

### Legislative Process 101

SDPhA was honored to again virtually join the classroom of Dr. Erin Miller Thurs., Feb. 9. Executive Director Amanda Bacon provided students with a walk-through of the legislative process, and used real-time examples from the current legislative session to explain many of the issues, challenges and pitfalls bill can face on the way from becoming an idea to a law, as well as the politics often in play behind the scenes. The students had fantastic questions, and we had great dialogue about how the process works, and how the results impact them each day in their professions. Our thanks to Dr. Miller for having us – we always enjoy the opportunity.

# SDPhA Spring and Annual Meetings

## Spring District Meetings

Spring District meetings are taking place in a variety of ways this year. While some districts are back to meeting in person, others continue to utilize Zoom to gather. Please watch your emails, <u>the website</u> and <u>social media</u> for dates and instructions. This spring meeting is the most important district meeting of the year, as the fall meeting is now optional. Many important items need to be addressed, including the election or re-election of district officers; nominations for the state association board of directors; and the recognition and nomination of worthy pharmacists, reps and technicians to be considered by the Executive Board for the awards presented at our annual meeting.

# National Efforts and Partnerships

## Federal Trade Commission and House Committee on Oversight and Accountability

We, along with many other organizations and individuals from South Dakota, have submitted comments to the Federal Trade Commission (FTC) regarding detrimental PBM practices, and expressed similar concerns to the Centers for Medicare and Medicaid Services (CMS) regarding DIR fees and their 2023 proposal. There's finally some true momentum in Washington D.C. on this topic. The bipartisan bill S. 127 Pharmacy Benefit Manger Transparency Act of 2023 was introduced at the end of January. Feb. 16, U.S. Sen. Maria Cantwell (D-Wash) convened a full committee hearing on, "Bringing Transparency and Accountability to Pharmacy Benefit Mangers. Just a few days later on March 1, the House Committee on Oversight and Accountability launch an investigation into PBM practices.

### Additional Advocacy Efforts

SDPhA also remains engaged in a variety of ways in other various national efforts on key topics directly impacting our pharmacists such as: TRICARE pharmacy contracts, COVID-19 related bills, DIR fee relief, PBM reform, pricing transparency, improvements to Medicare, prescription drug misuse and abuse, compounding guidance, and scope of practice.

### APhA Annual Meeting | March 24-27

The APhA Annual meeting will take place Phoenix, AZ March 24-27. SDPhA Board President Melissa Gorecki will represent SDPhA, and South Dakota in the House of Delegates. Plans are in the works to resume the tradition of taking the SDSU SCAPP students and faculty out for a dinner/activity – that's always a highlight!

# NCPA Congressional Pharmacy Fly-In | April 26-27

The National Community Pharmacy Association has is once again holding the pharmacy fly-in. We are in the process of finalizing who will attend for SDPhA. This is a fantastic opportunity for pharmacy to take the PBM fight to Capitol Hill, as well as take the opportunity to discuss other priority measures for pharmacy. NCPA has been an extremely important partner for us in our legislative work the past few years, and we appreciate the opportunity to participate in this important event.

# Coronovirus (COVID-19)

### Unwinding from the Public Health Emergency - Medicaid

The Public Health Emergency is set to expire May 11, 2023. That means a lot of different things for different aspects of healthcare, including pharmacy. According to Medicaid.gov, "The expiration of the continuous coverage requirement authorized by the Families First Coronavirus Response Act (FFCRA) presents the single largest health coverage transition event since the first open enrollment period of the Affordable Care Act. As a condition of receiving a temporary 6.2 percentage point Federal Medical Assistance Percentage (FMAP) increase under the FFCRA, states have been required to maintain enrollment of nearly all Medicaid enrollees. When the continuous coverage requirement expires, states will have up to 12 months to return to normal eligibility and enrollment operations. Additionally, many other temporary authorities adopted by states during the COVID-19 public health emergency (PHE), including Section 1135 waivers and disaster relief state plan amendments (SPAs), will expire at the end of the PHE, and states will need to plan for a return to regular operations across their programs. CMS will continue to update this page as additional tools and resources are released."

#### **Pharmacist Access**

Pharmacists were granted additional authorities through the Public Readiness and Emergency Preparedness (PREP) act. This was an emergency waiver granted through HHS, and linked to, but not dependent on, the Public Health Emergency. Under these authorities, HHS granted pharmacists and pharmacy technicians the ability to order and administer COVID-19 tests, vaccines and therapeutics. While those authorities run through Oct. 1, 2024, because pharmacists operate largely under state law, there's a lot that remains unclear when the emergency expires in May. Our national pharmacy groups are working together to urge the Biden administration to make these authorities permanent. SDPhA supports these efforts.

# Prescription Drug Abuse and Awareness

#### DEA Take-Back Events

#### The Spring DEA Take Back Day is planned for April 22, 2023. Please visit

<u>https://www.deadiversion.usdoj.gov/drug\_disposal/takeback/</u> for more information. We continue to work to encourage pharmacist participation in these locally-held events. We also continue to work with pharmacists and the BOP to promote the year-round pharmaceutical disposal receptacles. If you have a story you'd like to share about either to aid in that promotion, please contact our office.

#### Prescription Drug Monitoring Program

The Prescription Drug Monitoring Program (PDMP) continues to be an excellent resource for practitioners. South Dakota state law mandates PDMP registration for everyone who has a SD Controlled Substance Registration (SD CSR).

While the Board of Pharmacy is the entity managing the program, an advisory board was established under the law which consists of at least twelve (12) designees. Jessica Strobl serves on SDPhA's behalf on the advisory board. The group continues to make recommendations to the Board of Pharmacy as to how to best use the program to improve patient care and reduce the misuse, abuse or diversion of controlled substances. The advisory council also makes recommendations to the Board for release of information to only persons who are entitled to access in order to maintain the confidentiality of program information.

## South Dakota Opioid Abuse Advisory Committee

This committee met most recently Jan. 6, 2023. SDPhA Past President Kristen Carter represents SDPhA. The goal of the group is to review opioid use data for the state and develop strategies for preventing prescription opioid misuse and abuse. According to the National Institute on Drug Abuse, researchers have observed increases in substance abuse and drug overdoses since the COVID-19 pandemic was declared a national emergency. Nationwide, pharmacists continue to engage in the work to prevent prescription drug abuse with the knowledge that real solutions must balance the need for patient access to medications for legitimate medical purposes with the need to prevent diversion and abuse. # Health Professional Assistance Program

The passage of SB4 in 2021 brought changes to some of the requirements for HPAP program administration. We continue to appreciate the open communication with the Board of Pharmacy on what this may mean for the future of the program. Our association continues to support HPAP, and saw no changes in the billing for FY 2022-2023. A pharmacist may access the program by self-referral, board referral, or referral from another person or agency, employer, coworker or family member.

# Pharmacy Technician University (PTU)

The SDPhA board is committed to strongly supporting pharmacy technicians, including finding them, training them, and keeping them. We know this is becoming an even more pressing issue now than perhaps maybe ever before.

After negotiating a new contract for 2022-2024, SDPhA is pleased continue to offer low-cost access to this online training module. As with everything, user fees increased slightly starting in July 2022. SDPhA has now enrolled nearly 160 participants. We are also thrilled to report a record 15 student participants have enrolled through the DIAL Virtual Program for the 2022-2023 school year. This program works with high schools throughout South Dakota. We appreciate the pharmacists who have stepped up in communities across the state to work with the DIAL program and these students. This is an exceptional opportunity to introduce the profession into the school systems, and we are grateful for everyone working together who makes it happen.

Just a reminder, the Therapeutic Research Center - PTU 101 module we administer qualifies as a PTCB-Recognized Education/Training Program of the CPhT program, and upon completion, allows participants to sit for the certification exam. In addition to PTU 101, we now offer four additional training modules through TRC:

- PTU Elite: Immunizations
- PTU Elite: Math Mastery Community Pharmacy
- PTU Elite: Compounded Sterile Preparation Technician Program
- PTU Elite: Soft Skills Program.

The board approved at the October 2021 Board of Pharmacy meeting a pilot project to allow technicians to provide all types of immunizations in the pharmacy setting, outside of HHS PREP Act guidance. For this purpose, the board approved the variance to the following rules ARSD §§ 20:51:28:02.01, 20:51:29:20, & 20:51:29:21(6) to allow for Technician-Administered Immunizations. This variance was extended for another year at the April 2022 meeting. We are requesting an extension for another year.

Attached are the technician immunization numbers:

- We have 22 technicians trained to administer vaccine and CPR certified at 10 Hy-Vee sites in South Dakota
- Hy-Vee Pharmacies gave a total of 53,775 immunizations with technicians giving 17,702 from March 2022 through February 2023 in South Dakota
- Technicians have given 33 % of the vaccines given at Hy-Vee Pharmacies in South Dakota
- There were 3 refusals from patients compared to the 17,702 that were given.
- There were no adverse events recorded

# This program provided a great benefit to our pharmacies and pharmacists serving the public during the pandemic

- 1) Allowed for an increase in testing
- 2) We saw an increase in Covid-19 vaccines given due to new variants, approved boosters, children's vaccine approvals.
- 3) We experienced an increase in vaccines given during flu shot season and an increase in demand for Shingrix vaccine with new Medicare coverage mandates at the beginning of the year.

We thank the board for allowing us to participate in the variance allowing our technicians to assist our pharmacist with the increase in demand for immunizations our pharmacies experienced during the Covid-19 pandemic.

Many states have expanded and made permanent the authority of pharmacy technicians to immunize to ensure these benefits can continue to be realized after the HHS guidance expires. We would hope that South Dakota would consider legislation/rule changes to continue this practice.

Dear Members of the South Dakota Board of Pharmacy:

We would like to request a variance to SD Rule 20:51:29:20 at its Pharmacy Fulfillment Center in Sioux Falls, SD, which would allow us pharmacist verification by-pass. This variance request is due is in response to the use of automated mechanical distribution devices (AMDD) to provide the labeling, counting, and capping of applicable prescriptions in a fully automated process using Parata Express Robots. Hy-Vee utilizes a pharmacist verification process, canister replenishment/verification by a pharmacist, quality assurance procedures, industry standard safety procedures and an ongoing evaluation process to ensure patient safety while using the MDS. The AMDD used in Hy-Vee's Central Fill Pharmacy is of high quality and extremely accurate to ensure patient safety.

The physical verification for the prescription drug for the AMDD is focused on the replenishment and filling of the individual canisters. To also verify each individual item would greatly decrease the ability of the facility to process prescriptions medications and in turn decrease their ability to service stores in an effective manner. Compliance with SD Rule 20:51:29:20 would remove the efficiencies that render the Central Fill Pharmacy operationally viable. The safety measures laid out further in the application provide an extensive view of the measures already in place to ensure that an individual check of each item is not necessary.

The rule intends to ensure the verification of each product dispensed out of AMDD. Since a similar verification process takes place when the AMDD canisters are replenished and filled, the need for an individual check of each item that is filled from these canisters is not necessary.

There are many safety measures in place for this system. First, the AMDD system interface requires an exact NDC number (or other unique drug identifier) match to select the proper drug, strength, and manufacturer for replenishing in the canister. Without an exact match between the drug requested and drug stocked in the robotic system, the operating software will not allow the canister to be replenished. If the pharmacist or technician would attempt to scan an incorrect bottle during the replenishment process, an error code would lock the station requiring a pharmacist to physically inspect the machine and correct the error before proceeding. Further, AMDD includes a scale which is precisely calibrated for the identified drug in the related canister. The drugs that are dispensed from the canister are then weighed on the scale. The AMDD will detect a drug that does not meet the weight requirement and such an error would also require pharmacist intervention to correct the problem. Additionally, as an added safety measure, a photograph of the pills that are placed in a canister and every prescription that is filled by the AMDD is taken and recorded. Finally, a pharmacist physically verifies the first prescription filled out of a filled/refilled canister. If the pharmacist detects any errors through this physical verification process, the pharmacist immediately stops the AMDD process to identify the cause of the error, document the error, correct the error, and take measures to prevent the error from occurring in the future.

This variance request was also submitted to the Iowa Board of Pharmacy and was approved for Hy-Vee central fill sites filling prescriptions for Iowa patients. The Nebraska Board of Pharmacy does not require a variance for this at this time.
