Chairman Don Roby called the meeting of the South Dakota Transportation Commission (the “Commission”) to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Roby opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 – 23.

No members of the Commission disclosed a conflict or requested a waiver.

Roby asked for a motion to approve the February 13, 2025 Commission meeting minutes.

A MOTION WAS MADE by Simons and seconded by Vehle to approve the February 13, 2025 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Roby opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Roby asked for a motion for the Commission to enter into executive session.

A MOTION WAS MADE by Jensen and seconded by Vallery to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel and reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by roll call vote. The motion carried.

Weisgram explained that the city of Wagner (the "City") did not complete the advertisement of the bid-letting in accordance with state law. Consequently, the Department of Transportation (the "Department") recommends the Commission reject the bids.

Wagner City Council member, Brenda Jatton acknowledged the City’s error in not publishing notice of the bid-letting and explained that a grant to assist with the City’s project costs could be in jeopardy due to the publication oversight. She requested the Department promptly re-bid the project to allow the City to publish notice as required. Debra Houseman, City Administrator, asked that the project be promptly re-bid to allow the City to receive the grant for its utility project. Jacob Sonne of SPN & Associates, the engineer of record for the City’s utility project, addressed the Commission. He addressed the need for the city project, due to the potential for water main breaks and sewer breaks.

A MOTION WAS MADE by Frick and seconded by Vehle to reject bids #1 and #2. All present voted aye by roll call vote. The motion carried.

Weisgram was asked when the projects could be re-bid and he indicated the bid opening may be in late March, 2025.

A MOTION WAS MADE BY Karim and seconded by Jensen to approve all bids from February 19, 2025. All present voted aye by roll call vote. The motion carried.

Steve Blair from the South Dakota Attorney General's Office gave a presentation on Open Meeting Laws.

\*\*\*

Secretary Joel Jundt presented the following items to the Commission in his Secretary's Report:

1. Federal update –

- Appropriations: the current Continuing Resolution (CR) for all federal funding is set to expire March 14, 2025. News coming out of Washington DC is that there is still a lot of work to be completed prior to passing the full year appropriations bills by March 14. If Congress is unsuccessful, there will likely be another CR. Another CR may affect discretionary grants and the timing of notice of funding opportunities for applicants.
- With the new administration and the recent Presidential Executive Orders, the Department is working with our federal partners as they work through the administrative review process. The Department has had weekly discussions with Federal Highway Administration (FHWA), which we appreciate the open line of communications with the local division office – this has helped with keeping things moving and avoiding any major project delays. The Department will continue to collaborate with FHWA while this administrative review continues. Eventually, we do expect some changes to the federal programs which will be communicated via written guidance from those agencies.

2. State legislative session, there are only two weeks left. Bills of interest:

- All three DOT bills (SB38, SB39, and SB40) were signed into law by the Governor. Based on SB39 which modifies the US14 designation around Pierre, we will also need to change Administrative Rules for Long Combination Vehicles later this summer.
- HB1249, a condemnation bill, was amended numerous times and would have affected the Department's work. The prime sponsor amended the bill and it is now specifically targeted to carbon pipelines. The bill was passed by the House and is now waiting action in the Senate.
- SB95 makes an appropriation for distribution to county rural access infrastructure funds (RAIF). This bill would provide \$25 M of general funds to continue the RAIF program. The bill passed the Senate Transportation Committee and is scheduled for hearing on February 27, 2025.
- SB195 appropriates funds for public transit. This bill as amended would provide an additional \$825K of general funds towards public transit. The bill was tabled today in the Joint Committee on Appropriations.
- SB198 establishes conditions a prospective condemnor must satisfy before commencing condemnation proceedings. This bill was amended a number of times, with the main goal to require mediation to occur prior to any condemnation action being filed. Any cost for mediation would also be at the cost of the condemnor. This bill passed the Senate and was assigned to House State Affairs.
- SB116, a bill to revise and repeal provisions related to street racing prohibitions, has passed the Senate and the House Transportation Committee. This bill is geared at activities currently

occurring in Sioux Falls and impacting the highway safety of the community. This bill has the Transportation Commission referenced numerous times as the Commission would be the body that has authority for allowance of races to occur on state highways. The Department does not expect requests for this activity to come before the Commission any time soon.

- SCR601 is a concurrent resolution supporting the designation of a portion of US12 to honor the late Helen Miller. This resolution was amended to support the application of US12 for such designation and has passed both houses. The Department has received the actual application form and we are processing it for Commission consideration at a later meeting.
3. Public meeting open houses are planned for a Rails to Trails feasibility study on the Napa Junction to Platte railroad line. The study is being coordinated by the Department and is looking at the feasibility of installing a recreational trail on a portion of the state-owned railroad line. The open houses are to brief individuals on what information has been collected to date, what other data still needs to be collected, and gathering citizens' input. Eventually, after completion of the study, the results will be brought to the State Railroad Board for its consideration. The study was approved for state planning funds and that is why the Commission received notice of the meetings.

John Keyes, Program Manager for the Office of Right of Way, presented the following items for Commission consideration.

1. Request Transportation Commission approval to transfer by resolution the following property acquired for highway right of way:

Lots A and B in Lot H4 in the NE1/4 of Section 24, Township 110 North, Range 53 West of the 5<sup>th</sup> P.M., Kingsbury County, South Dakota. Lot A contains 4.71 acres and Lot B contains 0.38 acre.

Lots A and B are located at the intersection of highways SD14 and SD81 approximately two miles south of Arlington.

The above transfer completes Jurisdictional Transfer Agreement #613625 signed by DOT on October 22, 2010 and Kingsbury County on September 28, 2010.

DOT Aberdeen Region and Watertown Area advises the above property is no longer needed for highway purposes and transfer is recommended.

A MOTION WAS MADE by Karim and seconded by Vallery to approve the transfer to Kingsbury County. All present voted aye by roll call vote. The motion carried.

2. Request Transportation Commission approval to abandon by resolution the temporary easements on Brookings County Project P-PH 0014(172)418, PCN 01TJ. The project was US14 from west of Western Ave to Main Ave in Brookings and SE of US14B over west branch of Six Mile Creek and over Six Mile Creek. Construction included grading, PCC surfacing, curb and gutter, storm sewer, traffic signal upgrade, lighting, bridge deck overlay and guardrail.
3. Request Transportation Commission approval to abandon by resolution the temporary easements on Day and Marshall County's Project P 0025(00)181, PCN 02B5. The project was 1.8 miles of SD25 through Webster and Veblen. Construction included curb ramp upgrades and traffic signals.
4. Request Transportation Commission approval to abandon by resolution the temporary easements on Clay County Project NH-P 0050(91)396, PCN 0237. The project was 12 miles of SD50 from the Yankton/Clay County line to Vermillion. Construction included grading, PCCP surfacing, mill and AC overlay.
5. Request Transportation Commission approval to abandon by resolution the temporary easements on Custer County Project P-PH 0089(07)58, PCN H031. The project was 6 miles of SD89 from US 16A to SD87. Construction included mill and AC resurfacing.
6. Request Transportation Commission approval to abandon by resolution the temporary easements on Douglas County Project NH 0281(00)40, PCN 02BE. The project was 0.7 mile of US281 through Armour. Construction included curb ramp upgrades.
7. Request Transportation Commission approval to abandon by resolution the temporary easements on Gregory County Project P 0044(162)278, PCN 02V0. The project was 16 miles of SD44 from east of the SD47 junction. Construction included erosion and slide repair.

REV 25-022 This project was previously in the 2023-2026 STIP when bids were rejected due to higher-than-expected bids. The revision will add a FY2026 Variable Speed Limit & ITS Device project on I90 from 2 miles west of Exit 30 (Sturgis) to 1 mile west of Exit 44 (Piedmont) in the Rapid City Region.

FY 2026 Plus \$5,306,000

REV 25-023 This revision will add a FY2026 AC Resurfacing, Joint Repair project on US16A E & W at the Keystone Wye Interchange in the Rapid City Region.

FY 2026 Plus \$684,000

Doug Kinniburgh, Office of Administration, presented for Commission consideration the Bridge Improvement Grant (BIG) applications for 2025. Kinniburgh recommended award of the top 12 scoring applications for bridge rehabilitation grants and the top 5 scoring applications for bridge preservation grants as shown on **HANDOUT A**. He also requested that the projects receiving these grants be added to the STIP.

A MOTION WAS MADE by Jensen and seconded by Vehle to approve the 2025 Preservation and Rehabilitation/Replacement BIG awards as recommended by the Department and shown in **HANDOUT A** and add these projects to the 2025-28 STIP by revision. All present voted aye by roll call vote. The motion carried.

Behm provided the Commission with **HANDOUT B**, attached to these minutes, containing a list of 2024 TAP applications and included the Department's recommendations for TAP awards. The Department recommended award of all projects except the projects proposed in the cities of Beresford and Aberdeen.

A MOTION WAS MADE by Simons and seconded by Vallery to approve the TAP awards as recommended by the Department and highlighted in blue in **HANDOUT B** and add these projects to the 2025-28 STIP by revision. All present voted aye by roll call vote. The motion carried.
