Chairman Eric Odenbach called the meeting of the South Dakota Aeronautics Commission (the "Commission") to order at 2:00 p.m. CDT. A roll call was taken, and a quorum was determined.

Odenbach opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) Chapter 3-23.

Dustin DeBoer, Office of Legal Counsel, presented an annual disclosure and a waiver received from Vice-chairman Bob Huggins concerning a potential conflict of interest. A copy of the request for waiver is attached to and incorporated into these minutes as **Attachment A.** Huggins accepted a teaching position at Lake Area Technical Institute starting in the Fall 2022 semester.

A MOTION WAS MADE by Funk and seconded by Rieber that the matters disclosed in the annual disclosure and waiver request are fair, reasonable, and not contrary to public interest. All present voted age by roll call vote, except Huggins who abstained. The motion carried.

Tom Koch, Office of Air, Rail and Transit, introduced a letter to the Commission from the City of Groton concerning types of expenses and funding by the Commission.

Secretary Joel Jundt informed the Commission and the City of Groton this type of request should follow the current policy and procedures and be placed on the agenda for consideration of funding.

Secretary Jundt presented the Secretary's Report to the Commission:

- Department will present to the Commission for consideration, the current status and projections of the Aeronautics Funds at the September meeting.
- Department will also provide information to the Commission in September and an overview of the current zoning status of airports under the jurisdiction of the Commission.
