Chairman Jensen called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CST. A roll call was taken and a quorum was present.

Jensen opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

Karla Engle, Office of Legal Counsel, shared with the Commission that, due to his employment with Black Hills Energy, Commissioner Jaf Karim has identified a potential conflict of interest with Item #2 of the Right of Way Items found on Attachment #3 in the Commission packet. Commissioner Karin has previously disclosed his employment as a potential conflict of interest and the Commission has granted a waiver of the conflict, so no further Commission action is needed. Karim will recuse himself from the discussion and vote on this item.

No other members of the Commission disclosed a conflict or requested a waiver.

Jensen asked for a motion to approve the February 15, 2024 Commission meeting minutes.

A MOTION WAS MADE by Karim and seconded by Vehle to approve the February 15 ,2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Jensen opened the floor to public input.

No members of the public addressed the Commission nor offered input.

Secretary Joel Jundt presented the following items in his Secretary's Report to the Commission:

- The Federal appropriations bill has been verbally agreed upon. Another continuing resolution will be signed and set to expire on March 8, 2024 to allow time for the written document to be passed.
- Jundt gave an update on the status of the lawsuit, joined by 20 other states in addition to South Dakota, challenging Federal Highway Administration's (FHWA) new rule requiring state DOTs and Metropolitan Planning Organizations (MPOs) to set declining greenhouse gas (specifically tailpipe CO2) emission targets in connection with transportation planning. Karla Engle, Office of Legal Counsel, provided additional details about the legal filings and procedural status of the case.
- The State Legislative session is wrapping up and will be done on Thursday, March 7, 2024. The Joint Committee on Appropriations passed the Department's budget on Monday, February 25 as requested. It included additional funds for maintenance and public transit. Jundt also noted some bills that were followed by the Department, including HB1095 concerning laws for automated vehicles. This bill gives the Commission authority to promulgate administrative rules on the subject in the future. This bill had passed both Houses and was waiting for signature by the governor. If signed, it will go into effect on July 1, 2024. Other bills noted by Jundt were: SB211 (electronic remote notarization); SB76 (filling vacancies on boards and commissions); SB124 (extending the Rural Area Infrastructure Funding (RAIF) for culvert replacement to 2029); and SB169 (drone use).
- The Vehicle Miles Travelled (VMT) Advisory Team, which includes Commissioners Vehle and Simons, had an educational exchange with Utah Department of Transportation to learn about how that state implemented its voluntary VMT program. The advisory team's next step is to create the framework to move forward, including topics of legality, privacy, policy, and economic forecasting.
- There was a bridge hit on US212 at I-29 in Watertown. It is unknown who or what was the cause of the extensive girder damage. The Department will let the project as an emergency and use construction funds to fund the repairs.
- Lastly, Jundt shared that Commission Kathy Zander has given written notice of retirement from the Commission and that this would be her last meeting. He congratulated Zander and thanked her for her 10 years of service on the Commission and to the people of South Dakota.

John Keyes, Office of Right of Way (ROW), presented for Commission consideration the following items.

Beginning at the Northeast Corner of Section 1, Township 101 North, Range 48 West of the 5th P.M., thence south along the section line a distance of 200 feet, thence West a distance of 450 feet, thence north a distance of 200 feet, thence east along the section line a distance of 450 feet to place of beginning, Minnehaha County, South Dakota, containing 2.07 acres.

The above permanent easement is no longer needed for Roadside Park purposes and abandonment is recommended by Mitchell Region DOT and Sioux Falls Area DOT.

A MOTION WAS MADE by Karim and seconded by Simons to approve the abandonment of property in Minnehaha County. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2024 – 2.1 was adopted.

Commissioner Jaf Karim recused himself from the next item and took a seat in the gallery at 9:42 a.m.

2. Request Transportation Commission approval to grant a 20-foot-wide underground fiber optic line permanent easement to Clarity Telecom LLC of Rapid City, South Dakota upon the following DOT property:

Lot 9 in the SE1/4 NE1/4 of Section 15, Township 3 North, Range 6 East of the B.H.M., Meade County, South Dakota.

Lot 9 is located near Exit 46 on the east side of Interstate 90. Granting the easement as shown on Exhibit A will allow an underground fiber optic line to be placed at a depth of four feet or greater within the same easement location granted to Black Hills Energy as approved at the November 9, 2023 Commission meeting.

Clarity Telecom LLC accepts liability and financial responsibility for the underground fiber optic line. All State and Federal guidelines will be followed during the construction.

A MOTION WAS MADE by Nelson and seconded by Vehle to grant this permanent easement in Meade County. All present voted aye by roll call vote except Karim who recused himself. The motion carried.

Karim rejoined the Commission at 9:44 a.m.

This revision will add a FY2024 Statewide State Transportation Innovation Council (STIC) project to Implement Innovative Traveler Communications Strategy. SDDOT received a grant for \$95,000 through Federal Highway Administration for the project.

A MOTION WAS MADE by Zander and seconded by Karim to approve revisions 24-032 and 24-033 All present voted age by roll call vote. The motion carried.

This revision split a traffic signal project at the intersection of SD52 and Deer Blvd west of Yankton from a project planned on US81 through Yankton in the Mitchell Region to create two separate projects. (Sequence #1,008, Page 194 in the 2024-2027 STIP Book).

FY 2024 No Change

Joanne Hight, Program Manager for the Office of Administration for the Division of Planning & Engineering, presented to the Commission two requests for transportation loans.

The first request came from the City of Lemmon. The city requested a State Infrastructure Bank (SIB) loan in the amount of \$1,500,000 for phase 1 of reconstruction on 1^{st} Street East (Railroad Street) and 1^{st} Avenue East. The project includes approximately 882 feet of roadway reconstruction including draining improvements in Lemmon.

Chad Abel, Finance Officer for the City of Lemmon, addressed the Commission and answered questions from the Commission.

A MOTION WAS MADE by Nelson and seconded by Rosenboom to approve the loan as requested in the application.

A SUBSITUTE MOTION WAS MADE by Nelson and seconded by Rosenboom to approve the SIB loan for the City of Lemmon for \$1,500,000 amortized over 7 years at 1.5% annual interest and to amend the STIP to include the project. All present voted aye by roll call vote. The motion carried.

The second request came from the City of Vermillion. The city requested an advance of its Surface Transportation Block Grant Program (STBGP) funds in the amount of \$1,500,000 for improvements to East Clark Street. The City of Vermillion received approximately \$426,500 in STBGP funds in 2023.

José Dominguez and John Prescott from the City of Vermillion addressed the Commission and answered questions from the Commission.

A MOTION WAS MADE by Nelson and seconded by Zander to approve the loan as requested in the application.

A SUBSITITUTE MOTION WAS MADE by Nelson and seconded by Zander to approve the advance in STBGP funds to the City of Vermillion for \$1,500,000 amortized over 3 years at 1.5% annual interest and to amend the STIP to include the project. All present vote aye by roll call vote. The motion carried.

Based on these recent loan requests, the Commission discussed the need to consider possible changes to the Transportation Loan Guidelines at the next regular meeting of the Commission on March 28, 2024.

Doug Kinniburgh, Office of Administration, presented for Commission consideration the Bridge Improvement Grant (BIG) applications for 2024. Kinniburgh provided the Commission with **HANDOUT #2** and **HANDOUT #3**, attached to these minutes, containing a list of the 2024 Preservation BIG applications and 2024 Rehabilitation/Replacement BIG applications. The handouts included the Department's grant award recommendations.

A MOTION WAS MADE by Zander and seconded by Karim to approve the 2024 Preservation and Rehabilitation/Replacement BIG awards as recommended by the Department in **HANDOUT #2** and **HANDOUT #3** and add these projects to the 2024-27 STIP by revision. All present voted aye by roll call vote. The motion carried.

Director Behm presented for Commission consideration the Transportation Alternative Project (TAP) applications for 2024. Behm provided the Commission with Handout #4, attached to these minutes, containing a list of 2024 TAP applications. **HANDOUT #4** included the Department's recommendations for TAP awards.

A MOTION WAS MADE by Vehle and seconded by Rosenboom to approve the TAP awards as recommended by the Department in **HANDOUT #4**. All present voted aye by roll call vote. The motion carried.

Jensen asked for a motion for the Commission to enter into executive session.

A MOTION WAS MADE by Rosenboom and seconded by Simons to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel and reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by roll call vote. The motion carried.

Executive session began at 11:13 a.m. CT.
