Chairman Mike Vehle called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT

Roll call was taken, and a quorum was determined.

Vehle opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapter 3 - 23.

No conflicts of interest were disclosed, and no waivers were requested.

Vehle asked for a motion to approve the December 17, 2020 Commission meeting minutes.

A MOTION WAS MADE by Zander and seconded by Rosenboom to approve the December 17, 2020 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Dustin DeBoer, Office of Legal Counsel, presented to the Commission the consideration of authorization to file grant applications and other documents with the Federal Transit Administration (FTA).

A MOTION WAS MADE by Rosenboom and seconded by Nelson to approve the resolution authorizing the Secretary, Interim Secretary, or their designees, to file grant applications and other grant-related documents with the FTA and execute grant and cooperative agreements with the FTA. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2021 – 1.1 was adopted.

Interim Secretary Joel Jundt presented the Secretary's Report. Jundt provided an update on the current federal funding situation stating that Congress passed a general appropriations bill in December 2020 to authorize funding through September 30, 2021. The level of funding is very similar to the funding received in 2020. This gives the Department of Transportation (the "Department") more conformable budgeting and planning abilities.

Through the recently passed general appropriations bill, the federal government again provided federal funds for the Local Federal Bridge Replacement funds in the amount of approximately \$28.1 million, which is a less than the Department received in 2020. Jundt shared that the Department of Game, Fish & Parks (GFP) has approximately 20 structures that would qualify for the funds. Jundt asked the Commission to consider allowing GFP to participate in the grant process for the structures that meet the requirements.

A MOTION WAS MADE by Nelson and seconded by Zander to allow GFP to apply for and utilize the funds under the Federal Bridge Program for qualifying structures. All present voted aye by roll call vote. The motion carried.

Jundt shared that the COVID-19 Relief bill appropriated federal funding which included \$10 billion for highway infrastructure programs, with South Dakota receiving \$69.956 million of that \$10 billion. These funds will be 100% federal funding and would require no match. Jundt asked the Commission to add a discussion about local government share of funds to the February 25th meeting agenda. The Commission agreed continue the discussion and decide how to allocate these funds at the Commission's February meeting.

Jundt shared with the Commission the current status in the State Legislature in regard to the Department. Pursuant to Senate Bill 1 (SB1), the Department presented the Department's status report to the House Transportation Committee on January 14 and the Senate Transportation Committee on January 15. Jundt shared a traffic volume graph from the presentation that showed the last 12 months of Department revenue based on gas and excise tax. Jundt provided a commendation to the Department staff for their

hard work to keep the Department moving forward and completing projects during the past year once COVID hit. Jundt provided information on the other bills the Department is currently working on.

Jundt indicated that the Department is working on the date for the ribbon cutting ceremony for the Veteran's Parkway project in Sioux Falls, asking the Commissioners to tentatively hold February 15, 2021 on their calendars for the ribbon cutting ceremony.

Vehle opened the floor to nominations for the election of Commission officers.

A MOTION WAS MADE by Rosenboom and seconded by Zander to appoint Larry Nelson as Chairman of the Transportation Commission. There were no further nominations. All present voted aye by roll call vote, with the exception of Nelson who abstained. The motion carried.

A MOTION WAS MADE by Stoick and seconded by Zander to appoint Bruce Cull as Vice Chairman of the Transportation Commission. There were no further nominations. All present voted aye by roll call vote, with the exception of Cull who abstained. The motion carried.

Nelson and Cull will begin their new roles as Chairman and Vice Chairman, respectively, at the February 11, 2021 meeting.

Craig Smith, Division of Operations Director, presented the following Construction Change Orders (CCOs) for the month of December to the Commission.

Construction change orders completed in December contain an increase of approximately \$57,281.

Over the past 12 months, the overall contract increase is 2.41%.

The base course and furnish granular material items resulted from variations in salvage quantities available on the project compared to the plans estimate.

Mike Behm, Director of the Division of Planning and Engineering, presented recommendations to the Commission for their consideration of the Transportation Alternative (TA) program projects.

Vehle asked for public input from any person appearing via the telephone that would like to comment on recommendations. No members of the public offered input on the recommendation.
