Chairman Eric Odenbach called the meeting of the South Dakota Aeronautics Commission (the "Commission") to order at 1:01 p.m. A quorum was determined.

Odenbach opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3 – 23.

No conflicts of interest were disclosed and no waivers were requested.

Lantis joined the meeting at 1:03 p.m.

Odenbach called for a motion to approve the June 25, 2019, Aeronautics Commission meeting minutes.

Odenbach opened the floor for public input. No members of the public addressed the Commission or offered input.

Deputy Secretary Joel Jundt of the Department of Transportation (the "Department") presented the Secretary's Report. Jundt shared that the Title 50 Ad Hoc Committee met on July 15, 2019 and reviewed the entire Title 50. The committee plans to meet again on August 28, 2019, to finish the suggested recommended changes to Title 50. The hope is to present the changes to the Commission at the September Commission meeting before sending out for public input.

Jon Becker of the Office of Air, Rail, and Transit presented the fuel tax funding request at Britton Municipal Airport. The Britton Municipal Airport is requesting to use \$2,136.83 of its fuel tax funds for the purchase of a new brush and pump for the airport's sweeper. The current balance is \$5,587.22. The Department recommends approval of fuel tax funds in the amount of \$2,136.83.

Odenbach introduced Greg Klein to present a request of financial support for Lake Area Technical Institute's ("LATI's") Aviation Program. Funk abstained from the discussion and vote due to possible conflict of interest. Greg Klein and Tony Wegman from LATI appeared by phone to address LATI's request for \$30,000 in state financial assistance.

A MOTION WAS MADE by Odenbach and seconded by Lantis to provide financial support to LATI in the amount of \$30,000 to be used to update its aircraft's C-172 instrument panel with new modern equipment and use any leftover funding from the \$30,000 to update the interior of the plane. LATI would be required to submit an annual report each year for 3 years detailing how the \$30,000 was spent and the use of the aircraft, including number of students served. All present voted aye by roll call vote, except Funk who abstained from the discussion and vote. The motion carried.

Jenny Boehm of the Office of Air, Rail, and Transit discussed with the Commissioners updated sections of the Aeronautics Handbook. The Commission chose to receive hard copies of the updated sections to use to replace their current files rather than an emailed PDF version.

Jundt requested to move the August Commission meeting to Wednesday, August 28, 2019 from Tuesday, August 27, 2019 to coincide with the next Title 50 Ad Hoc Committee meeting. The Commission members agreed to hold the next Commission meeting on August 28, 2019, at 1:00 p.m. CDT.

Commissioner Rolf Johnson questioned the amount of hangar AIP projects and the process for funding for revenue producing hangars regarding the Federal Aviation Administration ("FAA") funding in said projects. Jon Becker provided information on FAA requirements.

Vice-chairman Robert Huggins requested that the August Commission meeting agenda include a discussion about the State Aeronautic Funds balance and its projected outlook.
