Chairman Roby called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CT. A roll call was taken and a quorum was present.

Roby opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

Karla Engle, Office of Legal Counsel, acknowledged the Commission's receipt of three annual conflict of interest disclosures submitted by Commissioners Jaf Karim, Larry Nelson, and Austin Simons, attached to these minutes as **ATTACHMENT A**, **ATTACHMENT B**, and **ATTACHMENT C**. Engle acknowledged that the disclosures and approved minutes will be filed in accordance with law.

In addition, Engle presented a new waiver request for Commission Larry Nelson related to his firm's legal representation of the Rapid City Area School District. A copy of the waiver is included in these minutes as **ATTACHMENT D.**

A MOTION WAS MADE by Vehle and seconded by Rosenboom that the matters disclosed in the written waiver request by Commissioner Nelson are fair, reasonable, and not contrary to public interest. All present voted aye by roll call vote except Nelson, who abstained. The motion carried.

No other members of the Commission disclosed a conflict or requested a waiver.

Roby asked for a motion to approve the June 26, 2025 Commission meeting minutes.

A MOTION WAS MADE by Jensen and seconded by Karim to approve the June 26, 2025 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle, Office of Legal Counsel, announced a public hearing on the Commission's consideration of proposed amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:44 – Lincoln County speed zone rule.

Engle explained the rule adoption process that had been followed to date for the amendments to the rule. Engle noted that state law allows citizens to petition state agencies to initiate rulemaking. Jenny Albers of Sioux Falls submitted a petition on May 15, 2025, requesting the commission lower the speed limit and establish a no passing zone on Highway 11 in Lincoln County between 69th Street and 271st Street, with possible consideration being given to changes further south as well. Engle noted a copy of Ms. Albers' petition, and Secretary Jundt's response granting the petition to initiate rulemaking, were included in the Commission's meeting packet. Engle then explained the effect of the rule changes. The new rule proposed by the Department of Transportation (the "Department") would extend the existing 55 miles per hour speed limit on State Trunk Highway 11 in a southerly direction for .87 mile through Shindler and through the intersection with 270th Street. The proposed rule would also eliminate speed limits for highway segments that are no longer under the jurisdiction and control of the department, specifically the repeal of current Section (2) concerning Highway 44 through Worthing and the amendment of current Section (5) which eliminates a section of Highway 115 that was taken over by the City of Sioux Falls.

Engle reported the purpose of the proposed rule changes is to enhance safety and eliminate provisions that purport to set speed limits on highways that are no longer under the authority of the department.

Engle discussed the speed study results and engineering analysis completed by the department that led to the proposed rule changes. Engle reported the rule changes were supported by the South Dakota Highway Patrol and the Lincoln County Sheriff.

Engle stated the Department received timely written comments on the proposed rule changes from Gary and Joy Griesse, Luke and Jenny Albers, Chris Svanda, Nathan and Celeste Osmanson, Jennifer Raddatz, and Robert Haas, all of whom reside in the vicinity of the affected highway segment. Their comments were included in the Commission packet or as a meeting handout and were posted on the Open SD website. All commenters supported extending the existing speed limit south through Shindler. However,

most commenters (Jenny Albers, Gary and Joy Griesse, Chris Svanda, Jennifer Raddatz, and Robert Haas) asked that the speed limit extend even further south, to include 271st Street (County Road 106). And Gary and Joy Griesse asked that the speed limit be reduced all the way to Highway 18 in Canton. Engle discussed the Department's reasoning for not further extending the speed limit, including differences in the land uses surrounding the highway, reduced crash rates, and concerns about driver compliance.

Roby asked for public testimony in favor of or opposed to the proposed rule amendments. No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Jensen and seconded by Nelson to approve the proposed amendments to ARSD 70:01:02:44 — Lincoln County speed zone rules. Commissioners Frick, Jensen, Nelson, Rosenboom, Vallery, and Roby voted aye and Commissioners Karim and Vehle vote nay by roll call vote. The motion carried.

RESOLUTION #2025 – 7.1 was adopted.

Roby opened the floor to public input.

No members of the public addressed the Commission or offered any input.

Secretary Joel Jundt presented the following items to the Commission in his Secretary's Report:

- Federal: The reconciliation bill passed and the results from a highway funding standpoint was neutral. Although the House Transportation & Infrastructure (T&I) Committee had proposed national registration fees for electric vehicles (\$250 per year), hybrid vehicles (\$100 per year), and all other vehicles (\$20 per year), this language did not carry through in the final bill.
- Federal Annual Appropriations: Congress is also in the processes of formulating the FFY2026 appropriation bill. The House Committee on Appropriations released its draft FFY2026 Transportation, Housing and Urban Development (THUD) appropriations bill and although there were a number of changes, the most significant change would be elimination of the Federal Highway Administration (FHWA) National Electric Vehicle Formula program (NEVI) program. The THUD bill would transfer \$1.0 billion out and into the Federal Aviation Administration (FAA) Facilities & Equipment. The department anticipates the overall final appropriations bills will not be done by September 30, 2025 and is expecting a Continuing Resolution into December 2025.
- Award of a federal grant: The Department received a Better Utilizing Investments to Leverage Development (BUILD) grant program for a US85 Belle Fourche River Bridge Replacement project located in Butte County. The grant is in the amount of \$22,009,000.
- State: The Department received a letter from a private citizen on US85 (Deadwood Box) encouraging consideration of a specific type of design for the installation of the structure. At this point in the design process, no structure type determination has been made. Preliminary discussions have included the consideration of cast in place vs. precast box sections as well as a hybrid of both. Several factors will determine structure type, including final roadway alignment and profile, construction impact to adjacent properties, final hydraulic & hydrology analysis and

- foundation conditions and traffic considerations. The department will inform the individual of receipt of the letter and status of where we are at with the design.
- State Budget: The Department is beginning to formulate its draft budget for Governor Rhoden. Overall, state highway revenues were down from FY2024 by about 1% (\$4.2 million) so we will need to consider this and how it may impact our recommendation to the Governor.
- Standard Specifications for Road and Bridges, Division 1 General Provisions: The Commission is responsible for approving any changes to this division. The provision includes definitions and terms, bidding requirements, award and execution of contracts, scope of work, control of the work, control of material, and numerous other sections. The Department has been working on revising these sections for several years with input by Department employees, contracting industry, and national experts who have helped the Department consider other states' provisions.

Ryan Johnson, Office of Operations Support, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in completed in June contain an increase of \$592,077.95. Over the past 12 months, the overall contract increase is 1.78%.

The following projects have a CCO amounting to a contract change more than \$50,000.

<u>Explanation of Change on CCO No. 1:</u> This increase is the result of SDDOT compensating the contractor for three additional portable changeable message signs needed to warn motorists and detour signing for an over-width detour determined necessary during construction due to lane width availability.

Contractor: D & G Concrete Construction, Inc

Type of Work: interchange reconstruction, structure, PCC surfacing, sidewalk

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of SDDOT compensating the contractor for providing concrete barriers and barrier pins. These are normally state provided but a shortage in supply required the contractor to provide these.

Type of Work: high friction surface treatment

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of SDDOT adjusting contract quantities concrete repair to match as built quantities. Additional repair areas were identified during construction.

5. Project: IM-CR 0291(139)4, Union County, PCN 09E7

Location: I-29 from North Sioux City to north of Exit 26 (Vermillion)

from 3 miles south of Exit 38 (Violin) to 1 mile south of Exit 38 (Violin)

<u>Explanation of Change on CCO No. 1:</u> This decrease is the result of SDDOT removing durable pavement markings and grooving from the contract. The new asphalt shoulders will be chip sealed which could damage the permanent pavement markings. All pavement markings on the project will now be high build waterborne pavement markings.

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of SDDOT paying the contractor for additional material and work to fertilize the grass that was not included in the original contract. A site review of the soil conditions determined fertilization was needed.

10. Project: P 0065(19)164, Corson, Dewey, & Ziebach County, PCN 06L0

Location: SD65 from US212 to the Grand River

Contractor: Lien Transportation Co.

Type of Work: pipe work, erosion control

<u>Explanation of Change on CCO No. 4F:</u> This decrease is the result of SDDOT adjusting the contract quantities to match as built quantities and removing unused items such as flagging and traffic control signs that were not used on the project.

RAPID CITY REGION

11. Project: NH-PH 0385(50)96, Pennington County, PCN 03VD

Location: US385 from 1.5 miles north of US16 east to Pactola Dam & structure over Horse Creek

Contractor: Oftedal Construction, Inc.

Type of Work: grading, interim surfacing, replace structure

<u>Explanation of Change on CCO No. 4:</u> This increase is the result of SDDOT compensating the contractor for additional work. Additional work included installing an approach and service road to access the Forest Service Road, removal and replacement of curb and gutter due to a staking error, installing pavement markings on a detour road, and installing concrete pads for mailbox supports.

The Commission requested that the Department identify the percentage change due to construction change orders as part of this informational item. The Department also suggested that the dollar limit (\$50,000) for including construction changes orders as a Commission item may warrant a change.

Joseph Sestak, Mitchell Region Access Management Engineer, presented for Commission consideration a request to reconstruct an access currently located approximately 316 feet east of the northbound I-90 off ramp at Exit 94 on the south side. The shared access location is in the control of access acquired during the original construction of the interchange with I-29 west of Baltic. Sestak discussed the engineering analysis that supports granting the request to relinquish access control to allow reconstruction of the access approach.

A MOTION WAS MADE by Vallery and seconded by Rosenboom to approve the relinquishment of access control as presented by the Department. All present voted age by roll call vote. The motion carried.

RESOLUTION #2023 – 7.2 was adopted.

Jack Dokken, Program Manager for the Office of Air, Rail and Transit, presented for Commission consideration the request to approve the current recommended scoring procedures for funding public transit with state funds. The procedures include consideration of ridership data from previous federal fiscal year to ensure a fair and performance-based allocation of funds as follows:
