A MOTION WAS MADE by Fouberg and seconded by Rosenboom to approve bid #3. All present voted aye by roll call vote. The motion carried.

Mike Behm, Division Director of Planning and Engineering, presented for Commission consideration an alternate public involvement process for the 2021 – 2024 Statewide Transportation Improvement Program (STIP).

Due to the COVID-19 Global Pandemic, an alternative method of public involvement is being considered for the 2020 public meeting. Knowing that not all individuals will have access to adequate technology, the recommendation was made to offer interactive participation via conference call. Behm described five actions the Department of Transportation (the “Department”) will take:

1. As typical of previous years, the Department will post the tentative STIP along with all other supporting documentation on the Department’s website once approved to do so by the Commission.
2. **New this year**, the Department will post a video recording of the overall Department’s mission and funding presentation from Behm and Program Manager Mark Leiferman as well as a recording of each Region Engineers’ presentations of major projects on the Department’s website in lieu of in-person presentations.
3. As typical of previous years, the Department will advertise through the South Dakota Newspaper Association (SDNA) the availability of the tentative STIP, the request for public input, and the dates and times to participate in the live conference calls for each region. SDNA advertises through local newspaper affiliates throughout South Dakota.
4. **New this year**, the Department will host four separate conference calls, one for each region, to provide the public an opportunity to ask questions and make comments to the Department’s staff in a live setting.
5. As typical of previous years, the Department will request public comments via email or mail to Levi Briggs. This will be an option for everyone but may be most beneficial to those who are not able to participate in a conference call.

A MOTION WAS MADE by Karim and seconded by Stoick to approve the alternate STIP public improvement process as outlined by the Department’s staff. All voted by roll call vote, 7 aye [Cull, Fouberg, Karim, Nelson, Roby, Rosenboom and Stoick] and one nay [Vehle]. The motion carried.

Chairman Vehle shared his thoughts and uncertainty about using the conference call method for the STIP public improvement process and wants to make sure that this does not become the default method for future meetings.

Deputy Secretary Jundt shared with the Commission that the Department is currently working on an external communication plan that will roll out soon and that he’d like to share with the Commission at a future meeting.

Commissioner Nelson recommended reviewing how this process worked at the July or August Commission meeting.
