Vice-chairman Bob Huggins called the meeting of the South Dakota Aeronautics Commission (the "Commission") to order at 2:00 p.m. CT. Roll call was taken. Commissioner Jerry Rieber joined the call at 2:01 p.m. A quorum was determined.

Huggins opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) Chapter 3 - 23.

Commissioner Rieber reminded the Commission of his previously stated conflict of interest with Watertown Regional Airport and will recuse himself for any agenda items regarding Watertown Regional Airport.

No other commissioners disclosed a conflict of interest nor requested a waiver.

Huggins asked for a motion to approve the May 23, 2024 Commission meeting minutes.

A MOTION WAS MADE by Johnson and seconded by Funk to approve the May 23, 2024 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Huggins opened the floor to public comment.

No members of the public addressed the Commission or offered input.

Secretary Jundt presented the Secretary's Report. He shared that the aeronautics trust fund has an approximate \$11 million balance and that the projected revenues received were in line with what was forecasted for the budget year. Jundt noted that the Department of Transportation (the "Department") will come to the Commission in the fall with a projection for funds moving forward for the Commission to discuss future funding practices.

Jundt presented to the Commission the options created by the Department of awarding options of the South Dakota Airport Terminal Funding Applications for the Commission's review.

Huggins asked each of the airports to whom applied to address the Commission to explain more about their project for the Commission to get any additional clarification needed before making decisions about how to allocate the funding at the July 18, 2024 meeting.
