Chairman Don Roby called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT. A roll call was taken and a quorum was present.

Roby opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3-23.

Commissioner Austin Simons disclosed a potential conflict of interest on Item #9 of Attachment #3A. Commissioner Simons has previously disclosed the matters which form the basis for the potential conflict of interest and the Commission has granted a waiver of that potential conflict of interest. Commissioner Simons stated he will recuse himself from the discussion and vote on Item #9 of Attachment #3A.

No other members of the Commission disclosed a conflict or requested a waiver.

Roby asked for a motion to approve the March 13, 2025 Commission meeting minutes.

A MOTION WAS MADE by Karim and seconded by Vehle to approve the March13, 2025 Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Roby opened the floor to public input.

No members of the public addressed the Commission or offered any input.

\*\*\*

Secretary Joel Jundt presented the following items to the Commission in his Secretary's Report:

- Federal: Congress passed a third Continuing Resolution for Federal Fiscal Year (FFY) 2025, resulting in the full year's appropriation. The passage of this bill avoided a federal government shutdown and provides funding for government and its programs for the entire federal fiscal year, through September 30, 2025. It will extend FY 2024 funding and policies for the remaining seven months.
  - o Funding wise, it appears funding the Department of Transportation's formula programs will remain close to FY24 levels. The largest federal funding issue for this Federal Fiscal Year (FFY) is that the Continuing Resolution eliminates all funding that was designated for earmarks. This would impact those tentative Senate-approved earmarks for transportation projects such as the Box Elder Regional Transportation Plan and design, Lake County By-pass in Madison, as well as Sioux Falls Regional Airport and Rapid City Regional Airport terminal projects. It is still unknown whether earmarks will be reinstated for FFY26. Overall, competitive grant programs for next year will likely be reduced to some degree.
  - Any federal discretionary grants are still on hold awaiting further administrative review for those projects.
- State: The legislature approved the Department of Transportation's budget as recommended by the Governor through the final state appropriation bill.
- The ribbon cutting for the new Waldron Bridge was held on Tuesday March 25, 2025 and it went very well. The Department appreciates Commissioner Vallery and Vehle attending. Governor Rhoden's remarks at the event were well-received.
- Mentor Program: The Department has had a formal mentoring program since 2007. The program matches a seasoned employee with a less-experienced employee to help that employee gain skills in numerous different areas. This program is mentee driven, meaning the mentee develops the goals and objectives, and prepares for meeting with the mentor throughout the year. On average we have approximately 30 pairs that are matched up and they work towards the mentee's goals. As part of the program, mentees are often exposed to work and opportunities outside of their regular duties. Today, mentors and mentees are to the Commission meeting.

Craig Smith, Division Director of Operations, presented the following informational Construction Change Orders (CCO) to the Commission.

CCOs completed in January contain an increase of \$56,365.16 and completed in February contain a decrease of \$301,047.91. Over the past 12 months, the overall contract increase is 1.83%.
