Vice-chairman Jerry Rieber called the meeting of the South Dakota Aeronautics Commission (the “Commission”) to order at 2:04 p.m. CDT. Roll call was taken. A quorum was determined.

Rieber opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) Chapter 3 – 23.

No members of the Commission disclosed a conflict or requested a waiver.

Rieber asked for a motion to approve the March 20, 2025 Commission meeting minutes.

Commissioner Bob Huggins asked to add an s to the word “Commissioner” in the last sentence on page 4 of the minutes.

Commissioner Dustin Coleman asked to add an s to correct the name “Sioux Fall” in the fourth motion on page 2 of the minutes.

A MOTION WAS MADE by Huggins and seconded by Funk to approve the March 20, 2025 Commission meeting minutes with the suggested edits from Commissioners Huggins and Coleman. All present voted aye by roll call vote. The motion carried.

Rieber opened the floor to public comment.

No members of the public addressed the Commission or offered input.

Karla Engle, Office of Legal Counsel, requested the Commission set a hearing date of June 12, 2025 to consider amendments to Administrative Rules of South Dakota (ARSD) Chapter 70:02:04 – airport licensing. She briefly explained the rule promulgation process.

A MOTION WAS MADE by Huggins and seconded by Funk to set the administrative hearing date for changes to ARSD Chapter 70:02:04 for the next meeting of the Commission on June 12, 2025. All present voted aye by roll call vote. The motion carried.

Becker noted that the Spearfish application was withdrawn and no action would need to be taken on that application.

A MOTION WAS MADE by Huggins and seconded by Coleman to approval the Brookings IIJA grant application. Huggins, Coleman, and Rieber voted aye by roll call vote and Funk recused himself from the discussion and vote due to a previously disclosed conflict of interest. The motion carried.

A MOTION WAS MADE by Huggins and seconded by Funk to approve all other AIP and IIJA grant applications as presented except the Spearfish application, which was withdrawn. All present voted aye by roll call vote. The motion carried.

Tom Koch and Jon Becker from the Office of Air, Rail and Transit presented to the Commission a request from the Spearfish Airport for state participation to fund weather cameras for the airport. Koch shared the history and process of purchasing weather cameras as well as what surrounding states are currently doing. Becker explain that in 2024, the Commission funded a portion of the weather camera purchase for the Sturgis Airport.

The Commission asked the Department of Transportation (the "Department") to survey pilots and airports and look at weather patterns to create a map of optimal locations across the state for installation of cameras.

A MOTION WAS MADE by Huggins and seconded by Funk to table any action on the Spearfish Airport request until the June 12, 2025 meeting. All present voted aye by roll call vote. The motion carried.

With no further business to come before the Commission, Vice-chairman Rieber adjourned the meeting at 2:42 p.m. CT.
