Chair Zander called the meeting of the Transportation Commission (the "Commission") to order at 9:00 a.m. A count of the Commissioners present determined a quorum.

Zander opened the floor to Commission members to disclose potential conflicts of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapter 3-23.

No conflicts of interest were disclosed, and no waivers were requested.

Zander asked for a motion to approve the minutes of the April 25, 2019, Commission meeting.

A MOTION WAS MADE by Roby and seconded by Vehle to approve the April 25, 2019, Commission meeting minutes. All present voted age by voice vote. The motion carried.

Zander asked for a motion to approve the minutes of the May 8, 2019, Commission meeting.

A MOTION WAS MADE by Rosenboom and seconded by Roby to approve the May 8, 2019, Commission meeting minutes. All present voted aye by voice vote. The motion carried.

Becky Janssen, Office of Legal Counsel, requested that the Commission set a hearing date for consideration of amendments to ARSD 70:01:02:00 (Interstate Highway speed zone rule); 70:01:02:21 (Custer County speed zone rule); and 70:01:02:02 (Pennington County speed zone rule).

FY 2019 Minus \$1,036,000

Steve Johnson, Chief Bridge Engineer for SDDOT, briefed the commission on a new Technical Briefing from Federal Highway Administration relating to new design considerations to protect structures from scour damage.

Doug Kinniburgh, Office of Planning & Engineering Administration for SDDOT, briefed the Commission on the progress made with the Bridge Improvement Grant ("BIG") Program since the program began in 2016.

Kinniburgh continued by asking the Commission with to consider and approve the Bridge Improvement Grant Procedures for this year. He summarized the changes that were made to the procedures for the coming year.

A MOTION WAS MADE by Marquardt and seconded by Roby to approve the BIG procedures effective May 26, 2019. All present voted aye by voice vote. The motion carried.

Kinniburgh also presented the Commission with the *Five-Year County Highway and Bridge Improvement Plan Guide*. He summarized the changes that were made to the procedures for the coming year.

A MOTION WAS MADE by Marquardt and seconded by Vehle to approve the Bridge Five-Year County Highway and Bridge Improvement Plan Guide effective May 26, 2019. All present voted aye by voice vote. The motion carried.

Greg Fuller, Director of Operations, presented the following information regarding Construction Change Orders to the Commission:

Construction change orders approved in March contain an increase of approximately \$1,028,028.

Construction change orders approved in April contain a decrease of approximately \$914,862.

Over the past 12 months, the overall contract increase is 2.23%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

<u>Explanation of Change on CCO No. 2:</u> This decrease is the result of an underrun in the contract quantity of asphalt concrete composite. The Department eliminated the over width detour route resulting in approximately 7000 tons of asphalt not being used on the project.

Location: Various locations in the Watertown area

Contractor: Subsurface, Inc.

Type of Work: Culvert Repair & Lining

<u>Explanation of Change on CCO No. 3:</u> This increase is the result of an overrun in the contract quantity of chemical grout void fill. The quantity of grout required to complete the work was much more than estimated in the plans. Due to the nature of this work, estimating the quantity is challenging and the final quantity is not known until the void filling process is complete.

<u>Explanation of Change on CCO No. 3:</u> This decrease is the result of an adjustment to the contract quantities of base course, asphalt binder, and asphalt for tack. Less material was used to construct the roadway than estimated in the plans. The variations are considered normal variations for this type or work.

<u>Explanation of Change on CCO No. 1:</u> This increase is the result of an adjustment to the contract quantity of concrete repair. Additional repair areas resulted in an increase to the quantity. The variation is considered common for concrete repair work. Additionally, the Department made an incentive payment for the timely completion of the work. The incentive payment was made in accordance with the contract.

<u>Explanation of Change on CCO No. 2:</u> This decrease is the result of the Department adjusting various contract quantities to match the actual quantities used during construction. Larger decreases were made for water for embankment, asphalt binder, and asphalt for tack all due to normal project variations.

Contractor: T&R Contracting, Inc.

Type of Work: Grading, Structure, and PCC Surfacing

Original Contract Amount: \$ 7,794,913.15 Change on CCO No. 4: \$ 342,401.43 Net Change to Date: \$ 405,012.86

<u>Explanation of Change on CCO No. 4:</u> This increase is the result of the Department adjusting various contract quantities to match the actual quantities used during construction. Larger increases were made for base course, gravel cushion, and asphalt concrete all due to normal project variations. In addition, the Department approved additional granular material and MSE fabric throughout the project due to the wetter than normal spring and summer conditions encountered during construction.

VIII. Project: IM 0292(74)62, Lincoln County, PCN 035A

Location: I-29 Exit 62 (Canton) Contractor: T&R Contracting, Inc.

Type of Work: Grading, Structure, and PCC Surfacing

Original Contract Amount: \$ 7,794,913.15 Change on CCO No. 5: \$ 301,310.53 Net Change to Date: \$ 706,323.39

Explanation of Change on CCO No. 5: This increase is the result of the Department adjusting various contract quantities to match the actual quantities used during construction. Larger increases were made for excavation, asphalt concrete, and PCC pavement. The increase in excavation resulted from variations in excavation quantities throughout the project as measured by the final survey. The variation in asphalt concrete resulted from additional temporary asphalt pavement to accommodate traffic during construction. The variation in PCC pavement is the result of a plan error in the left turn fillets. This error was discovered once the roadway was open to traffic and an issue with trucks turning was identified. Additional pavement was placed to accommodate trucks turning. In addition, the Department made an incentive payment for pavement smoothness in accordance with the contract.

<u>Explanation of Change on CCO No. 6F:</u> This decrease is the result of the Department addressing a quantity calculation error for excavation. The Department identified the error during the project quantity and payment final review process.

<u>Explanation of Change on CCO No. 1F:</u> This decrease is the result of the Department adjusting the contract quantities for signs, posts, and object markers to match the quantities installed. These variations are considered normal for this type of work.

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of the Department adjusting the contract quantities for microsurfacing aggregate and emulsion. Additional rutting throughout the project resulted in the need for additional material to fill the rutting.

XII. Project: NH-EM 0083(74)55, Jones County, PCN 036E

Location: US 83 From north of the Mellette/Jones county line north to south of Murdo

Contractor: Zandstra Construction Incorporated

Type of Work: Grading, Structures, and Interim Surfacing

Original Contract Amount: \$ 18,638,962.86 Change on CCO No. 1: \$ 90,965.41 Net Change to Date: \$ 90,965.41

<u>Explanation of Change on CCO No. 1:</u> This increase is the result of the Department changing the type of Right-of-way fencing at one parcel of land in accordance with the landowner agreement with the Department. Additionally, the Department added the requirements and pay item for a Contractor furnished checker to the contract. This item was inadvertently missed in the plans.

XIII. Project: IM-FP 0903(104)153, Jackson County, PCN 03W6

Location: I-90 westbound lanes from Kadoka to Belvidere

Contractor: Reede Construction, Inc.

Type of Work: Remove & Replace PCC Surfacing, Edge Drains, Inslope Flattening, Asphalt Concrete Resurfacing, Pipe Work, and Extend Culvert

Original Contract Amount: \$ 18,706,382.34 Change on CCO No. 3: \$ 221,451.00 Net Change to Date: \$ 269,267.95

<u>Explanation of Change on CCO No. 3:</u> This increase is the result of the Department adding the contract item of salvage and stockpile asphalt mix material to the contract. In the fall of 2018, the Contractor, at the Contractor's expense, placed asphalt concrete on the shoulders to prepare the project for the winter and open the project to traffic. The Department agreed to purchase the salvaged asphalt from the Contractor to be stockpile for future use.

XIV. Project: IM 0904(62)210, Lyman County, PCN 067N

Location: I-90 eastbound and westbound lanes from Exit 212 (US 83) to Exit 226

Contractor: Border States Paving, Inc.

<u>Explanation of Change on CCO No. 1:</u> This decrease is the result of the Department approving a sequence change proposed by the Contractor. The Contractor is opting to complete the work with lane closures in lieu of closing lanes and maintaining 2-lane 2-way traffic in one set of lanes at a time. The Contractor preference for the sequence of operations resulted in several quantity and contract price adjustments resulting in an overall savings to the Department.
