Chairwoman Zander called the meeting of the South Dakota Transportation Commission (the “Commission”) to order at 9:03 a.m. A count of the Commissioners present determined a quorum.

Zander opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 – 23.

No conflicts of interest were disclosed, and no waivers were requested.

Zander asked for a motion to approve the minutes of the February 28, 2019, Commission meeting.

A MOTION WAS MADE by White and seconded by Rosenboom to approve the February 28, 2019, Commission meeting minutes. All present voted aye by voice vote. The motion carried.

\*\*\*\*\*

Karla Engle, Office of Legal Counsel, requested the Commission set an administrative hearing date for April 25, 2019, to consider amendments to ARSD Article 70:06 Transportation Assistance.

A MOTION WAS MADE by Fouberg and seconded by Vehle to set the hearing date as April 25, 2019. All present voted aye by voice vote. The motion carried.

**RESOLUTION #2019 – 3.1 was adopted.**

Engle presented for Commission consideration the proposed amendments to ARSD 70:12 (County highway and bridge improvement) and ARSD Chapter 70:13:01 (Local Bridge improvement grant requirements).

Engle explained the procedural steps that were followed for the proposed rules then proceeded with a discussion of the proposed changes to the rules.

There were no formal written comments received.

No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Rosenboom and seconded by Fouberg to approve the proposed changes to ARSD 70:12 and ARSD Chapter 70:13:01. All present voted by voice vote. There were 6 ayes (Fouberg, Marquardt, Roseboom, Vehle, White, Zander) and 1 nay (Nelson). The motion carried.

**RESOLUTION #2019 – 3.2 was adopted.**

Secretary Bergquist provided an update on the significant weather event that hit the state March 13 – 15, 2019. Due to weather reports in advance of the storm, the Department of Transportation (the "Department") moved and repositioned some of its equipment from the southeast part of the state to the central and western parts of the state in preparation for the weather event. This helped to clean up the roads much quicker than would have been possible otherwise. The southeast part of the state received a fair amount of rain, which led to flooding concerns. The Emergency Operations Center was opened to help coordinate the state's response to the ongoing blizzard and flood conditions. The Department will continue to monitor the run off and flooding concerns as well as continue to monitor several bridges due to the amount of water flowing underneath the bridges.

Mike Behm, Director of Planning and Engineering presented for Commission consideration the subject of an appointment to the Contractor Prequalification Committee. Behm recommended appointing Tony Ondricek, State Operations and Maintenance Engineer for the Department's Office of Operations.

A MOTION WAS MADE by Vehle and seconded by White to appoint Tony Ondricek to the Contractor Prequalification Committee. All present voted aye by voice vote. The motion carried.

Ryan Johnson, Office of Operations, presented the following information regarding Construction Change Orders to the Commission:

Construction change orders approved in February contain an increase of approximately \$400,164.

Over the past 12 months, the overall contract increase is 2.55%.

Over the length of the project minor variations in the depth of base course due to differences in field conditions compared to the plans typical sections resulted in a large change in quantities.

Minor plan errors and variations from the estimate of quantities accounted for the variations to silt fence removal, structural concrete, and pavement markings.

Kinniburgh distributed revised lists of all applications received, which included the scores and the amount of funding requested for both Preservation Applications and Rehabilitation/Replacement Applications. The revised lists included the Department's recommendation for funding. The revised lists were distributed to the Commission members and were made available to members of the public.

A MOTION WAS MADE by Marquardt and seconded by Rosenboom to approve the Department's staff recommendation for award of the 2019 Bridge Improvement Grants for Preservation and Rehabilitation/Replacement and STIP amendment 19-046 to include the grant projects. All present voted aye by voice vote. The motion carried.

Chair Zander opened the floor for public input. No members of the public addressed the Commission or offered input.

Mike Behm, Director of Planning and Engineering offered to provide, as an informational item at a future meeting, the accomplishments of the Bridge Improvement Grant program.
