Chairman Jerry Cope called the meeting of the South Dakota State Railroad Board (the "Board") to order at 1:02 p.m. CDT. A roll call was taken, and a quorum was determined.

\*\*\*\*\*

Cope opened the floor to the Authority members to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) chapters 3 – 23.

Cope acknowledged submission of his annual conflict of interest disclosure, a copy of which was included as Attachment A in the Board's packet. No other conflicts of interest were disclosed, and no waivers were requested.

Cope asked for a motion to approve the August 18, 2021 Authority meeting minutes.

A MOTION WAS MADE by Scharnweber and seconded by Burket to approve the August 18, 2021 Authority meeting minutes. All present voted aye by roll call vote. The motion carried.

Cope opened the floor to public input. No one from the public addressed the Board.

\*\*\*\*\*

Secretary Joel Jundt did not present a Secretary's Report. Jundt acknowledged a request, received from the Friends of Tabor to Platte Rail to Trail organization, to use a portion of the Napa to Platte rail line for a trail. This matter will be given further consideration at the next regular meeting of the Board.

Jundt introduced the presentations of the Consolidated Rail Infrastructure & Safety Improvements (CRISI) and Special Transportation Circumstances (STC) grant applications. Jundt shared a brief description of the process for the 2021 STC grant application. The STC grant application deadline and requirements have not been set yet, but there is an estimated \$6.9 million that is projected to be available for award.

The CRISI notification for funding has been released to the public with a mid-November deadline.

By the Board's September 21 deadline, the Department of Transportation (the "Department") received one application for a CRISI grant and six STC applications.

### The following presentations were made to the Board:

1. **Presenter:** Jerry Vest, RCP&E/G&W

**CRISI Project:** Reconstruction project involves 88 miles of replacement rail with 136lb CWR and the upgrading of 121 bridge structures. Results of the project would allow for a minimum of 25 mph operations over the PRC Subdivision with 286,000 lb. freight car weight limit. This \$22 million grant request will be matched by \$42 million in RCP&E funds and \$20 million in State of South Dakota funds authorized by the state legislature and signed into law by Governor Noem in 2021.

**CRISI Funding Request:** Provide contingent concurrence for a potential CRISI competitive grant submission for the PRC Subdivision project if the Rebuilding American Infrastructure with Sustainability and Equality (RAISE) grant is not awarded.

**STC Project:** After professional hydrology studies were completed in 2020 and early 2021, seven culverts and one bridge structure were identified at significant risk of future heavy storms. Addressing these eight locations is the basis for the project.

**STC Funding Request**: \$1 million estimated total project cost, consisting of \$800,000 (80%) in federal grant and \$200,000 (20%) in RCP&E funding match

2. **Presenter:** Hollie Stalder, Belle Fourche Development Corporation (BFDC)

**Project:** Construct two tracks into the Belle Fourche Industrial & Rail Park to provide service to a new customer and provide service to an area to be used for a laydown yard for the Sanford Lab Long-Baseline Neutrino Facility project in Lead.

**Funding Request:** \$1,710,160.25 estimated total project cost, consisting of \$1,368,128.20 (80%) in federal grant and \$342,032.05 (20%) BFDC funding match

3. Presenters: Scott Van Den Top, D&I Railroad

**Project:** Replace the main line bridge located in rural Akron, IA and replace the auxiliary track bridge simultaneously.

**Funding Request:** \$1,360,000 estimated total project cost, consisting of \$1,088,000 (80%) in federal grant and \$272,000 (20%) D&I match.

4. **Presenter:** Paul Hegg – Encore Park and Dan Kippley – Ellis & Eastern

**Project:** Construct a 5,121 ft. siding along the Ellis & Eastern from MP 50.94 to 51.91, install 6 rail turnouts on the siding, and a 948-foot siding into a new rail service industrial park located on the west edge of Brandon, SD.

**Funding Request:** \$3,020,075 estimated total project cost, consisting of \$2,416,060 (80%) in federal grant and \$604,015 (20%) Encore Park match

5. **Presenter:** Kley Cameron - WATCO

**Project:** Build-out of new railroad infrastructure in Plankinton located on wholly-owned railroad property at MP395 that includes a 558' locomotive shop track and two 1,500' transload tracks. Ancillary project work would include a loadout spur, access roadway for transloading, six turnouts, and a maintenance pit.

**Funding Request:** \$2,998,348.39 estimated total project cost, consisting of \$1,799,009.03 (60%) in federal grant and \$1,199,339.36 (40%) WATCO match..

6. Presenter: Ralph Schmidt, Sisseton Millbank Railroad/ Twin Cities & Western

**Project:** Replace 4 miles of 60 lb. rail with new jointed 115 lb. rail, add 2400 tons of ballast, and surface the track.

**Funding Request:** \$2,161,804.72 estimated total project cost, consisting of \$1,729,443.78 (80%) in federal grant and \$432,360.94 (20%) Sisseton Milbank Railroad match.

No action was taken on the grant request. The grant applications will be considered at the next regular meeting of the Board.
