Chairman Bruce Cull called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CST. A roll call was taken and a quorum was determined.

Cull opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapters 3 – 23.

No conflicts of interest were disclosed and no waivers were requested.

Cull asked for a motion to approve the February 10, 2022 Commission meeting minutes.

A MOTION WAS MADE by Roby and seconded by Rosenboom to approve the February 10, 2022 Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle, Office of Legal Counsel, requested the Commission to set a hearing date of March 24, 2022 to consider amendments to Administrative Rules of South Dakota (ARSD) 70:01:02:26 – Edmunds County speed zone rule.

A MOTION WAS MADE by Jensen and seconded by Karim to set the administrative hearing date for March 24, 2022 . All present voted aye by roll call vote. The motion carried.

#### RESOLUTION #2021 – 2.3 was adopted.

#### \*\*\*\*\*

Secretary Joel Jundt presented the following items in the Secretary's Report.

- Commissioner Benj Stoick resigned from the Commission as of March 1, 2022. The Governor's Office is working on appointment a new commissioner.
- Congress passed another Continuing Resolution (CR) to fund the government through March 11, 2022. The Department of Transportation (the "Department") is hopeful that the Appropriations bill for the Bi-partisan Infrastructure Law (BIL) will be passed prior to the March expiration date.
- When the Appropriations bill does pass, the Department will present to the Commission for consideration an increase to local governments Surface Transportation Block Grant Program (STBGP) funding.
- The Department of Game, Fish, and Parks ("GF&P")will present to the Commission an annual report at the April 28<sup>th</sup> commission meeting, which was a requirement of the Agreement and Memorandum of Understanding (MOU) of 2022 between the Department and GF&P.
- The BIL included the authorization of the National Electric Vehicle Infrastructure (NEVI) Formula Program. Under the NEVI Formula Program, each state is required to submit an Electric Vehicle Infrastructure Deployment Plan (EV Plan) no later than August 1, 2022 to the Joint Office of Energy and Transportation. Jundt shared that the Department is creating an advisory team to develop the EV plan Mike Behm, Division Director of Planning & Engineering, will be heading the advisory team. Behm explained that the Department will present an RFP (request for proposal) in the coming weeks to hire a consultant to assist the Department with the EV plan. He also asked the Commission if any members would be interested in participating in the process. Commissioner Don Roby volunteered.

Craig Smith, Division of Operations Director, presented the following Construction Change Orders (CCO) for the month of January to the Commission.

CCOs approved in January contain an increase of \$359,130.59.

Over the past 12 months, the overall contract increase is 2.75%.

The quantity of in-place surfacing available for salvaging during construction was more than estimated in the plans. This variation resulted in an excess material available at the end of Construction. The Department purchased the unused virgin material supplied by the Contractor for future use.

Explanation of Change on CCO No. 2: This increase is the result of the Department compensating the Contractor for extra work performed to extend asphalt concrete surfacing to the top of the northbound off ramp at Louise Avenue.

Explanation of Change on CCO No. 4: This decrease is the result of the Department adjusting numerous contract quantities. The variations are the result of eliminating edge drains from the project and changing the 4' median shoulder surfacing from asphalt concrete to PCC pavement. The edge drains were eliminated at the request of the Department's Geotechnical Office to help prevent bringing moisture into the subgrade rather than expelling excess moisture. The median shoulder surfacing type was changed at the request of the Department to aid in the maintenance of traffic during the future WBL reconstruction while traffic is maintained on the newly constructed eastbound lanes.

Due to the Contractor's sequence of operation, a portion of the temporary sidewalk was not necessary and eliminated from the contract work. A plan error in reinforcing steel quantities resulted in the decrease to the two reinforcing steel quantities needed for construction.

Doug Kinniburgh, Office of Local Government, presented the 2022 Bridge Improvement Grant (BIG) applications for the Commission's consideration. Kinniburgh provided the Commission and members of the public with a recommended list of 2022 Preservation BIG applications and 2022 Rehabilitation/ Replacement BIG applications. A complete copy of this revised list is attached to these minutes as **ATTACHMENT A.** Recommendations for consideration are based on remaining grant year funding, redistribution of project costs on recently closed projects, and an additional allocation of \$7.5 M from the BIG fund. The total amount made available for annual total of \$24.75 M.

Kinniburgh provided information about the Department's process for considering and scoring each BIG application. The Department presented three recommendations: (1) approval of BIG grants for all preservation projects in the amount shown on **ATTACHMENT A** and add the projects to the STIP by revision. (2) award an additional \$397,800 to Day County to convert the project from preservation work to rehabilitation/replacement work and modify the project as noted in the STIP by revision.; and (3) approval of BIG grants for the remaining twenty-seven projects recommended for award by the Department in the amounts shown on **ATTACHMENT A** and add the projects to the STIP by revision.

A MOTION WAS MADE by Roby and seconded by Rosenboom to award 2022 BIG Preservation grants to the 11 applicants as recommended by the Department on **ATTACHMENT A** and add the projects to the STIP by revision. All present voted aye by roll call vote.

A MOTION WAS MADE by Zander and seconded by Karim to amend agreement #716833 with Day County to award an additional \$397,800 as recommended by the Department on **ATTACHMENT A** and modify the project as noted in the STIP by revision. All present voted aye by roll call vote. The motion carried.

A MOTION WAS MADE by Rosenboom and seconded by Roby to award 2022 BIG Rehabilitation or Replacement grants to the remaining 27 projects recommended for award by the Department in the amounts shown on **ATTACHMENT A** and add the projects to the STIP by revision. All present voted aye by roll call vote. The motion carried.
