Vice-chair Vehle called the meeting of the Transportation Commission (the "Commission") to order at 9:00 a.m. Roll call was taken, and a quorum was determined.

Karla Engle, Office of Legal Counsel, provided annual disclosure information to the Board and reminded Board members to submit their annual disclosures before the July meeting for Board consideration.

Vehle opened the floor to Commission members to disclose potential conflict of interest and to present requests for waivers pursuant to South Dakota Codified Law (SDCL) chapters 3 - 23.

No conflicts of interest were disclosed, and no waivers were required.

Vehle asked for a motion to approve the minutes of the June 13, 2019, Commission meeting.

A MOTION WAS MADE by White and seconded by Fouberg to approve the June 13, 2019, Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Engle presented for Commission consideration proposed amendments to ARSD 70:01:02:00 – Interstate Highway Speed Zone Rule; ARSD 70:01:02:02 – Pennington County Speed Zone Rule; and ARSD 70:01:02:21 – Custer County Speed Zone Rule.

Engle explained the procedural steps that were followed for the proposed rules then proceeded with a discussion of the proposed changes to the rules.

There were no written comments received.

No members of the public offered testimony in support of or in opposition to the rule changes.

A MOTION WAS MADE by Fouberg and seconded by White to approve the changes to ARSD 70:01:02:00 – Interstate Highway Speed Zone Rule; ARSD 70:01:02:02 – Pennington County Speed Zone Rule; and ARSD 70:01:02:21 – Custer County Speed Zone Rule. All present voted aye by roll call vote. The motion carried.

#### **RESOLUTION #2019 – 6.1 was adopted.**

Secretary Bergquist presented the Secretary's Report. Bergquist shared that Ron Baumgart will be inducted into the Transportation Hall of Honor. Baumgart is the Executive Director of River Cities Public Transit. An award banquet will be held at a later date.

Vehle asked Bergquist about an update on the State's federal funding. No update was available.

\*\*\*\*\*\*

Tammy Williams, Office of Administration, Local Government Program, provided the Commission with an update on the local government flood response. Williams stated there have been two events (March 13-16 and May 21- 22) that received statewide emergency declarations made by Governor Noem. The first event has received a presidential declaration. Williams shared the funding eligibility procedures and requirements for federal funding assistance programs and progress made for both events.

Williams also shared that the Department of Transportation (the "Department") has had requests from several counties to do special bridge inspections statewide on 261 bridges. Highwaters are delaying inspections. Of the inspections that are done, twelve bridges have been closed and three bridges have been routed down to one lane. The Department suspects that there is more damage and will continue inspections.

Greg Fuller, Director of Operations, presented the following information regarding Construction Change Orders to the Commission:

Construction change orders approved in May contain an increase of approximately \$120,972.

Over the past 12 months, the overall contract increase is 3.28%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

Explanation of Change on CCO No. 3: This decrease is the result of an underrun in the contract quantities of controlled density fill, rip rap, and floating silt curtain. The fill material and rip rap varied from the plan estimate due to normal deviations. The floating silt curtain was not used on the project due to a change made on construction and the Contractor using a diversion pipe in lieu of the silt curtain.

The additional cost is due to labor of placing the material. The Department made the change due to limited time available for state maintenance forces to perform the patching. The repairs were in need of completion prior to work commencing on a separate contract along the route.

The Department along with FHWA are letting 3 projects in 2019 and adding this requirement to 2 projects in 2019 to obtain data and experience with this equipment for future specification and construction practices development. The equipment is designed to give the roller operator a better idea of where additional passes are necessary and the temperature of the asphalt mat all in an effort to increase overall density and therefor longer lasting pavements.

Mike Behm, Director of Planning & Engineering, presented for Commission consideration the public release of the Statewide Transportation Improvement Program (STIP) and Public Transportation Improvement Program.

Deputy Secretary Joel Jundt presented for Commission consideration of State matching funds for rural public transit subrecipients. Jundt shared the 3-year plan of the new fund allocations based Administrative Rule 70:06:02:02 that was changed by the Commission on April 25, 2019. The goal is to phase out the formula-based system and move to a performance-based system.

A MOTION WAS MADE by Rosenboom and seconded by Fouberg to use the public transit State match funding scoring procedures as documented in Attachment #7 (see below) effective July 1, 2019. All present voted aye by roll call vote. The motion carried.

# Attachment #7 Public Transit – State Matching Funds

As per Administrative Rule 70:06:02:02, the Department will award state matching funds for rural public transit subrecipients "based on factors including number of passenger trips provided, vehicle miles driven, transit administration expenses, operating expenses, grant administration performance, and level of local funding. At least annually, the department shall obtain commission approval of objective scoring procedures for determining grant awards pursuant to this subsection."

Accordingly, the Department is recommending the following scoring procedures be used. The goal for the past number of years has been to phase out the formula-based system and move to a performance-based system. The data used for scoring performance would be based on the previous federal fiscal year's data.

For FY2020, funds distributed based on the following percent allocation:

Current Formula Base: 34.44%

Performance Base: 65.56% with the following subcategory breakdown:

Number of Rides provided: 25% Number of Miles driven: 25% Local Funds Expended for Overall program: 20% Administrative Cost Expended per Ride:5% Operating Costs Expended per Ride: 5% Local Funds Expended per Ride 5% Overall Grant Administration Performance:15%

For FY2021, funds will be distributed based on the following percent allocation: Current Formula Base: 17.22%

Performance Base: 82.78% with the following subcategory breakdown:

Number of Rides provided: 25% Number of Miles driven: 25% Local Funds Expended for Overall program: 20% Administrative Cost Expended per Ride:5% Operating Costs Expended per Ride: 5% Local Funds Expended per Ride 5% Overall Grant Administration Performance:15%

For FY2022 and thereafter, funds will be distributed based on the following performance-based allocation:
