Dear Mr. Behm:

The following items are recommended for Commission consideration:

1. Request Transportation Commission approval to abandon by resolution the following permanent easement acquired in 1972 from the SDGFP for a Roadside Park:

Beginning at the Northeast Corner of Section 1, Township 101 North, Range 48 West of the 5th P.M., thence south along the section line a distance of 200 feet, thence West a distance of 450 feet, thence north a distance of 200 feet, thence east along the section line a distance of 450 feet to place of beginning, Minnehaha County, South Dakota, containing 2.07 acres.

The above permanent easement is no longer needed for Roadside Park purposes and abandonment is recommended by Mitchell Region DOT and Sioux Falls Area DOT.

2. Request Transportation Commission approval to grant a 20-foot-wide underground fiber optic line permanent easement to Clarity Telecom LLC of Rapid City, South Dakota upon the following DOT property:

Lot 9 in the SE1/4 NE1/4 of Section 15, Township 3 North, Range 6 East of the B.H.M., Meade County, South Dakota.

Lot 9 is located near Exit 46 on the east side of Interstate 90. Granting the easement as shown on Exhibit A will allow an underground fiber optic line to be placed at a depth of four feet or greater within the same easement location granted to Black Hills Energy as approved at the November 9, 2023 Commission meeting.


Clarity Telecom LLC accepts liability and financial responsibility for the underground fiber optic line. All State and Federal guidelines will be followed during the construction.

- 6. Request Transportation Commission approval to abandon by resolution the temporary easements on Kingsbury County Project P 0081(104)112, PCN 044G.






