Dear Mr. Behm:

The following items are recommended for Commission consideration:

1. Request Transportation Commission approval to abandon by resolution the following properties acquired for highway right-of-way:

Lot AB2 in Lot H-1 in the SE1/4 of Section 21, Township 115 North, Range 47 West of the 5th P.M., Deuel County, South Dakota.

Said Lot AB2 contains 9.04 acres.

This property is no longer needed for highway purposes and abandonment is recommended by DOT Watertown Area. (See attachment.)

2. Request Transportation Commission approval to abandon by resolution the following properties acquired for highway right-of-way:

Lot A in the existing SD 34 right-of-way, located adjacent to Lot 1 of Block 8 in the original town of St. Onge, Lawrence County, South Dakota.

Said Lot A contains 0.10 acre.

The proposed abandonment lot is located along Hwy 34 in St. Onge. The above property is no longer needed for highway purposes and abandonment is recommended by DOT Belle Fourche Area. (See attachment.)

3. Request Transportation Commission approval to abandon by resolution the following properties acquired for highway right-of-way:

Lot A of Lot H2 and H3 of Government Lot 13 and Lot H4 of Government Lot 19 of Section 11, and Lot B of Lot H2, H3, and H4 of Government Lot 3 and Lot H4, H5, and H6 of Government Lot 11 of Section 14. All located in Sections 11 and 14, Township 5 North, Range 3 East of the B.H.M., City of Deadwood, Lawrence County, South Dakota.

Said Lot A contains 3.306 acres; Said Lot B contains 2.942 acres.

The proposed abandonment of Lots A and B are located along Hwy 85 one mile north of Deadwood. The above property is no longer needed for highway purposes and abandonment is recommended by DOT Rapid City Area. (See attachment.)

4. Request Transportation Commission approval to vacate by resolution the following plat:

Parcel 29: Lot H1 in Lot 1 in Block 7 of Gesley's Addition and Lot H1 in Lot 1, Lot H1 in Lot 2, Lot H1 in Lot 3, Lot H1 in Lot 4 all in Block 10 of Gesley's Second Addition to Watertown, Codington County, South Dakota. (Plat was recorded August 9, 2021 in Book of Plats OP on Page 916)

The above plat was recorded but not used as part of DOT project NH 0212(174)377, PCN 027D construction. The Watertown Area DOT requests the plat be vacated. (See attachment)

5. Abandonment – Beadle County

Request Transportation Commission approval to abandon by resolution the temporary easements on Beadle County Project NH-PH 0037(88)125, PCN 00XA.

6. Abandonment – Bon Homme County, Charles Mix County, and Yankton County

Request Transportation Commission approval to abandon by resolution the temporary easements on Bon Homme County, Charles Mix County, and Yankton County DOT Project NH-P 0023(37), PCN 041Q. This project spanned three counties. A separate resolution for each county will be provided to their respective County Register of Deeds if the Transportation Commission approves this abandonment of the temporary easements.


7. Abandonment – Hutchinson County and Turner County

Request Transportation Commission approval to abandon by resolution the temporary easement on Minnehaha County DOT Project P 0011(00)81, PCN 03KD.



Deuel County Proposed Abandonment







