REV 19-SC-030 This Revision increased the cost estimate on a Temporary Traffic Signal project on

US14B / 22nd St in Brookings in the Watertown Area.

US18 from east of Vetal to the Bennett/Todd County line in the Winner Area.

REV 19-SC-035
