The following items are recommended for Commission consideration:

1. Transfer – Minnehaha County

Request Transportation Commission approval to transfer by resolution to city of Sioux Falls the following property acquired for highway right-of-way:

A portion of Veterans Parkway from 57th Street to Rice Street in Sioux Falls, Minnehaha County, South Dakota, legally described as follows:

Parcel 5 – Lots H3 and H4 in the E1/2 NE1/4 of Section 24, Township 101 North, Range 49 West of the 5th P.M., lying South and West of Lot H2, Minnehaha County, South Dakota. Said Lot H3 contains 1.22 acres (52944 sq. ft.), more or less. Said Lot H4 contains 0.01 acre (305 sq. ft.), more or less. Warranty Deed – Book 515 of Deeds, Page 682. Quit Claim Deed – Fee Title – Book 516 of Deeds, Page 390. Plat – Book of Plats 69, Page 166.

This resolution will transfer a portion of Veterans Parkway towards completing the Memorandum of Understanding between the City of Sioux Falls and Department of Transportation. The highway right of way described above would be transferred to the city of Sioux Falls and the city of Sioux Falls would accept ownership, jurisdiction, operational and maintenance responsibilities of the above described right-of-way.

Sioux Falls Area DOT recommends the transfer. (See attachments)

This resolution will abandon the temporary easements on Perkins County Project P 0042(53), PCN 042F.

9. Abandonment – Roberts County

This resolution will abandon the temporary easements on Roberts County Project P 0010(91)358, PCN 028U.

10. Condemnation - Project NH 0018(193)252, PCN 04FD, Tripp County

Request Transportation Commission resolution determining that the taking and damaging of real property interests in and to the following property is necessary for a public purpose and authorizing condemnation:


Parcels 13 and 13A – Lantern Development, LLC; Mortgage Holder – First Dakota National Bank




PLAT OF LOT H1 IN LOT A AND LOT H1 IN C & NW TRANSPORTATION COMPANY TRACT 3




Parcel 13A
