Dear Mr. Behm:

The following items are recommended for Commission consideration:

1. Request Transportation Commission approval to abandon by resolution the following permanent easement:

Lot 6 in Block 1 of First Ashland Park Addition to Huron, Beadle County, South Dakota. As recorded on March 1, 2018 as document number 109095, in Beadle County, South Dakota. (Parcel 5A)

The above permanent easement for a Beadle County Project P 0037(128)125, PCN 0271, Highway traffic sign/signal light will be relocated to Lot 7 in Block 1 of First Ashland Park Addition to Huron (Parcel 4B). The Huron Area DOT has deemed the Parcel 5A permanent easement no longer necessary for use in construction or maintenance of highways or for highway purposes. (See attachment).

2. Abandonment - Pennington County:

Request Transportation Commission approval to abandon by resolution the following property acquired for highway right-of-way:

Lot A in a portion of Lot H-2 of Lots 17, 18, 19 and 20 and a portion of Lot H-3 of Lots 21, 22, 23 and 24 in Block 1 of Green Acres Addition to the City of Rapid City, Pennington County, South Dakota, containing 0.12 acre.

Lot A1 in a portion of Lot H-1 of Lots 10, 11, 12, 13, 14, 15 and 16 and a portion of Lot H-2 of Lot 9 and a portion of the north half vacated alley in Block 2 of Green Acres Addition to the City of Rapid City, Pennington County, South Dakota, containing 0.16 acre. Lot A in a portion of Lot H-3 of Lots 3, 4, 5 and 6 in Block 2 of Green Acres Addition to the City of Rapid City and vacation of a portion of W. Chicago Street, Pennington County, South Dakota, containing 0.14 acre.

Lot A1 in a portion of Lot H-1 of Lots 11, 12, 13, 14, 15 and 16 and a portion of Lot H-2 of Lots 9 and 10 and vacation of a portion of 16' wide alley in Block 1 of Green Acres Addition to the City of Rapid City, Pennington County, South Dakota, containing 0.08 acre.

The above property is no longer needed for highway purposes and abandonment is recommended by DOT Rapid City Region and Area. (see attachments)

3. Abandonment - Pennington County:

Request Transportation Commission approval to abandon by resolution the following property acquired for highway right-of-way:

Lot A in Lot H1 in the NE1/4 SW1/4 of Section 9, Township 1 South, Range 7 East of the B.H.M., Pennington County, South Dakota. (contains 0.96 acre)

The above property is no longer needed for highway purposes and abandonment is recommended by DOT Rapid City Area. (see attachments)

4. Condemnation - Project IM 0293(106)76, PCN 03RA, Minnehaha County

Request Transportation Commission resolution determining that the taking and damaging of real property interests in and to the following property is necessary for a public purpose and authorizing condemnation:

Parcel 37 – Charles J. Gustafson and Heather S. Gustafson Parcel 37A – Charles J. Gustafson

To date, the Department of Transportation has been unable to acquire the real property interests through negotiations for the project IM 0293(106)76, Minnehaha County, PCN 03RA, I29 - Exit 77 (41st Street Interchange) in Sioux Falls Structure # 50-173-235, 50-175-230, Interchange Modification, Bent Strengthening. 5. Condemnation - Project P 0020(160)411, PCN 04FR, Harding County

Request Transportation Commission resolution determining that the taking and damaging of real property interests in and to the following property is necessary for a public purpose and authorizing condemnation:





Proposed Abandonment - Parcel 5A - Huron









Alley Boundaries

Proposed Abandonment













Proposed Abandonments - HWY 231 - Rapid City






Proposed Abandonment - Lot A - Pennington County
