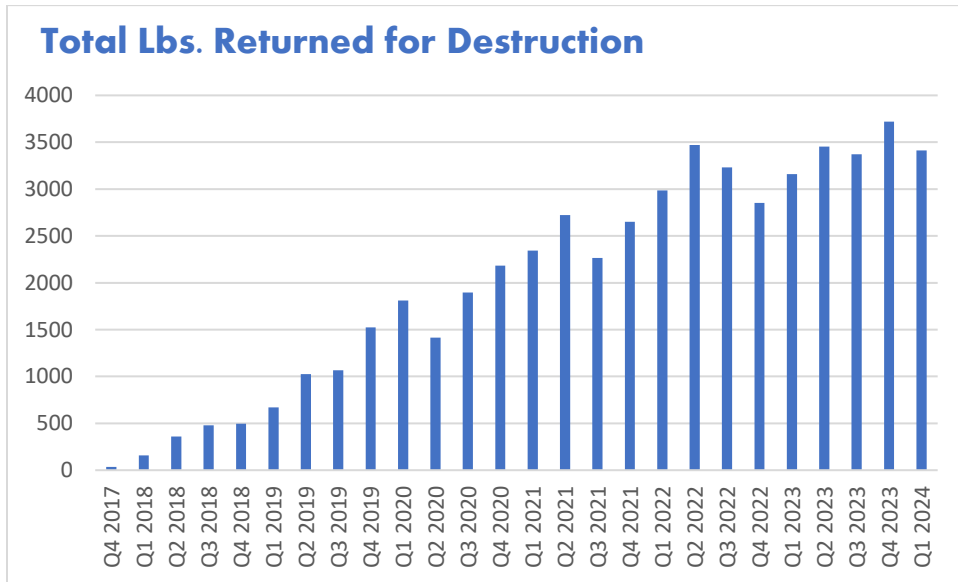

 - One site no longer participating due to pharmacy closure; working to place this receptacle in a new site



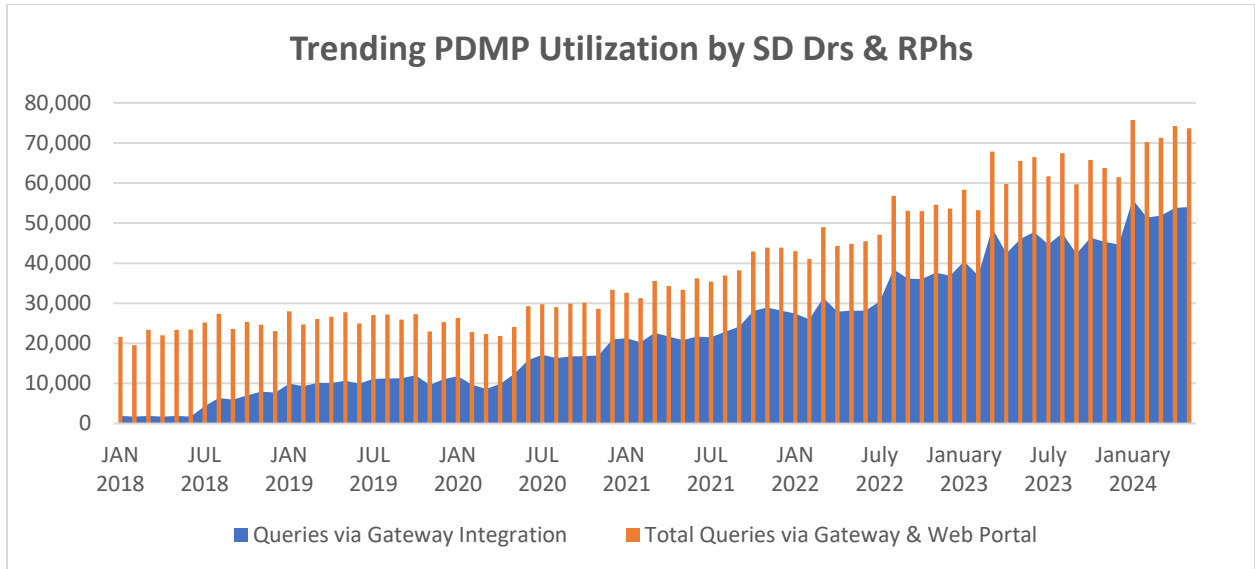

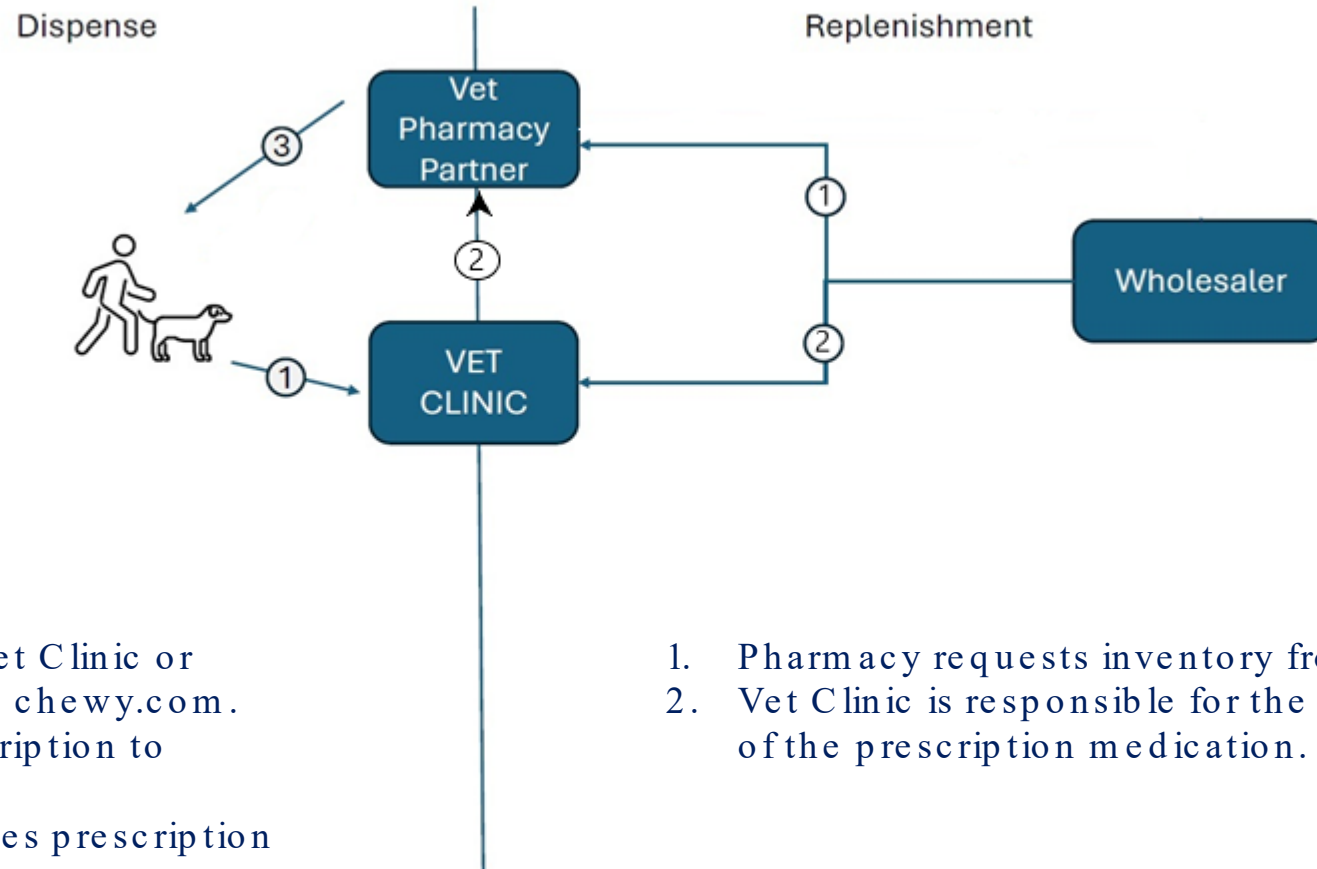

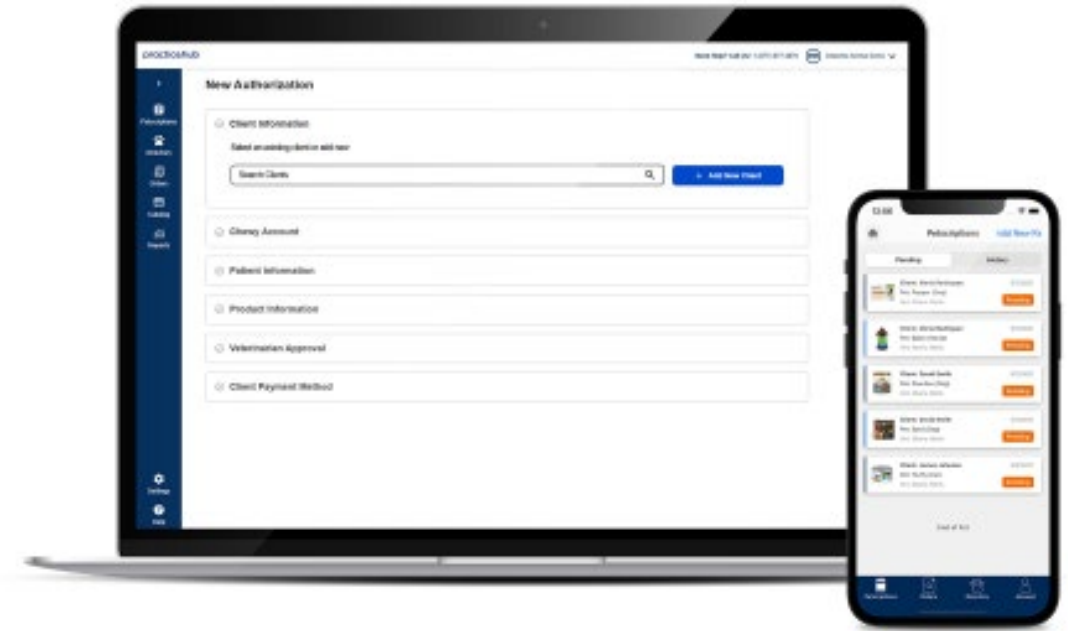
