### **BACKGROUND**

- DOE proposed to eliminate School Psychological Examiner endorsement at the April 2022 Board meeting
- School Psychological Examiner is referenced in:
  - 24:28 Educator Certification
  - 24:53 Educator Preparation
  - 24:05 Special Education
- Board didn't take action at the April meeting and requested DOE form a workgroup to address:
  - Impact of eliminating the endorsement in consideration of shortages of School Psychologists
  - Impact to those currently endorsed and practicing as School Psychological Examiners
  - Scope of practice
  - Coursework requirements options and preparation

# **WORKGROUP COMPOSITION**

- Workgroup composition included:
  - 4 practicing school psychologists
  - I mentoring school psychologist
  - 2 school psychological examiners
  - School Administrators of South Dakota
  - University School Psychology Preparation Program Faculty
  - 3 District/Coop Special Education Directors/Supervisors
  - DOE Special Education, Certification and Legal Office representatives

# WORKGROUP RECOMMENDATIONS

- Retain School Psychological Examiner Endorsement
  - Revise DOE defined coursework (those currently endorsed would be grandfathered in)
  - Develop Scope of Practice guidance
- Continue to work on expanding School Psychologist preparation, recruitment and retention
- Investigate ways to make coursework accessible virtually or without being enrolled in a specific university program to obtain School Psychological Examiner endorsement

### DOE DEFINED COURSEWORK

- Retain:
  - Master's Degree with concentration of coursework psychological in nature
  - 30 transcripted credits (must be earned within last 10 years per certification requirements)
  - Assessment reports must be signed by a SD certified school psychologist

### DOE DEFINED COURSEWORK

#### New Coursework Requirements

- 5 required courses at graduate level of at least 3 transcripted credits each:
  - Assessment of intelligence (must include actual test administration)
  - Practicum in individual psychological evaluation
  - (New area) Personality and behavior assessment
  - Child/Adolescent psychology
  - (New area) Behavioral collaboration and intervention

#### Previous Requirements

- Course in each of the following:
  - Individual psychological evaluation
  - Practicum in individual psychological evaluation
  - Group testing
  - The child with disabilities
  - Educational statistics

# DOE DEFINED COURSEWORK (CONT.)

#### New Coursework Requirements

- 5 required courses at undergraduate or graduate level:
  - Developmental psychology
  - Abnormal psychology
  - Disabilities in education
  - Educational assessment
  - Instructional strategies and intervention

#### Previous Requirements

- Sixteen credits in five or more of the following areas:
  - Child, adolescent, developmental psychology
  - General psychology
  - Abnormal psychology
  - Educational psychology
  - Principles and practices of guidance programs
  - Elementary guidance
  - Counseling methods or techniques

# DOE DEFINED COURSEWORK (CONT.)

#### **New Coursework Requirements**

- Non-required courses at undergraduate or graduate level that can be applied to remaining credit requirements:
  - Educational psychology
  - Principles and practices of guidance programs
  - · Elementary guidance
  - Counseling methods or techniques
  - Educational statistics

#### Previous Requirements (same as previous slide)

- Sixteen credits in five or more of the following areas:
  - Child, adolescent, developmental psychology
  - General psychology
  - Abnormal psychology
  - Educational psychology
  - Principles and practices of guidance programs
  - Elementary guidance
  - Counseling methods or techniques

### **ROLES AND RESPONSIBILITIES**

- DOE guidance School Psychological Examiner Roles and Responsibilities:
  - Responsibilities within the scope of practice
  - Responsibilities outside the scope of practice (unless other qualified through other degrees, certification or training)
  - Responsibilities of the SD certified school psychologist signing reports
  - Responsibilities of the hiring entity

- DOE Special Education accountability reviews will include a review of district/coop policy and practice if they employ a school psychological examiner
- Continue to explore opportunities to address shortages
