Minutes of the Meeting Wednesday, August 20, 2025 10:00 A.M. (CT)

### Call to Order and Roll Call

Chairman Engel called the meeting to order at 10:02 a.m., roll was taken, and a quorum was present.

Chairman Engel asked if any Commissioners had a conflict of interest related to any matter under consideration during the meeting. Commissioner Pat Miller disclosed her affiliation with the Trail of Governors Foundation as a member.

## Approval of the Agenda

Commissioner Gilbertson moved to approve agenda as presented, seconded by Mayor Harding. The motion carried unanimously.

## **Approval of the Minutes**

Commissioner Bachand moved to approve the draft minutes from the April 16, 2025, meeting as presented, seconded by Commissioner Miller. The motion carried unanimously.

## **Introduce New Members**

Chairman Engel announced Senator Chris Karr (absent) has replaced Senator Helene Duhamel as a member of the Commission and introduced Val Simpson who replaced Peggy Stout. Commissioner Simpson briefly introduced herself to the Commission.

## **GFP Youth Urban Fishing Program**

Leah Haugan introduced Secretary Kevin Robling to present an Urban Youth Fishing Program sponsored by SD Game, Fish, & Parks (GFP) which would allow folks with a valid South Dakota Fishing Permit along with their minor children to fish in Capitol Lake at designated locations. The purpose of this program is to encourage the younger generation to spend time outdoors and to promote fishing. Commissioner Gilbertson moved to approve the proposed Urban Youth Fishing Program as presented, seconded by Mayor Harding. The motion carried unanimously.

## **Governor Noem Statue Location, Trail of Governors**

Leah Haugan introduced Rick Jensen, President of the Trail of Governors Foundation to propose a location for Governor Noem's bronze statue on the State Capitol Complex at the Church Street entrance to Hilger's Gulch. The statue will be unveiled in June of 2026. Commissioner Gill moved to approve the location as proposed, seconded by Mayor Harding. The motion passed unanimously.
