## SOUTH DAKOTA STATE RAILROAD BOARD MEETING MINUTES

Chairman Jeff Burket called the meeting of the South Dakota State Railroad Board (the "Board") to order at 11:01 a.m. CT. A roll call was taken, and a quorum was determined.

Burket opened the floor to the Board members to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) chapter 3 – 23.

Karla Engle, Chief Legal Counsel, acknowledged the Board's receipt of an annual conflict of interest disclosures submitted by Jack Nelson attached to these minutes as **ATTACHMENT A**. The disclosures will be filed as required by law.

No other conflicts of interest were disclosed, and no waivers were requested.

Burket asked for a motion to approve the July 16,2025 Board meeting minutes.

Board member Scott Lockwood noted a typo on page 2 of the minute. The typo was the time the Board entered into Executive Session; it should read 11:07 a.m., not 10:07 a.m.

A MOTION WAS MADE by Carmon and seconded by Nelson to approve the July 16, 2025 Board meeting minutes with the noted edit. All present voted aye by roll call vote. The motion carried.

Burket opened the floor to public input.

Dan Bilka, All Aboard, addressed the Board. Bilka shared that he had met with the U.S. Department of Transportation last month and that the Federal Railroad Administration (FRA) would be willing to present to the Board the Long-Distance Service Study on passenger rail.

Secretary Joel Jundt shared that the Board would need to take action at a future meeting if it desired to hear a presentation. In addition, the Secretary noted that the item would be put on a future agenda once additional logistical details were gained from the FRA.

No other members of the public addressed the Board nor offered input.

Burket asked for a motion for the Board to enter into executive session.

A MOTION WAS MADE by Nelson and seconded by Carmon to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel and reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by voice vote. The motion carried.

Executive session began at 11:07 a.m. CT

Executive session ended at 11:34 a.m. CT.

Karla Engle, Office of Legal Counsel, addressed the Board. She explained that a new law requires the Board to annually acknowledge review of materials provided by the Attorney General concerning open meetings laws. Engle pointed out that the updated 2025 Open Meeting brochure authored by the Attorney General had been provided to the Board as an updated Attachment #2 for the Board's review.

All present acknowledged reviewing these open meeting materials by roll call.

Secretary Jundt presented to the Board the following items in his Secretary's Report:

- **Federal:** September 16, 2025 the House Appropriations Committee released the Continuing Appropriations and Extensions Act, 2026. The bill would keep the government open and ensure service to the American people. The House is expected to consider the bill on the House floor this week. The Senate bill(s) have not advanced to the same level as of yet.
- Grant Update: Still no news on the anticipated release date for the Notice of Funding
  Opportunity (NOFO) for the Consolidated Rail Infrastructure and Safety Improvement (CRISI)
  grants or the Special Transportation Circumstance (STC) grants. In FY2024, the CRISI NOFO was
  published in March 2024 with awards occurring in October 2024. We are still hopeful FRA will
  publish the NOFO's still yet this year.
- Napa to Platte Rail Line: Dakota Southern Railroad Company did file the necessary documents
  on with the Surface Transportation Board (STB) for intent to terminate their modified certificate
  for the Napa Junction to Tyndall section of the Napa-Platte line. This 60-day notice was
  submitted to the STB on August 7, 2025. The Department of Transportation (the "Department")
  has also gone out for quotes for vegetation control and tree trimming and those quotes are due
  today. The Department will be reviewing those quotes and making a determination on next
  steps.

Jundt presented for Board consideration the future lease or sale of the Napa to Platte rail line. He briefed the Board on the importance of securing a new operator to protect this corridor for freight rail service. He explained that the Department thinks the best way to secure an operator who can fulfill this need is to solicit proposals from rail operators via an Invitation for Proposals (IFP) to either purchase the line or enter into a lease. Such was similarly done in FY2020. The Department would use that document as the template to be modified for purposes of selling or leasing the Napa to Platte Rail Line. The process would also be similar: the proposers would come before the Board to present their proposal, the Board would be able to inquire, and, ultimately, the Board would decide on a course of action. If the Board was to select one of the proposals for future negotions, the Department would pursue negotiations.

The Board members discussed the topic and vocalized their preference for selling the line or at least finding a long-term lessee.

A MOTION WAS MADE by Nelson and seconded by Carmon to authorize the South Dakota Department of Transportation to prepare and issue an invitation for proposals to purchase the state-owned Napa to Platte railroad or lease the Napa to Tyndall segment of that line. A primary purpose of the IFP shall be to reflect the primary purpose of fostering, developing, and protecting freight rail service. All present voted aye by roll call vote. The motion carried.

\*\*\*\*

Jack Dokken, Program Manager of the Office of Air, Rail & Transit, presented the Board with updates on the current open grants—STC, CRISI, and RAISE. He described the status of each project and their projected completion dates.

With no further business to come before the Board, Burket declared the meeting adjourned at 12:06 p.m. CT.
