Chairman Mike Vehle called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:00 a.m. CDT

Roll call was taken, and a quorum was determined.

Vehle opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) chapter 3 – 23.

Vehle presented an annual conflict of interest disclosure and a request for waiver received from Vice-chairman Nelson concerning potential conflicts of interest. Nelson's prior disclosure was dated July 16, 2019. A copy of the annual conflict of interest disclosure and request for waiver are attached to and incorporated into these minutes as **Attachment A**. Nelson's law firm was hired to represent the Sioux Falls School District 49-5 and provide lobbying services. Nelson's law firm was also retained as Legal Counsel for the Disciplinary Board of South Dakota and provide lobbying services.

A MOTION WAS MADE by Zander and seconded by Fouberg that the matters disclosed in the annual disclosure and waiver request are fair, reasonable, and not contrary to public interest. All present voted aye by roll call vote, except Nelson who abstained. The motion carried

Vehle presented the annual conflict of interest disclosures received from Commissioners Karim and Fouberg, which were previously submitted to the Commission. Karim's prior disclosure was dated November 25, 2019. Fouberg's prior disclosure was dated June 28, 2019. The Commission acknowledged receipt of Karim and Fouberg's annual disclosures of potential conflict of interest, which will be filed with the required state agencies. Copies of the written annual disclosures are attached to and incorporated in these minutes as **Attachments B and C**.

Vehle asked for a motion to approve the July 23, 2020, Commission meeting minutes.

A MOTION WAS MADE by Fouberg and seconded by Roby to approve the June 23, 2020, Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

Karla Engle, Office of Legal Counsel, presented for Commission consideration the proposed amendments to Administrative Rules of South Dakota (ARSD) 70:07 – Highway construction contracts. Engle explained the rule adoption process that had been followed and the purpose and effect of the rule changes.

Engle reported that no written comments were received on the proposed rule changes.

Engle requested that ARSD 70:07:02:08 be amended to incorporate throughout the rule those style and form changes to parenthetical material that had been recommended by Legislative Research Council (LRC). Through inadvertence, the recommended change by LRC had not been incorporated throughout the rule that was included in the Commission's packet. Engle also drew the Commission's attention to ARSD 70:07:04:12 — Duration of Debarment. Engle explained that the Department had proposed changes to this rule and that LRC had made recommended style and form edits. Engle discussed the edits with Interim Code Counsel for LRC and is proposing adoption of language that is slightly different than LRC's written style and form edits. Engle believes the language is an improvement over the current rule and achieves the clarity LRC desires. As a procedural matter, if the Commission adopts the newly proposed language, then the Department will need to appeal to the Rules Review Committee for approval of the language, since the new language does not exactly mirror the written style and form edits from LRC.

A MOTION WAS MADE by Fouberg and seconded by Karim to submit 70:07:04:12 to the Rules Review Committee as written by the Department of Transportation (the "Department") in Attachment #5. All present voted aye by roll call vote. The motion carried.

A MOTION WAS MADE by Roby and seconded by Fouberg to approve changes to the wording in ARSD 70:07:02:08 to incorporate throughout the rule the style and form changes to parenthetical material that had been recommended by LRC. All present voted aye by roll call vote. The motion carried.

Chair Vehle called for public testimony in support of the rule changes. Toby Crow of Associated General Contractors testified that his organization had no objection to the proposed rule changes. Concerning ARSD 70:07:02:03, which sets the dollar limit for the prequalification requirement, Crow had no objections to the current change to \$250,000, but he asked that the Commission refrain from further changes any time soon.

Chair Vehle called for public testimony in opposition to the rule changes. No members of the public testified in opposition to the proposed rule changes.

A MOTION WAS MADE by Stoick and seconded by Zander to approve the Department's proposed amendments to ARSD Article 70:07, including the previously approved changes to ARSD 70:07:02:08 and the language recommended by the Department for ARSD 70:07:04:12. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2020 – 8.1 was adopted.

Secretary Bergquist presented the Secretary's Report. Bergquist presented the following items to the Commission:

- 1. The final plans are in place for the annual *On the Road* Meeting for September 22 23. The Department will hold the meeting at the SDDOT Sioux Falls Area Office, and the Commission will tour 3 4 spots in Sioux Falls including Veteran's Parkway and the Valley Springs rest stop.
- 2. The 2020 Transportation Hall of Honor inductees have been selected. They are Myron Rau, Barb Cline, and Ben Orsbon.
- 3. Bergquist requested Christina Bennett, Traffic Engineer for the Department, present additional information to the Commission regarding the fatal accident markers that are sometimes installed along the interstate and highway. Bennett made a brief presentation to the Commission.
- 4. Bergquist provided follow-up information regarding the Fallen Hero Bridge Naming program. Bergquist shared what he learned after a conversation with the Department of Veteran's Affairs (DVA), which facilitates the program. DVA wishes to continue approving a maximum of six (6) bridges per year. DVA solicits applications through its webpage and social media pages as well as by a press release. DVA plans to name bridges from each of the war eras and across the state. Bergquist shared the confirmed upcoming events for the bridges named at the June 25, 2020, Commission meeting:
 - a. Lance Corporal Conrad Flyinghorse October 10, 2020, at 10:00 a.m. MDT at the McIntosh School Football Field
 - b. Sergeant Allen Kokesh, Jr. October 3, 2020, at 1:00 p.m. CDT at the Yankton County Court House
 - c. Sergeant 1st Class Richard Schild September 12, 2020, at 10:00 a.m. CDT at the Yankton County Court House
 - d. Staff Sergeant Jason Montefering and Sergeant Jeremiah Boehmer November 11, 2020, at 9:00 a.m. CDT at the Parkston High School Auditorium
- 5. Bergquist provided background on wetland mitigation achievements through shared efforts by the Department and the South Dakota Department of Game, Fish & Parks. He noted that there would be a presentation later in the meeting.
- 6. Bergquist asked Craig Smith, Director of Operations for the Department, to provide an update on the ditch closure situation in the Black Hills. Smith shared that the Department is working with U.S. Forest Services to come up with a plan and that the Department is waiting on information from the Wyoming Department of Transportation, an agency that has been working with a similar

- situation. In 2023, there is a shoulder widening project so a more permanent solution will be possible at that time.
- 7. Kirk Fredrichs from the Federal Highway Administration was planning to address the Commission and present information on the Federal Highway Trust Fund, but due to COVID19 restrictions, this presentation will be postponed until the October meeting.

Bruce Cull left the meeting at 9:56 a.m.

- 8. Bergquist shared that traffic numbers in the state are back to normal. The State Highway Fund, however, is lower. The Fuel Tax revenue is down 14.5% and the Excise Tax revenue is down 26.8% compared to this time last year. Overall, the deposits into the Highway Trust Fund are down 18.04% for the month of July.
- 9. The Federal highway and transit funding program will expire September 30, 2020. Congress is working on reauthorizing the program with both the House and the Senate working on potential new legislation. With little movement on this expected until after the election, it is hoped that a continuing resolution can be passed to allow continued federal funding to be distributed pending final passage of new legislation.

Vehle asked for a motion for the Board to enter into Executive Session.

A MOTION WAS MADE by Zander and seconded by Fouberg to enter into executive session pursuant to SDCL 1-25-2(3) for the purpose of consulting with legal counsel or reviewing communications from legal counsel about proposed or pending litigation or contractual matters. All present voted aye by roll call vote. The motion carried.

Executive session began at 10:10 a.m. CDT.

Vehle called the meeting back into session at 11:29 a.m. CDT. A roll call was taken, and a quorum verified.

Craig Smith presented the following Construction Change Orders (CCOs) to the Commission. Before starting, he noted the total on the letter in the attachment was incorrect and should be closer to \$3.7 million.

Construction change orders completed in July contain an increase of approximately \$1,699,246.

Over the past 12 months, the overall contract increase is 1.22%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

Explanation of Change on CCO No. 2: This increase is the result extra worked performed by the Contractor to raise the roadway an additional 9 inches and to install fabric, riprap, and guardrail along the shoulder of the roadway. The Department determined the additional grade raise was necessary following a significant rain event during construction. In addition, the Department added the installation of guardrail along the shoulder of the grade raise for the safety of the traveling public and installation fabric and riprap to protect the shoulders from erosion.

<u>Explanation of Change on CCO No. 6:</u> This increase is the result extra work performed by the Contractor to repair the detour route with asphalt concrete.

There are no CCOs amounting to a change of \$50,000 to report this period.

<u>Explanation of Change on CCO No. 1:</u> This increase is the result of extra work performed by the Contractor to repair and replace a portion of the degraded existing pavement at bridge

approaches. The Department ordered a modification to the designed paving notch resulting in the extra work.

IV. Project: NH 0083(82)25, Mellette County, PCN 03RR

Location: US 83 from the West junction of US 18 to the North junction of SD 44

Contractor: Bituminous Paving, Inc.

<u>Explanation of Change on CCO No. 11:</u> This increase is the result of additional salvage base course material necessary to bring the shoulders up to the typical section elevation prior to paving asphalt concrete on the shoulders. Additionally, the Department adjusted the hours for flagging and pilot car to match the quantity used during construction to safely accommodate traffic during construction.

V. Project: NH 0083(86)0, Todd County, PCN 068G

Location: US 83 from the Nebraska state line to Mission

Contractor: Bituminous Paving Inc

Type of Work: Cold Milling Asphalt Concrete, Asphalt Concrete Resurfacing, and Rumble Strips

Original Contract Amount: \$ 6,950,879.72 Change on CCO No. 4: \$ 340,627.60 Net Change to Date: \$ 578,898.60

Explanation of Change on CCO No. 4: This increase is the result of the Department adjusting the contract requirement for recycled asphalt pavement (RAP) content in the new asphalt concrete. The RAP material generated from milling the roadway is not of sufficient quality for use in the new asphalt concrete. This reduction of RAP content resulted in an increase to the amount of virgin mineral aggregate needed and a higher asphalt binder content than estimated.

<u>Explanation of Change on CCO No. 5:</u> This increase is the result of the Department adjusting the contract quantities of flagging, pilot car, and temporary pavement marking. The additional hours for flagging and pilot car represent the quantity used during construction to accommodate traffic. The temporary pavement marking was increased to address a plan error.

Explanation of Change on CCO No. 1: This increase is the result of extra work performed by the Contractor to excavate and replace additional base course and asphalt concrete pavement material. Due to heavy rains and saturated conditions, the existing base and surfacing deteriorated and settled.

VIII. Project: NH-P 0031(29), Haakon County, PCN 042G

Location: Various Locations in the Pierre Area Contractor: Steve Lehrkamp Enterprises, Inc Type of Work: Culvert Replacement and Repair

Original Contract Amount: \$ 798,803.72 Change on CCO No. 2: \$ 52,791.07 Net Change to Date: \$ 170,832.64

<u>Explanation of Change on CCO No. 2:</u> This increase is the result of extra work performed by the Contractor to excavate and replace an additional 48-inch pipe culvert identified by the Department as in need of replacement.

<u>Explanation of Change on CCO No. 3:</u> This decrease is the result of the Department adjusting the contract quantities of water for granular material. Additional water was used to provide for proper compaction of the granular material.

The additional base course and asphalt concrete was used to correct plan errors and variations in depth encountered during construction. The asphalt binder increase was the result of a small increase in the binder content in the asphalt concrete mix. The Department adjusted the hours of flagging to represent the hours used during construction to accommodate traffic.

Brooke White, Access Management Engineer for the Department, presented for Commission consideration a request for control of access relinquishment on South Dakota Highway 34 for the Southridge Professional Building, LLC.

A MOTION WAS MADE by Zander and a seconded by Fouberg to approve the request for relinquishment of control of access on South Dakota Highway 34 in Madison as presented. All present voted aye by roll call vote. The motion carried.

RESOLUTION #2020 – 8.2 was adopted.

Ryan Johnson, Specification Engineer for the Department, presented for Commission consideration the following revisions to the special provision for price schedule for miscellaneous items:

- Engineer Directed Surveying/Staking change from "Three Man Survey Crew" at the current rate
 of \$160.00 / hour to new item at \$150.00 / hour. This item was last modified in 2009 and has been
 discussed with DOT staff and AGC regarding changes to current staking methods, equipment,
 and crew size.
- 2. Water for Dust Control change from the current rate of \$15.00 / MGal. to \$25.00 / MGal. This item was last modified in 2009. Average unit bid prices for the item of Water for Granular Material and information provided from AGC was used to establish this rate.
- 3. Extra Haul (Various Granular Materials) change from the current rate of \$0.15 / ton-mile to \$0.20 / ton-mile for truck haul and added a rate for yd³-station at \$0.08 / yd³-station for scraper haul. This item was last modified in 2009. Information provided from AGC was used to establish this rate.
- 4. Unclassified Excavation Digouts change from the current rate of \$8.00 / yd³ to \$11.00 / yd³. This item was last modified in 2009. Information provided from AGC was used to establish this rate.
