Chair Kathy Zander called the meeting of the South Dakota Transportation Commission (the "Commission") to order at 9:01 a.m.

\*\*\*\*\*

Zander opened the floor to the Commission members to disclose potential conflicts of interest and to present requests for waiver pursuant to the South Dakota Codified Law (SDCL) chapters 3 – 23.

Karla Engle, Office of Legal Counsel, presented a disclosure and waiver request from Jafar Karim concerning potential conflicts of interest. Copies of the disclosure and waiver request are attached to and incorporated into these minutes as **Attachment A.** 

A MOTION WAS MADE by Nelson and seconded by Rosenboom that the matters disclosed in the waiver request are fair, reasonable, and not contrary to the public's interest. All present voted ave by roll call vote except Karim who abstained. The motion carried.

Zander asked for a motion to approve the minutes of October 24, 2019, Commission meeting.

A MOTION WAS MADE by Fouberg and seconded by Stoick to approve the October 24, 2019, Commission meeting minutes. All present voted aye by roll call vote. The motion carried.

\*\*\*\*\*\*

Secretary Darin Bergquist presented the Secretary Report. Bergquist provided an update on the two emergency grade raise projects due to flooding on US Highway 18 and US Highway 81. The water has receded off US Highway 18 near Lake Andes. The Department of Transportation (the "Department") plans to install guardrail along this section of the roadway. US Highway 81 near Arlington has most of the paving completed and the Department hopes to install the guardrail soon.

Bergquist provided an update on the current status of federal highway funding. A Continuing Resolution was passed by Congress and signed by President Trump to continue to fund federal agencies through December 20, 2019. The Continuing Resolution repealed Section 1438 of the FAST Act. The repealed provision would have rescinded \$7.6 billion in federal-aid Highway Program contract authority on July 1, 2020.

Greg Fuller, Director of Operations, requested to take his portion of the agenda items out of order and present the following Construction Change Orders (CCO) to the Commission first and then proceed to the consideration of Veterans Memorial Highway application.

Construction change orders completed in September contain an increase of approximately \$310,244.

Over the past 12 months, the overall contract increase is 3.33%.

The following projects have a Construction Change Order (CCO) amounting to a contract change more than \$50,000.

#### **ABERDEEN REGION**

I. Project: NH 0014(225)347, Beadle County, PCN 05U0

Location: US14 from the east city limits in Huron to the end of the divided section

Contractor: Asphalt Paving & Materials Company

Type of Work: Cold Milling Asphalt Concrete and Asphalt Concrete Resurfacing

Original Contract Amount: \$ 1,866,245.47 Change on CCO No. 2F: \$ (76,673.75) Net Change to Date: \$ (76,645.49)

Explanation of Change on CCO No. 2F: This decrease is the result of the Department adjusting the contract quantity of asphalt binder and various granular material and salvage granular material items. The Contractor used less asphalt binder than estimated in the plans to construct the pavement in accordance with the contract. Minor variations in the granular and salvage granular material items resulted from normal variations during construction.

II. Project: IM-NH-P 0012(203), Watertown Area, PCN 05L7

Location: Various Routes in the Watertown Area

Contractor: Asphalt Surface Technologies Corporation Type of Work: Asphalt Surface Treatment (Chip Seal)

Original Contract Amount: \$ 2,718,653.19 Change on CCO No. 1: \$ (144,722.69) Net Change to Date: \$ (144,722.69)

<u>Explanation of Change on CCO No. 1:</u> This decrease is the result of the Department eliminating one route from the contract.

### MITCHELL REGION

III. Project: P 1358(05), Minnehaha County, PCN 05JE

Location: 26th street from Cleveland Ave to west of Southeastern Ave in Sioux Falls

Contractor: D & G Concrete Construction, Inc.

Type of Work: Grading, Storm Sewer, Curb & Gutter, PCC & Asphalt Concrete Surfacing,

Signals, Lighting, Permanent Signing, and Sidewalk,

Original Contract Amount: \$ 23,990,635.29 Change on CCO No. 1: \$ 58,452.92 Net Change to Date: \$ 58,452.92

Explanation of Change on CCO No. 1: This increase is the result of a change ordered by the Department. During construction of pier #2, the Contractor encountered a variation in bedrock elevation from what was depicted the plans. Upon additional investigation, the Contractor and Department decided to excavate additional material and to place a reinforced concrete pad for use as the foundation of the pier.

#### PIERRE REGION

IV. Project: IM 0904(62)210, Lyman County, PCN 067N Location: I-90 EBL & WBL from Exit 212 to Exit 226

Contractor: Border States Paving, Inc.

Type of Work: Asphalt Concrete Resurfacing, Approach Slab Replacement, Polymer Chip

Seal, Deck Overlay, and CRC Pavement repair

Original Contract Amount: \$ 22,939,718.99 Change on CCO No. 6: \$ 92,117.38 Net Change to Date: \$ 42,591.38

Explanation of Change on CCO No. 6: This increase is the result of a plan error. The plans did not contain the quantity of cable guardrail required for replacement at 2 ramps at Exit 212. In addition, the Department made change to the mulching material placed on the project. The plans required straw mulch. During construction, the Department elected to require fiber mulch to reduce mulch material blowing into traffic lanes.

V. Project: P 0044(192)254, Gregory County, PCN 03RX

Location: SD44 from Winner to SD47 Contractor: Border States Paving, Inc.

Type of Work: Process in Place, Asphalt Concrete Resurfacing, and Pipe Work

Original Contract Amount: \$ 12,945,992.77 Change on CCO No. 2: \$ 61,962.00 Net Change to Date: \$ 91,962.00

<u>Explanation of Change on CCO No. 2:</u> This increase is the Department paying the Contractor for 50% of the haul road repair required to restore the roadway to a preconstruction condition. Due to wet conditions, the haul road was damaged. The Department made the payment in accordance with the contract.

VI. Project: PH 0083(70)0, Todd County, PCN 03B2

Location: US 83 from the Nebraska State Line to south of Mission

Contractor: Bituminous Paving, Inc.

Type of Work: Shoulder Widening, Spot Grading, Asphalt Concrete Surfacing, Sidewalk,

Original Contract Amount: \$ 13,412,013.04 Change on CCO No. 17: \$ 149,600.00 Net Change to Date: \$ 741,295.70

<u>Explanation of Change on CCO No. 17:</u> This increase is the result of the Department paying for additional base course material necessary on the project. Due to various overruns and alterations to the plans, additional material was necessary to construct the typical section.

VII. Project: P 0073(72)0, Bennett County, PCN 05KN

Location: SD73 from the Nebraska State Line to Martin

Contractor: Jensen Rock & Sand, Inc.

Type of Work: Asphalt Surface Treatment and Crack Sealing

Original Contract Amount: 721,921.04 \$ Change on CCO No. 2F: (50, 152.72)\$ Net Change to Date: (25,464.88)

Explanation of Change on CCO No. 2F: This decrease is the result of the Department adjusting the contract quantities to match the quantities used during construction. The increases include crack sealing, asphalt for surface treatment, cover aggregate, flagging, and pilot car. The increases are the result of normal project variations.

#### RAPID CITY REGION

There are no CCOs amounting to a change of \$50,000 to report this period.

Christina Bennett, Operations Traffic Engineer, presented for Commission consideration a Veterans Memorial Highway application. The request is to designate United States Highway 16B from Interstate 90 to the intersection of South Dakota Highway 79 in Rapid City as the United States Submarine Veterans Memorial Highway. Due to an error on the Department's website, the application was submitted using an old application form that included a \$600.00 fee rather than the new application that was updated at the end of April 2019, with an application fee of \$2,000.00. The Department is requesting the Commission to allow the Department to accept the \$600.00 fee in lieu of the \$2,000.00 due to no fault of the applicant.

- One project will be to install equipment to detect flat and under-inflated tries and nonfunctioning brakes on commercial vehicles at the Sisseton Port of Entry.

This revision will add a FY2020 Railroad Crossing Signal Upgrade with Catwalk Extensions project on the RCP&E Railroad to the 2020-2023 STIP in the Rapid City, Pierre and Aberdeen Regions.
