Program Update from Victims' Services

- **Claim Specialist: Randi Spaid**
 - Since the last commission meeting, SDVS has gone through staff changes within the program. Previous SDVS Director Cora Olson resigned in March of 2024 to return to law enforcement. DPS is currently in the last phases of hiring a new Director. In June of 2023, SDVS hired a new Claims Specialist, Nicci Rancy.
 - As of SFY 2024, Crime Victims' Compensation Program has processed 248 claims compared to 224 claims processed in SFY 2023.

- Another area of focus for SDVS is the law enforcement reimbursement program to be utilized more frequently for direct reimbursement to the officers who assist those in crisis.
- **David McVey: Attorney Advisor**
 - Provided update from Office of Justice Programs of proposed rulemaking to enhance the federal Crime Victim Compensation Program. Most relevant to SD, the proposed rule would impact contributory conduct, and the Commission would be precluded from considering contributory conduct for the award. The proposed changes would also preclude criminal history and prior payments when making award decisions. The contributory conduct has multiple states with issues. SD Office of Attorney General has signed on to a letter with other states opposing those changes. It is anticipated if rule passes in its current form, there could be multi-state litigation over that. The position the states are taking is OJP lacks the authority to make those changes.
