#### **SECTION 4. APPLICATION NARRATIVE**

#### A. PROJECT ABSTRACT AND DEMONSTRATION OF NEED

It is no secret that many of our young people are struggling with their mental health. This fact rings truer when knowing that SD ranks 5<sup>th</sup> in the nation for deaths by suicide among our youth.

A 2017 study by Modern Psychological Studies (vol 22) notes that students in animal-assisted therapy programs had a 0% dropout rate, versus a 40% rate for those without this therapy. The same study found that students were 94% more likely to seek out mental health help with animal-assisted therapy than traditional one-on-one counseling.

A recent study in The Journal of Pediatric Nursing noted a marked decrease in mental health disorders for children/youth engaged in animal-assisted therapy.

A 2020 article from the Mayo Clinic states:

"Animal-assisted therapy can significantly reduce pain, anxiety, depression and fatigue."

#### B. STRATEGY FOR IMPLEMENTATION AND SUSTAINABILITY

Davison Co JDAI Coordinator has been working with Reclamation Ranch, a local resource that provides equine therapy services, in working with youth within our community. Reclamation Ranch already does work with youth in treatment facilities, veterans, disabled individuals, etc. They are well versed in helping youth who struggle with depression, anxiety, low self-esteem, as well as many different mental health disorders our youth of today face. Our goal is to help as many families break through social, racial, ethnic, and economic barriers that would normally prevent them from receiving these services, and allow the youth to heal, learn, and live a full life. Reclamation Ranch

will continue to apply for grants and gain community support for sustainability in working with Davison Co youth.

Davison Co JDAI Coordinator has been working with I.AM.LEGACY to work in conjunction with their program to provide services to youth in Davison Co. I.AM.LEGACY will commute to Mitchell 1 time per month (for a 2 day service) to work with the indigenous youth population. I.AM.LEGACY has a great reputation for serving indigenous youth on the west side of the state and has helped countless youth create a positive path towards being positive members of their community. I.AM.LEGACY will continue to collaborate with Davison Co to work towards having a positive community member lead the youth groups in hopes of continued services and even higher hopes of growth in the program.

- I. Informative meetings will be held with system stakeholders, non-profit organizations, and faith-based organizations in attempts to gain community support. Radio interviews and newspaper articles will be done to keep up community involvement and support ongoing
- II. Work in conjunction with Reclamation Ranch and I.AM.LEGACY to provide relevant juvenile justice and racial/ethnic disparities training (ongoing)
- III. Coordinate referral system with Reclamation Ranch and I.AM.LEGACY for referring youth over for services. -by August 2024
- IV. Coordinate efforts and serve as liaison between youth/family, court, I.AM.LEGACY, and Reclamation Ranch to ensure youth are successful- ongoing.
- V. Submit for reimbursement ongoing.
- VI. Work with community charities for assistance and support once grant funding is complete- ongoing

Helping with Horsepower respectfully requests your support and approval in applying for funding to the R/ED (Reducing Racial and Ethnic Disparities) Grant to provide funding for equine therapy for at-risk youth at no charge to the participant for a year.

The United States is facing a mental health crisis among its youth, regardless of race or ethnicity. South Dakota is no different, ranking 5th in the country for deaths by suicide among youth. What are we doing about it?

A great majority of youth within JDAI (Juvenile Detention Alternative Initiative) have been diagnosed with some type of mental health disorder or a substance use disorder and labeled "at-risk". This is really no surprise to anyone that works in the field of corrections. With your help, we have the "horsepower" to change the trajectory of many of these individuals and prevent them from a perpetuating downward spiral of hopelessness.

This program will be led by EGCM practitioner Crystal Young. Through the partnership of a horse, each individual will learn and discover the skills and confidence to overcome challenges, set healthy boundaries, and learn to trust again. At-risk youth will participate in a 6 week program for weekly sessions. Each session is one on one and 90 minutes in length. Sessions are experiential and work with each individual to provide insight and discovery of their own internal strengths while healing unfinished traumas. Horses are non-judgemental and teach those having experienced trauma and struggling with mental health issues:

- Courage
- Trust
- Resilience
- Forgiveness
- Healthy Boundaries
- Hope

Since 2010, Helping with Horsepower has been providing solutions and programs that empower, encourage and inspire at-risk youth. We have seen countless improvements among the mental health of at risk youth through our programs. Horses have been utilized as teachers and healers for hundreds of years and research has now been proving it. When nothing else seems to be working in hopes of impacting mental health, why not turn to a horse?

Abbott House Program Director Deb S witnessed the transformation of one of the girls she knew. Hannah was a young Native American teen who recently became emancipated. "We have a young lady that has really been struggling. She ran last November and was gone for almost 2 weeks. Since she has been back she is angry at the world, feels hopeless and unlovable. Earlier in the year she went out to the ranch and worked with Crystal and really seemed to make a connection with her. We've tried quite a few things to get Hannah out of this angry place but it wasn't working so we started looking outside the box and talked with Crystal and the horses. We talked to her about this yesterday when walking her back to her pod her staff looked at

her and she had tears dripping from her eyes. Her staff asked her what was wrong. Hannah told her staff that she had never felt so loved."

Having worked with many organizations in our community for nearly 15 years, our goal is to continue to provide our programs for as little as possible if not free of charge to those in need. Helping with Horsepower continues to offer out of the box opportunities for individuals that face daily adversities. Our mission is simple, see a need, fill a need. There is most definitely a need for mental health services not only in our community but nationally. With your help and support, we can make a difference in more lives like Hannah's through Helping with Horsepower. In hopes that someday, South Dakota will be a leader in innovation and resources on mental health.
