<u>MINUTES</u>: Board Member Schroyer made a motion to approve the minutes for the November meeting of the Board. Board Member Beck seconded the motion. All members voted aye; the motion carried.

BOARD REPORT: Val McGovern was available and updated the board on the following:

-There were 17 pardon applications received in November and the current set-out period is to March 2023. There are currently 54 pending clemency cases pending a decision by Governor Noem.

- Board Members Myers, Hall, Beck, and Steele have their applications submitted for the Parole Board NIC training in Colorado in February, this is pending an application review and acceptance from NIC.

- Chuck Schroyer's last board week will be January 8-11th, Val McGovern previously reached out to the Supreme Court Justice and is awaiting their new appointment.

- Contested hearings that go before the board will not have a BH (Behavioral Health) summary. Most of these cases will have a discretionary date set and will not be pending a release, if questions arise during the hearing, Val McGovern will reach out to proper staff to get the questions answered.

-An Affidavit was sent to a reservation regarding a parole absconder to confirm her revocation of parole, in the hope of maintaining a parole detainer and not needing to send a Governor's Warrant. So far, no other complications have come from this specific case.

FIELD SERVICES REPORT: Director Lewandowski updated the board on the following:

- Open positions: 9 agent positions: 2 Sioux Falls (position has been re-posted), 5 Rapid City (positions relisted (three currently vacant)) 1 Watertown (position listed and interviews are ongoing), 1 Pierre (Specialist position moved from Rapid City; conditional offer has been accepted); .5 secretary positions: Part-time Spearfish (not listing at this time). Agent Ashtyn Shafer started in Sioux Falls 11/9/2023.

Agent Anthony Fontenot started in Pierre 11/13/2023.

A conditional offer was made to Amanda Forbes for the parole agent specialist position in Pierre, SD. The tentative start date is scheduled for January/February 2024 as she is moving from out of state.

Chris Martin (Parole Agent in Rapid City) began his duties as the West Region Supervisor 11/24/2023.
