VI. Special Session Pardon Denials (SDCL 24-15A-11.2)

Board Members reviewed the denials of 6 pardons by the two-panels at Special Session. Motion by Brown, second by Hall to ratify the decisions and adopt the denials. All members voted aye. Motion carried.

VII. January Minutes

Board Members reviewed the minutes for the January 2026 meetings of the Board. Motion by Aasen, second by Brown to approve the January 2026 minutes. All members voted aye. Motion carried.

VIII. February Hearing Panels

Board Member Meyers was unable to participate on Tuesday and Wednesday due to an unexpected conflict. There were no other changes to the posted schedule.

IX. Full Board Cases / Potential Upcoming Paper Review Cases

Board Members were advised that the March calendar has 1 full board case currently scheduled.

X. March Proposed Schedule

Board Members reviewed the proposed schedule for March. Due to a lower number of full board cases in March, the board will hold its business meeting on Wednesday, March 11th, 2026, and not convene on March 12th, 2026. Board Members indicated whether they would be appearing via Teams and had no further changes to the proposed schedule.

XI. Board Report / Field Services Report

Board Members reviewed the board report and monthly metrics. There was a Special Session held on January 29th; there were paper reviews of early discharges, pardons, and commutation applications, waivers (parole/SSV/non-compliance) signed, and parole revocation, suspended sentence, and non-compliance hearings. The current set-out period for pardons is April 2026.

XII. Items for Discussion

Chair Rau discussed holding JPA A131 discretionary parole hearings only by Teams. Board members will not go into room A131, and the board administration office will not send any staff in person. Hearings will be held in the case manager's offices, which is how it is done at other
