Thanks for the productive discussion on our partnership yesterday. I appreciate you taking the time to connect with me and to provide me with valuable feedback.

### Quick Recap:

- We discussed the importance of the pricing and justifying the value of our solution for you and your team.
- You shared insights from your Council members on the ongoing costs they have experienced with other website providers, ranging from \$5,000 to \$10,000 per year.
- You also highlighted the potential challenges with using the Bureau of Information and Telecommunications (BIT) for the website project:
  - SD DD's site may get pushed to the back when higher priority items come up.
  - BIT's availability is only 8am to 7pm on weekdays when Granicus is available 24/7
  - There is a current hole as Jeff Clines has moved from CIO in SD to CIO in Wyoming, which causes bandwidth issues
  - BIT will charge for every minute spent on adjustments, consultation (if available/applicable) and continual q&a and modifications needed as the website continues to grow. Granicus' ongoing fees include all services to your site should you need help.
- We talked through the different components included in Granicus' ongoing costs, such as the software platform, hosting, and the 24/7 support services we provide.
