South Dakota Conservation Commission:

The Miner Conservation District would like to request a 'one year' extension for the "East Central Range Stewardship Grant" #2021-CSW-031.

This is an excellent grant with added contributions from US Fish & Wildlife Service and SD Game, Fish, & Parks, making the total cost-share up to 50% for producers. We were in a drought in 20, which is why we applied for this grant. Right after we were approved in 2021, Miner & McCook & Sanborn counties all reached a D3 status on the Drought Index. Many of the producers we had already worked with now qualified for ECP funding, so all the work we had done was handed over to the FSA Agencies. The projects that included wells due to lack of rural water hookup ability were forwarded to SD GF&P and US F&WS. Hanson county was not considered D3 but were still in a drought and in need of livestock water. Many missed the signup for ECP – they had hoped it would rain and their problems would be solved. Supplies (pipeline, fittings, tanks, etc) were next to impossible to get so many producers had to wait until the summer of 22 and some are even still waiting. Many areas in these 4 counties are dryer right now than they were in 2021. We currently have many requests but are waiting for Cultural Resource to be completed and contractors to secure the needed pipe, etc.

We would love to receive a one-year extension for the remaining funds, to allow the remainder of the producers signed up a chance to get their livestock water systems done with the assistance of this grant.

This project has been very well received. We have received numerous phone calls and visits concerning this grant. Our livestock producers have been very thankful for this opportunity to help fund their livestock water systems and create grazing plans.

The Bennett and Badlands Conservation Districts approved cost-share to 3 producers, for 4 tree plantings, all in Bennett County. The plantings were: 2 livestock plantings, 1 renovation and 1 wildlife planting, all of which will also benefit soil health in the area. The plantings totaled 6.9 acres. No grant dollars were used for the removal of any existing trees.

The Districts provided news articles with information about the grant program to the local newspapers for publication. Information was included in the Districts' newsletters and annual report.

## Corson Conservation District Final Report Tree & Fence Grant 2022-CSW-007

We are happy to submit our final report for our tree and fence grant. This was our first Commission Grant and was a great learning experience. This grant helped two producers in Corson County complete two functional tree shelterbelts which may otherwise not have been installed. Between these two producers, we successfully installed the following:

- 1,575 ft of fence
- 8,434 ft of fabric
- 1,502 trees
- 4.46 total acres of tree plots

This grant also provided a new working relationship with one producer who had never planted trees before and allowed us to continue our relationship with our other long-time producer. You cannot place a dollar amount on the ability of a Conservation District to make positive working connections within the community it serves.

Unfortunately, due to an unforeseen change in circumstances for one of the producers, we are having to turn back \$1,355.31 in funds.

Thank you for your support of 2022-CSW-007. We hope to work with the Conservation Commission again soon.



Dear Alex Roeber and the Conservation Commissioners,

The 2022 SDACDE Conservation Awareness allowed our Conservation Districts to promote conservation and the services our districts offer. Districts had the opportunities to hold training sessions, workshops, classroom activities, and public events.

Our districts outreach activities included a presence at the following events, among others not listed: Central States Fair and the South Dakota State Fair. Employees volunteer to fill shifts at a booth reserved at each event. Promotional items are distributed which include the "stress trees and the neon green back packs. We have added shopping totes as a "giveaway' at our booths. Each item has the South Dakota Conservation Districts logo on them. It is always rewarding to see the bright green back pack on the back of a child out in the public! A SD map was displayed at the booth at the State Fair, showing all the S.D. counties. Each person that stopped by the booth was able to check off their county, as they discussed the goals and services of the districts. A total of fifty one of the sixty six counties were checked off of the map. Three gift certificates were given at the end of each shift throughout the day. These allow the winner to purchase products or services at their individual district.

During the winter months, a Crop Expo was held in Watertown where over 200 were in attendance. The SD Soil Health Conference was attended by 350+ people. A booth was rented at the Watertown Winter Farm show. Kingsbury Conservation District held an Open House event. Hughes District joined the SD Soil Health for a "round table talk" with area producers and numerous speakers. Later in the year, Sanborn, Hamlin, Kingsbury, McCook and other districts each visited area schools to give Arbor Day presentations. Tree Seminars, Tree Pruning workshops and Pollinator Garden Sessions were held in Kingsbury County. At each of these events, SDACDE employees were able to answer questions about the Conservation Districts, our goals and services. Hamlin CD held a "worm farm" /soil health day at the area school. August is the month for Fairs. We not only have a presence at the SD State Fair, but are also at the Brown County Fair and the Central States Fair. Marshall CD hosts an Eco-Ed Day, which teaches about Prairie and Range Soils, Forestry and Wetlands.

At each of these events, the Conservation Districts work to convey the goals and services of our districts. Promotional items are distributed.

This funding has become vital to our conservation districts. Many of the districts do not have the financial means to conduct these important events. The districts must remain visible to share the conservation message. Thank you for continuing to provide this resource.

Soil Health and Hughes Co. Conservation District joined together on March 17<sup>th</sup> at Medicine Creek Bar & Grill in Blunt, SD for a Soil Health Sit-Down. About 30 producers came from the surrounding areas to sit down and talk with other produces and experts. We handed out Conservation District Tote bags and Back-Packs with information from NCRS, Soil Health Coalition and Hughes Co. Conservation District for producers to look through.

Sam Ireland from Dakota Lakes Research Farm uses several different kinds of Cover Crops and talked about why cover crops are important and that knowing your soil types, can help you figure out what cover crops would be better for your production as not very producer can use that same cover crop.

Jason Miller from NRCS Agronomist talked about a cover crop seeding tool that helps the producers figure out the different kinds of mixtures and the costs of mixtures.

Cody Silverberg from Dakota Lakes Research Farm talked about how livestock integration is a good thing for all soils. Also, why all kinds of livestock are important for the soil and what they do for the soil. Cody also talked about when people take bales out of the fields, they are taking the nutrition away from the field for next year.

## **Fun with Education**



Marshall County Conservation District hosts 2022 Eco-Ed Day at Fort Sisseton

Eco Ed Day was held on September 7<sup>th</sup> on a beautiful very warm day at Fort Sisseton, located on top of the Coteau Hills. Fifty-two—7<sup>th</sup> grade Marshall County students participated in an outside classroom, learning about our Natural Resources. The sessions (and instructors) included Prairie & Range (Blaze Jones-NRCS Soil Conservationist, Marshall Co.), Soils (Matt Hubers, NRCS, Webster FO), Forestry (Josh Wagner, Day County Conservation District Manager), Water Quality (Dennis Skadsen, Glacial Lakes Project Coordinator), and Wetlands (Laura Hubers, retired --FWS, Waubay). Nine helpers also participated in the day's activities and teaching.

A morning snack with bottled water was provided by the District as the students arrived for the day of learning. Back-packs, pens and the instructional booklets were given each student. The sessions were each ½ hour in length. The groups were divided into app. 10 to each group with a leader to guide them from session to session. Three sessions were held in the morning before breaking for lunch.


Following lunch, which was provided by the Marshall County Conservation District, the students watched the Rainfall and Wind Simulators presented by Ryan Forbes & Craig Veldkamp of the Brookings Area NRCS Field office. This demonstration effectively showed the run-off and absorption of water on tilled ground, no-till soils, cover crop soils, continual grazing vs rotational grazing. Area producers were also invited for the noon meal and to watch the rainfall simulator. A few were in attendance.

The afternoon held two more sessions for each group. The day wrapped up with another snack and a short recap before the buses headed back to their respective schools.

The Kingsbury County Conservation District along with the Miner Conservation District shared grant funds in the amount of \$9,000.00 from the Department of Agriculture to assist the district with funding to help educate, promote and advocate for conservation within our counties.

Educational supplies expenses were used to cost-share items purchased for educational events and conservation programs. Classroom and program expenses consisted of printer paper, ink, envelopes, and stamps for outreach events.

Wages & benefit expenses were cost-shared for time and mileage that conservation staff accrued while planning and hosting events.

Tree replacement cost-share funds were used towards planting young vibrant trees at area schools. Bare-root hand plant trees were given to area students for Arbor Day. #### NORTHWEST AREA NATURAL RESOURCE SPECIALIST 2021-CSW-020 FINAL REPORT

This is the final report for the South Dakota Conservation Commission grant 2021-CSW-020. The grant has enabled the Northwest Area Conservation Districts with providing their producers with the expertise and ability to plant shelterbelts. These shelterbelts provide protection for livestock, prevent erosion of fields, and most have the added benefit of providing food and shelter for wildlife.

#### 2021-CSW-020 Tree Planting Grant

- In 2021 assisted 9 producers plan shelterbelts on their land with approximately 2258.5 rod rows
  of trees, 465.8 rod rows of shrubs, and 44,937 feet of fabric
- In 2022 assisted 2 producers plan shelterbelts on their land with approximately 919.7 rod rows of trees, 122.4 rod rows of shrubs, and 17, 194.50 feet of fabric

This grant has provided the Northwest Area producers with the ability to plant shelterbelts to protect livestock and against erosion and hopefully can continue with it in the future.

#### **Braun Ag Plot Final Report**

Thank you for your help with this plot. We started this project with the hope to take a site with tough soils and make it productive through regenerative agriculture practices. In the past four growing season we have learned a lot...

In the beginning we started with 24 plots and planted a variety of crops. The first year sunflowers, cover crop, and millet was planted. The plot evolved from there as we added 60" corn, beans into rye, Italian Rye grass, and a Three Sisters (sweet corn, green beans, and squash) garden plot over the years. The annual crops suffered in the soil from year to year, but the perennial hay mix has done well. Soils tests were taken each year to see what crops have helped the soil so we could track the progress. Each year had its challenges and we have had a variety of weather working against us the past few years from wet springs to drought in the late summer. We took each challenge in stride and learned from them. In 2020 and 2021 we hosted a plot tour where we had producers come visit the site. We hoped to inspire the producers into add a couple of regenerative practices to their operations after seeing done at the plot.

As we close out this grant we have come to an intersection with the plot. We will have to have a discussion with the landowner soon to see what the best actions to take going forward. Even with all the challenges, this plot and grant has been successful. It has provided us, along with our board with a great learning experience. We hope with the knowledge that we have acquired we can help producers implement some of the successful regenerative practices around Spink County.
