Can you please explain the background/reasoning for the following changes? Thank you.

70:02:04:02 Changes the distance between public/private airports from 6 miles down to 2 miles The opposite is actually being proposed (increasing from 2 miles to 6 miles).

70:02:04:06 Deletes the entire section related to: Airports, heliports to be located to avoid conflicts and overlaps. (Again, appears to allow for a private airfield close to existing airports) This was redundant language as part of the airport layout planning process (which would be approved by the FAA) is avoidance of conflicts and overlaps.
