Thank you for your consideration in lowering the speed limit on Highway 11, south of 69th Street through Shindler, in Lincoln County. We are glad to see this matter being taken seriously, and would like to state that we believe the proposed 55mph speed limit on the above referenced section of Highway 11 is a necessary safety measure.

We would also like to address and insist on the need for a no passing zone to be extended from 69th through Shindler. This concern was discussed in our original letter to the Transportation Commission, but it doesn't appear to have been addressed in the review completed by the SDDOT. The multitude of driveways and entrances onto Highway 11 through the section being discussed (south of 69th through Shindler) necessitates a no passing zone. Far too often, near collisions occur as drivers enter or attempt to enter the highway and find themselves on course for a head-on collision with a car that is passing. Passing cars and those entering the highway often either do so at the same time or are unable to see one another. With so many homes and highway entrances located on this section of highway, it is an absolute mistake to continue allowing passing zones here. We are confident that implementing (and therefore extending current no passing zones on either side of the location being discussed) are necessary to prevent fatal accidents. We appreciate your consideration of this matter as well.
