Dear Mr. Dokken,

As a land owner and farmer, I have several concerns about the proposed rail to trail project. While I believe I understand the desire behind creating the trail, I also believe some critical issues have been overlooked. I have read the literature mailed to me as well as the information available on Facebook and the website. My concerns include, but are not limited to the following points.

- I. Comparison to the Mickelson Trail
 - A. The local mindset and economic factors are quite different than the that of the Black Hills making the comparison to the Mickelson Trail illogical. In this instance, a great deal of the trail goes through private property rather than state property while the opposite is true for the Mickelson trail.
 - B. Agriculture provides the economic foundation of this community whereas tourism is a backbone in the Black Hills area.
 - C. The Tabor to Platte Rail to Trail goes through a great deal more private land than state land.
 - D. Several sections are inaccessible due to dense overgrowth or submersion.

- II. Liability Concerns
 - A. Fencing and Gates
 1. Responsible party for repairs to damaged private property
 2. Livestock escape due to unclosed gates/damaged fencing

 - B. Destruction of crops
 1. When a spark from an ATV (or a child playing with a lighter) starts a fire in a wheat field, who is liable for the loss of the crop? That loss is not just an inconvenience but a loss of livelihood for the farmer amounting to tens of thousands of dollars.

 - C. Injuries
 1. People on the trail injuring livestock through attempted contact or taunting
 2. Injury to people due to attempted contact or taunting
 3. Physical injuries sustained during trail activities

Who assumes responsibility for injuries along the trail – to riders, walkers and livestock? A slip or fall that results in a sprain or broken bone is probable. Recall the footage we all saw of the woman that approached a buffalo. A cow protecting her calf will respond the same. When the trail moves onto a county or township road, what entity is liable?

- III. Supervision and Rule Enforcement
 - A. Collection of Fees
 - B. Litter clean-up and garbage collection
 - C. Trespassing onto private property
 - D. Motorized vehicles – 4 wheelers, ATVs, or snowmobiles used simultaneously with hikers
 - E. Vagrancy

- IV. Benefit vs. Cost
 - A. Projected cost of Maintenance
 - B. How many people will it bring in and who will benefit?

I ask you to imagine your own business. Now imagine strangers entering your business unsupervised, day and night, for any reason, to do as they please. How would this impact your safety? What effect would this have on your business? What losses would you incur? Farm owners have much more at risk than meets the eye. They face damage or destruction of fencing, equipment, livestock and crops in addition to their loss of privacy and safety. Farming is a *business* and *livelihood* that operates at home. What other business would you expect to allow people to enter their home or office unsupervised with so much at stake.

It has come to my attention the Friends of the Tabor to Platte Rail to Trail is petitioning the State to grant a lease to construct a walking path along the Napa Junction to Platte. I am opposed to this request.

My family's farm happens to be the first parcel of property's Southeast of Platte, this is the first section outside of Platte that the railbanked right of way starts, the property North West has already been sold back to adjacent property owner. It would be my ask that the State of South Dakota and the South Dakota State Railroad Board would deny the request for the lease.

I understand that I am finding old information but, the State did just try and sale several parcels of railroad including the Napa Junction to Platte section. I do not recall any engagement with the current adjacent property owners to see if they would like to purchase this right of way back, I know if at the time my family would have been aware of the possibility, we would have pursued it.

When Mr. Hoffman bought his section of railroad back from the State every other property owner signed petitions to do the same however, these requests have gone unanswered.

In the late 1800's and early 1900's our forefathers sacrificed acres of land to grant these right of way deeds knowing the transporting of their crops would out way the loss of production acers. Now that the railroad right of way is no longer used it is time for the State to sale back the land and to let us do what we do best and farm the ground.

Please let the adjacent property owners who have maintained the railroad right of way for over one hundred years have a chance to make our farms whole again.
