Participants in need of home modifications do not always receive them as quickly as they need. Resources for accessibility related modifications (aside from ILC) are scarce. ILC's list of projects that need to be completed is always long and growing.	A satisfaction survey that was returned by a family member noted that dad (participant) passed away before shower modification could be completed. He was placed on ILC's Project list in February 2023 and passed in September, before modifications had begun. Two other participants that were on ILC's project list to receive a ramp also passed away since completion of last quarterly report.	It is an ongoing balance of having enough approved contractors to complete projects (but not too many contractors so that they do not get enough bids and lose interest in completing projects for ILC), enough staff and staff time (along with other participants they are serving and job duties), funding (annual funding received and additional funding generated by ILC), and availability of supplies (shower modifications in particular). We focus on building positive working relationships with contractors, working through projects as quickly as possible, and streamlining the processes for staff to be able to complete HMAD projects in an efficient manner.
