BOARD REPORT: Val McGovern was available and updated the board on the following:

- There was a Special Session held by the parole board on December 29th, 2023.
- Board Members continued to utilize Adobe sign for board slips and legal findings.
- Val McGovern continues to audit the Top 50 absconder warrants in NCIC to ensure they are active.
- -There were 14 pardon applications received in December and the current set-out period is to April 2024. There are currently 57 pending clemency cases pending a decision by Governor Noem. .
- Board Members Myers, Beck, and Steele have been accepted in the Parole Board NIC training in Colorado in February and have confirmed their attendance.
- Chuck Schroyer's last board week will be January 8-11th, Val McGovern previously reached out to the Supreme Court Justice and is awaiting their new appointment.
