IV. July Hearing Panels

Board Members Meyers and Aasen conducted hearing panels in RCC on Teams due to an unexpected issue resulting in room unavailability. There were no other significant changes from the published agenda.

V. August Proposed Schedule

Board Members reviewed the proposed schedule for August. Board Member Meyers will not be available on August 14, 2024. Auxiliary Member Chuck Schroyer will be sitting in on a commutation hearing on August 15, 2024. Board Members had no further changes to the proposed schedule.

VI. Board Report / Field Services Report

Board Members reviewed the board report, monthly metrics, and annual metrics. There was a Special Session held on June 27, 2024; there were early discharges, waivers (parole/non-compliance), a suspended sentence revocation hearing, a rescindment hearing, and paper review commutation hearings. Governor Noem acted upon 22 clemency cases in the month of June. There were 15 pardon applications received in June and the current set-out period is to August 2024. Parole Board Administration Manager Shelli Gust attended the DOC Basic Training Program and graduated on June 10, 2024.

There was no Field Services Report submitted to the Board.

VII. Items for Discussion

Board Members discussed including questions about pending, unresolved major write-ups in their interviews with offenders.

Chair Rau advised that former board member Gordy Swanson would like to sit as an auxiliary board member and is eligible to do so for four years following his service on the board. Service as an auxiliary member does not require appointment.

Board Members discussed potential upcoming changes to how System Risk 3 offenders are classified and how that may impact the number of full board cases going forward.

VIII. Training

Board Members engaged in a general Q&A with DOC Attorney Addyson Aguirre.

Board Members participated in refresher training offered by Parole Board Admin Mgr. Shelli Gust on SDCL 1-25 – Meetings of Public Agencies and SDCL 1-27 – Public Records and Files.

Board Members participated in training on DOC Tablets and educational programs offered by Parole Board Corrections Specialist Stacy Cole. Two offenders gave presentations on the benefits of the programs offered on the tablets, and their interest in expanding AVP and other programs to offenders going through the A&O Process. Board Members expressed an interest in receiving a demonstration of the tablet and more information about the specific programs offered. Board Members expressed an interest in encouraging offenders to complete programming on the tablets prior to being seen by the Board and possibly posting an open letter on the Tablets. Staff will work on those items.

IX. Policy Review

Board Members reviewed Policy 8.1.A.5: Parole Decisions and Setting of Next Review Date. Motion by Albers, second by Brown to direct staff to revise language on the recusal section and bring it back before the Board in August. All members voted aye. Motion carried.

Board Members reviewed Policy 8.1.A.1: News Media and Cameras at Board Hearings. Staff recommended revisions to the policy so that the language was consistent with the DOC institutional policies. Motion by Meyers, second by Albers to adopt Policy 8.1.A.1: News Media and Cameras at Board Hearings as amended. All members voted aye. Motion carried.

X. Full Board Cases / Potential Upcoming Paper Review Cases

Parole Board Admin Mgr. Shelli Gust advised the Board of two paper review parole hearings and three in-person parole hearings that are scheduled for August. Parole Board Corrections Specialist Stacy Cole advised the Board of a paper review commutation hearing in August, a commutation hearing in September, and a commutation hearing in October.

XI. Special Session Decisions

Motion by Beck, second by Meyers to ratify the special session clemency decisions. All members voted aye. Motion carried.
