I. Call to Order

III. Parole Hearings

V. Secretary of Corrections Nick Lamb

Secretary of Corrections Nick Lamb introduced himself to the Board Members and engaged in a brief question and answer session about general topics involving the DOC, Parole, and the Parole Board. SOC Lamb was invited to attend any board meeting in the future if his schedule allows.

A brief break was taken.

VI. May Minutes

Board Members reviewed the minutes for the May 2026 meetings of the Board. Motion by Beck, second by Steele to approve the May 2026 minutes. All members voted aye. Motion carried.

VII. Full Board Cases / Potential Upcoming Paper Review Cases

Board Members were advised that the July calendar currently has 2 cases currently scheduled and the August calendar currently has 1 case currently scheduled.

VIII. July Proposed Schedule

Board Members reviewed the proposed schedule for July. Due to a lower number of full board cases in July, the board will hold its business meeting on Wednesday, July 15th, 2026. Board Members indicated whether they would be appearing via Teams. Going forward, Board Members would like to designate the Sioux Falls One Stop as the preferred location for full board meetings, with the JPA Visit Room being a secondary location if the Sioux Falls One Stop does not have any available rooms.

IX. Board Report / Field Services Report

Board Members reviewed the board report and monthly metrics. There was a Special Session held on May 28th, 2026; there were paper reviews of early discharges, pardons, and commutation applications, waivers (parole/SSV/non-compliance) signed, and parole revocation, suspended sentence, and non-compliance hearings. The current set-out period for pardons is August 2026.

A brief break was taken.



X. Policy Review

Board Members reviewed recommended changes to the following policies: 8.1.A.3: Dispositional Meeting and Attachments; 8.1.A.2: Parole and Suspended Sentence Revocation Hearings; and 8.1.A.15 Revocation of Suspended Sentence. Recommended changes took into consideration feedback received from Board Members, the goals of the DOC's Smarter Supervision Initiative, and Governor Rhoden's expansion of those goals through his request that the Board process revocations faster, impose stronger sanctions, hold dispositional meetings more frequently, and increase the length of returns to prison.

Motion by Pilcher, second by Beck, to adopt 8.1.A.3 Dispositional Meetings and Attachments, 8.1.A.2: Parole and Suspended Sentence Revocation Hearings, as amended, and 8.1.A.15 Revocation of Suspended Sentence, as amended. All members voted aye. Motion carried.

XI. Items for Discussion

Board Member Lieberman discussed staff safety concerns. Board Administration Manager Gust will visit with her staff and explore whether there may be new technology or processes available to reduce the safety concerns.

Board Administration Manager Gust and Chair Rau shared their experiences from attending the second SDMF Community of Practice in Aurora, Colorado on June 2nd – 4th, 2026. A new e-course launching soon will provide the Board with an opportunity to engage in additional SDMF training and evaluate how they may more effectively use SDMF going forward.
