Governor Rhoden did not act on any commutation or pardon applications this month. There were 3 pardon applications received in February, and the current set-out period is May 2025.

Board members reviewed Policy 8.1.A.5: Parole Decisions and the Setting of Next Review Dates. Staff recommended minor revisions to the policies so that the language was consistent with statute and current and best practices. Motion by Brown, second by Beck to adopt Policy 8.1.A.5: Parole Decisions and the Setting of Next Review Dates as amended. All members voted aye. Motion carried.

Board Members were advised that the April calendar has 6 full board cases currently scheduled.
