The issue for consideration by the One Call Board at this hearing is whether Darwin Toof violated 49-7A-8 and 49-7A-12 for an incident occurring on October 15, 2020 at 815 E New York Street, Lot 29, Rapid City, South Dakota; and if so, whether civil penalties should be assessed.

The Office of Hearing Examiners, will direct the process and make procedural and evidentiary rulings. The One Call Board members will hear the evidence presented at that hearing and then enter an Order based upon the record created at the hearing.
