

MINUTES OF THE SOUTH DAKOTA ANNUAL WEED & PEST CONTROL COMMISSION MEETING 1
February 19, 2021 – 9 am
Matthew Training Center, Foss Building, 523 E. Capitol Ave., Pierre, SD

Chairman Lynn Deibert called the meeting to order at 9:05 am, February 19, 2021.

Chairman Deibert presented the Committee recommendations for funding the FY2022 Competitive Grants. The Committee met on January 6th in Pierre. 
A public comment period was held with no comments presented.
