MINUTES OF THE SOUTH DAKOTA ANNUAL WEED & PEST CONTROL COMMISSION MEETING 2 Wednesday, February 19, 2025 – 1:30 pm CT Crossroads Hotel & Huron Event Center, Huron, SD

Chairman Darwin Kurtenbach called the meeting to order at 1:32 pm, February 19, 2025.

Members Present: Commissioners Chuck Anderson, Bruce Helbig, Darwin Kurtenbach, Game Fish & Parks representative Ryan Wendinger, Department of Transportation representative Christina Bennett; School and Public Lands (SPL) Commissioner Brock Greenfield; Non-Voting Member - SDSU representative Eric Jones; SD Department of Agriculture & Natural Resources representative Bill Smith; and Commission Secretary and Plant Industry Program Manager Brenda Sievers.

Brock Greenfield made a motion to approve the agenda. Seconded by Ryan Wendinger. Motion carried.

Chairman Kurtenbach asked for any changes to the minutes from the September 10, 2024, meeting. A motion was made by Brock Greenfield to approve the minutes. Seconded by Bruce Helbig. Motion carried.

Old Business

No old business presented.

New Business

Requests for Locally Declared Noxious Weeds & Pests

Discussion was held on the locally noxious weed requests. Brock Greenfield made a motion to approve the locally noxious requests listed. Seconded by Ryan Wendinger. Motion carried.

The Weed and Pest Coordinator Report was given by Brenda Sievers. The department updated Weed and Pest Manual and distributed copies to the weed supervisors at the morning training. The manuals hadn't been updated for many years with an actual printed copy and jump drives of the information were also handed out. Weed and Pest Staff set up and assisted at the Association of SD County Weed and Pest Board booths at Sioux Falls Farm Show, Black Hills Stock Show, and Watertown Farm Show. Emerald ash borer was found in Brookings last summer which extended our quarantine, and it was also found in North Dakota about 70 miles north of Aberdeen.

Jeremiah Phelps, Weed and Pest Program Specialist, has been compiling the annual, fiscal and inspection summary reports sent in. All counties that applied for grants did get their reports in. He also reported on shows he assisted at.

District reports were given by:

- District 2 Representative Darwin Kurtenbach he assisted at Sioux Falls Farm Show and the Black Hills Stock Show, answering many questions.
- District 3 Representative Bruce Helbig talked about the red seed head weevil in sunflowers, grasshoppers affecting people and the multi-county annual weed meeting last March that was well received.

District 4 Representative Chuck Anderson – last year had good moisture but then dried up, grasshoppers were sprayed privately.

Agency reports were given by:

- School and Public Lands Commissioner Brock Greenfield talked about the grasshopper history of spraying starting about two years ago which ended up being 11 times bigger than anticipated, SPL were sprayed by lessees, many benefited since a large area worked together, Mike Cornelison has been with SPL office for 46 years.
- SDSU Representative Eric Jones reported that Graig Reicks has been hired as the Extension Weed Ecology Field Specialist. He will be in Brookings and will assist with field trials and other program duties.
- Department of Transportation Representative Christina Bennett for FY2025 they have spent about \$873,000, with 80% going on non-interstate highway ditches, with the remaining 20% going toward the interstates. March and April are bid lettings for weed spray contracts and there are typically 36-40 contracts.
- Game, Fish and Parks Representative Ryan Wendinger sprayed about11,000 acres in 2024, they have 725 game production areas across the state, amounting to 290,000 acres to control in the Wildlife Division, there are another 100,000 acres in the Parks Division. There were about 60,000 acres that were grazed, hayed or burned in 2024. There are some concerns with the drought monitor for spring control but have hired a lot of their seasonal positions.
- SD Department of Agriculture and Natural Resources Representative Bill Smith reported on late fall pockets of mountain pine beetle in the Black Hills. The Conservation Commission will have an upcoming grant round at their next meeting. Bill reported on the legislative session currently taking place and the two bills his division is tracking. Bill answered a question on how many dollars the Conservation Commission grants out. Each year they have \$500,000 available to grant out but have had a growing balance and must meet the requirements of the coordinated plan for natural resources conservation. Districts must provide approximately 50% local match with a minimum 25% landowner match, and other state or federal money doesn't count toward the match. Bill also answered questions on the Ips beetle and if there are control programs for landowners.
- CAPS/Bio Control Jeremiah Phelps reported surveying the *Rhinusa pilosa*, for yellow toadflax with galls found in Brown County. Due to a mechanical issue at the rearing site that killed off the insects, no releases were received last fall. Brenda Sievers reported the status of the federal funding for CAPS programs is unknown at the present time, but one intern has been hired, and work will proceed if funding becomes available. The State Survey Coordinator position has been hired and will start in June.

Harding County's regular/contractual grant application didn't arrive at the Department. Harding County Weed Supervisor Misty Koan put together a letter explaining when she had mailed the application and asked the Commission to allow her county's grant since she hadn't missed a deadline in her 12 years with Harding County. A motion made by Bruce Helbig, seconded by Ryan Wendinger, to accept Harding County's grant application. Motion carried.

Chairman Kurtenbach announced it was time for the public comment period. No comments were received.

Competitive Grants FY2026 - \$200,000 available for grants

Discussion was held on the Committee recommendation for funding for the FY2026 grants. Sievers reported there were two counties that did not sign in and were not present for Supervisor's Training, so would not be eligible to receive funds, per the grant criteria.

A motion was made by Ryan Wendinger to approve funding the FY2026 regular/contractual grants as presented, with the adjustments as needed for those counties that weren't at the Supervisor's Training. Seconded by Bruce Helbig. Motion carried.

Extended discussion was held on the competitive grant funding and the Committee recommendation for that funding.

Ryan Wendinger made a motion to accept the Committee recommendations for funding the FY2026 competitive grants. Seconded by Brock Greenfield. After dissenting votes, Chairman Kurtenbach asked for a show of hands on the vote. Yes – Bennett, Greenfield and Wendinger. No – Helbig, Anderson. Motion carried.

- WP-C26-2 Association of SD County Weed & Pest Boards \$55,000 2025 Awareness Project
- WP-C26-4 Brown County Weed & Pest Board \$2,000 Yellow Toadflax Biological Control
- WP-C26-5 Brown County Weed & Pest Board \$1,000 Yellow Toadflax Mapping and Spot Spraying Project
- WP-C26-6 Pennington County Weed & Pest Board \$10,000 Absinth Wormwood and Common Tansy Reduction Project
- WP-C26-9 Deuel County Weed & Pest Board \$3,100 Eradication of Common Mullein
